

**ORDINANCE NO.** \_\_\_\_\_

An ordinance amending Title 22 - Planning and Zoning of the Los Angeles County Code, reducing the temporary use permit fee from \$770 to \$150.

The Board of Supervisors of the County of Los Angeles ordains as follows:

**SECTION 1.** Section 22.60.100 is hereby amended to read as follows:

**22.60.100 Filing fees and deposits.**

A. For the purpose of defraying the expense involved in connection with any application or petition required or authorized by this Title 22, the following fees shall accompany the application or petition:

- Adult Business Permits -- \$4,478.00.
- Animal Permits -- \$662.00, except that where a public hearing is requested as specified in Section 22.56.470, an additional fee of \$1,043.00 shall be paid.
- Aviation Cases -- \$857.00.
- Cemetery Permits -- \$4,478.00.
- ...
- Temporary Use Permits -- ~~\$770~~150.00, except that when a public hearing is requested as specified in Section 22.56.1885, an additional fee of \$1,814.00 shall be paid.
