18.	Other	Jo Drummond	In just the past year, Malibu has experienced nearly a dozen brush fires, several near Big Rock, attributed to transient vagrants. Fortunately, the fires were identified quickly, the winds were calm, and LACFD was able to extinguish these fires without loss of life and with only minimal loss of property and injury. With less fortunate conditions, any one of those fires could have grown into the next Woolsey Fire (or worse). For over the last 4 months there have been illegal campers just above moonshadows, near our homes in big rock, on private property where apparently the city has failed to obtain a "letter of agency" so even though the homeless have been ushered out it they have returned and the debris is twice the size as it started 4 months ago. It includes propane tanks and cooking supplies which can cause fires. There have also been other areas above Tuna Canyon that need to be regularly patrolled for homeless encampments that have been growing on and off. I understand that the City has adopted legislation to deal with the fire danger posed by transient vagrants in specific locations in Malibu and under specific weather conditions. Although these actions are a step in the right direction, they fail to address the fact that CalFire has designated the entirety of the City of Malibu as a Very High Fire Hazard Severity Zone (a "VHFHSZ") and there is insufficient time and resources to locate transient encampments, evict and relocate the inhabitants, and remediate the fire hazard conditions when we are in or approaching a red flag situation. Please declare a formal resolution declaring an emergency situation in Malibu resulting from the severe danger to the health, safety and welfare to the community posed by unhoused individuals living in areas designated by CalFire as a VHFHSZ, and declaring the City's desire that the LASD strictly enforce the City's No Camping Ordinance. An emergency situation should also allow bypass of the letter of agency necessary to access private property as well and make those neglig

As a homeowner in the Santa Monica mountains, I'm so scared by the threat of homeless people camping and cooking in the dry brush they are making camps in. There have already been fires caused, the latest just a stone throw from my back patio. Bravo 69 put it out as it was just close to their location: but if there had been more need for them elsewhere, we would not have been so lucky. Some teepees have even put up in full visibility of the Los Flores fire department, just below them on the mountain side. Please please put fire protection into effect by letting these people know they cannot camp out in these mountains it is a massive risk that they don't understand. I have lived in these mountains since 1988 and witnessed the 1993 fire. We are seeing them pop up any where and everywhere with the homeless populations setting up homes in the mountains. We need the law to move them out into other accommodation. First priority, before other homeless encampments in the city, for massive community safety.

Attention: Los Angeles County Board of Supervisors

We, residents of Topanga, respectfully request that action be taken to prevent camping fires and similar high-risk human behaviors, in order to **protect our lives**, **homes**, **and community**, including the homeless themselves.

Our foremost concern is public safety for the residents of Topanga and all those living within the Santa Monica Mountains. There have been a record number of fires in L.A. County started by human behavior. The recent Palisades, Tuna and Las Flores Fires and at least three fires along Topanga Canyon Blvd, demonstrate how close these fires came to devastating our community. Had it been Red Flag Days, we certainly would have had a different fate.

Topanga Canyon is experiencing serious effects of California's drought first hand, with considerable acreage of dry brush, poised for kindling. The combination of homeless encampments and their camp fires, along with high winds, and this desiccated vegetation create the "perfect storm" for mass devastation to residents, workers, and wildlife in Topanga. Residents and local governments of Pacific Palisades and Malibu all agree that we are in a "crisis."

Given the critical risk to life and property that will only increase over the coming months, we implore you to approve agenda item 18 - Reducing the Risk of Fires Associated with Homeless Encampments in High Fire Hazard Severity Zones with a sense of urgency.

It has been reported that about 20 fires have been started this year in and around Topanga and Malibu. WE NEED ACTION NOW!
