Re-establish the Reward Offer in the Murders of Boston Farley and Richard Williams

On Sunday, May 15, 2016, at 8:58 p.m., 24-year-old Richard Williams and 23-year-old Boston Farley were struck by gunfire on the 1200 block of S. Wilmington Avenue, in the city of Compton. Richard was driving his vehicle and exiting the parking lot of a 76 gas station with two friends, Boston Farley and 26-year-old Brandon Upchurch, when a white pick-up truck drove up and blocked their path. A suspect exited the passenger side of the truck and fired multiple rounds into the victims' car. The suspect then re-entered the truck which was driven out of view. The suspects' vehicle is described as a white Chevy or General Motors utility service truck with ladder racks and built-in side toolboxes. The vehicle was last seen driving northbound on Wilmington Avenue.

Richard sustained multiple gunshot wounds to the torso and died from his injuries at the scene. Boston also sustained multiple gunshot wounds to the torso and was transported to Saint Francis Medical Center where he succumbed to his injuries.

The Los Angeles County Sheriff's Department (LASD) detectives believe there are witnesses in the neighborhood that may have seen the suspects leave the area or know of their identities. The Los Angeles County Board of Supervisors (Board) approved a \$10,000 reward offer on December 6, 2016; re-established it on May 15, 2018, August 14, 2018, and May 4, 2021; and extended it on November 7, 2018, April 30, 2019, November 5, 2019, April 28, 2020, October 27, 2020, and July 27, 2021. This reward expired on January 28, 2022 and needs to be re-established. Detectives believe re-establishing the reward may help solve the crime.
