## Recognizing "California Rideshare Month" and "Clean Air Day" in the County of Los Angeles

The American Lung Association's 2022 State of the Air Report gives Los Angeles a failing air quality grade based on its high ozone and particle pollution levels. This annual report serves as a reminder that Los Angeles County (County) communities are breathing some of the most polluted air in California and the United States, which is being exacerbated by our changing climate and extreme heat events.

For these reasons, each October, the County recognizes "Clean Air Day" and "California Rideshare Month" to raise awareness about air pollution and ridesharing as one solution to help clean the air. As part of this month's events, the County hosts an annual Civic Center Clean Air/Rideshare Fair in Grand Park. This year we are hosting the third Countywide Virtual Clean Air/Rideshare Fair from October 1st to October 31st at Rideshare.lacounty.gov.

Ridesharing includes any alternative to driving alone to work, such as walking, bicycling, carpooling, vanpooling, riding public transit, and teleworking. The County promotes the use of rideshare options to help reduce the number of vehicle miles traveled and improve local air quality and public health. In each Department, there are Designated Employee Transportation Coordinators who are responsible for promoting awareness and assisting employees with their rideshare needs.
