1.	2	Oppose	Adrienna Wong	<p>We respectfully request that the Board of Supervisors reject the CEO's proposal to allocate an additional \$49.6 million to LASD jails for the purported purpose of "meet[ing] the terms of the DOJ consent decree," and instead allocate that money to a real solution: increasing community-based mental health services in order to alleviate the massive overcrowding in the jails. Increasing jail spending will not bring the County into compliance with the Department of Justice consent decrees.</p> <p>The jail budget has increased 44 percent since fiscal year 2011. The number of LASD employees has also increased. It is clear that LASD – and by extension the County – cannot staff its way into compliance with the consent decrees. The jails are operating at 20 percent above capacity. Staffing at that level will not bring the County into compliance with its responsibilities in lawsuits, and especially its responsibility to care for people with severe mental illness.</p> <p>Increasing LASD funding will not solve LASD's institutional inability to address mental health crises. LASD has proven time and time again that the department is neither qualified nor willing to provide the care and support for those suffering from mental health issues inside of the jails. It would be safer to decarcerate those nearly 6,000 people (almost 40 percent of the jail's population) to community-based mental health care models.</p> <p>Correctional Health Services (CHS) has consistently rejected the idea of housing Moderate Observation Housing (MOH) or High Observation Housing (HOH) individuals at MCJ. Continuing to fund any LASD supervision of MOH inside of MCJ would put those designated as MOH and HOH in dangerous and inhumane conditions. For this very reason, the Office of the Inspector General (OIG) and CHS oppose MOH and HOH within MCJ. While LASD has asserted that additional MOH/HOH positions are necessary to comply with the DOJ consent decree, permitting MOH and HOH housing within MCJ would set compliance even farther back. Community-based services are needed here, not additional funding for MOH and HOH staff.</p> <p>The most effective way to address overcrowding and inhumane jail conditions is to decrease the number of people going in and the number of people who are already inside. Instead of pouring ever-more money into LA County jails, the Board of Supervisors should move swiftly towards decarceration of the jail population through proven community diversion programs, such as those of the Office of Diversion and Reentry and community-based alternatives.</p>

People make money off of homelessness existing in this city and anything being funded to actually keep it alive I no longer support.</p> <p>I currently am on the developing team with the Governors office and the new chair in the voices council in south central in a new proposal that is already trying to recreate this version of money being reallocated and divested away from the communities. There are better partnerships that can be created and a care first budget has to actually put care first, not social and political agendas. The background to all of this is I was unlawfully incarcerated am a native of Los Angeles and Long Beach but was wrongly convicted and unlawfully incarcerated as a vagrant, I am far from that. I won my case in appeal though I had cases filed in California Supreme Court and faced extreme police retaliation that appeared mainly through these coalitions who are preaching noble causes. I do not advocate for a budget that supports a widespread cause AGAINST people of color and these organizations very plainly have shown to be against any actual remedy.</p>

We are here to urge the board to allocate \$6M in funding for the continuous and sustained implementation of Market Match. County residents need solutions to the chronic issue of nutrition insecurity as nearly 25% of households do not have enough food to eat. Market Match is an evidence-based program which benefits families, our local economy and small and midsize business and is a solution specified in the Food Equity Roundtable's strategic plan. In November the Board approved a motion regarding healthy food access and diabetes prevention which included exploring the strategies on making Market Match a sustainable program. Since the motion, DPH has reported back on staffing needs and recommended a feasibility assessment as a likely next step. vulnerabilities that would pose fiscal constraints on future budgets.

We commend CEO Davenport's proposed \$3.4 million to upstart the Centralized Contracting and Procurement Office. This office would go far to make the contracting process significantly more friendly for small businesses and nonprofits seeking to do business with the County. Further, fulfilling the unmet need of \$6.3 million to create an E-procurement system would amplify the Office's work and outreach as well as help meet the County's equity in contracting goals.

Further, the \$271 million appropriated to the Department of Economic Opportunity covering a diversity of issues including workforce pipelines, regional recovery partnerships, and justice involved population employment support will help stimulate the regional economy as we rebound from the Covid-19 pandemic and develop new competitive advantages for the 21st century. To help accelerate this effort, fulfilling the Department's unmet needs of program positions in the Policy and Strategy and Office of Small Business divisions.

Lastly, key investments in broadband and closing the digital divide will ensure all communities will access workforce training, employment opportunities, and other career pathways which develop a comprehensive, robust economy. Fulfilling the unmet needs of \$400,000 for a director of digital equity and \$200,000 for network infrastructure would have minimal impact to the budget, yet, produce significant dividends for the economy.

safety benefit at all, and in fact harm our communities by causing trauma, interfering with people's lives and ability to get to work, eroding trust in public institutions, creating racial inequality, and heightening risk of police violence. LA County can and should reduce staffing and related spending by moving away from this failed Patrol strategy.

(2) Reject Allocation of \$1.5 Million in AB 177 backfill funds to LASD. The Board must demand the reallocation of the nearly \$1.5 million in AB 177 backfill funds that the recommended budget allocates to LASD. The Legislature passed AB 177 in recognition of the racial and economic harms of criminal administrative fees on system-impacted people, their families, and their communities, which have directly contributed to the racial wealth gap. Nothing in AB 177 suggests that the County should allocate the backfill funds to the Sheriff's department. To the contrary, the proponents of that legislation, including sponsoring groups based in LA County, have consistently demanded that backfill funds be allocated to reentry services and community economic development programs that repair the harm caused by the County's historical use of criminal administrative fees. And to the extent that the allocation will go towards a general services and supplies appropriation, this will obstruct the county's legal obligation to describe the specific programs, services, strategies, and enhancements funded by the backfill. In the final budget, the AB 177 funds should be shifted to reentry services and economic and workforce development programs, where those funds belong.

(3) Reallocate LASD Funding That Could Be Better Used To Address L.A. County's Housing and Houselessness Crises. The LASD's Homeless Outreach Service Team (HOST) budget for fiscal year 2022–2023 was 3.75 million dollars, which diverted funding that could be spent on addressing the root causes of houselessness. HOST's spending includes costs such as deputy overtime, weapons, and policing equipment - all of which are counterproductive responses to houselessness. Although we support the proposed budget's removal of \$912,000 in one-time funding to HOST, funding for LASD outreach to unhoused populations must be removed entirely.

Evidence shows that law enforcement homeless outreach teams are not effective, especially when compared with civilian-led outreach teams. For example, a study of Los Angeles homeless outreach efforts revealed that outreach teams led by a homeless services nonprofit were able to connect 27 percent of people they contacted with housing, while law enforcement outreach teams working in the same system placed only 1 percent of people they contacted in housing. Similarly, the civilian non-profit teams referred twice as many people to services as law enforcement outreach teams.

Deploying police to unhoused encampments is harmful and dangerous, even when they receive specialized training. HOST deputies receive only 40-80 hours of specialized training and do not have the skills or expertise to interact with unhoused individuals in a humane way and connect them to services they need. Studies show that exposure of unhoused people to law enforcement increases the likelihood of their criminalization, and that

encampment displacements harm the health and wellbeing of unhoused residents.

HOST does not provide any services to unhoused people, nor does the team track outcomes related to housing or services. Rather, they rely on local organizations to connect unhoused people to services. HOST is an expensive law enforcement middle-man that relies on nonprofits to provide services to the people they displace.

Funding spent on the HOST program should be reallocated to Housing First programs and voluntary, care-based outreach and support services. We ask the Board of Supervisors to expand funding for its "Homeless Initiative" and to ensure these funds go to low-barrier, non-congregate interim and permanent housing based on Housing First principles. Importantly, none of the funding should go toward the "resolution" or displacement of encampments; this is a non-solution that is harmful to people's health and wellbeing. Additionally, we ask the board to fully fund the Health Services Department's request for \$26.8 million for recuperative care centers and that Department's request for \$3.9 million to provide additional interim and permanent supportive housing, both of which are currently listed as "critical and unmet needs" in the recommended budget. Lastly, it is critical for the board to invest in housing subsidies and social housing for households with very low- and extremely low-incomes. The recommended budget provides \$30 million to maintain a total of \$100 million for the development and preservation of affordable housing. This fund is vitally important, but it must be vastly expanded to reflect the magnitude of the need for subsidized, affordable housing in LA County.

We ask the Board of Supervisors divest funding from the HOST program and reallocate this funding to unmet needs for affordable housing and Housing First solutions to meet the scale of the County's housing crisis.

(4) Take Budget Action to End LASD Exploitation of LA County Families. For yet another year, the recommended budget includes no provision for a fee-free system of phone calls for incarcerated people and their families, to replace the exploitative system in place to generate revenue for LASD -- despite the Board passing a motion to change this system in May 2021, despite Sheriff Luna publicly approving of this shift, and despite litigation targeting LASD's "extortionate" phone fees, as recently reported on by the LA Times. The budget should be revised to reflect the County making good on its promises instead of incurring more liability.

Specifically, the County budget should provide for free phone calls in L.A. County jails; this would require a miniscule portion -- less than half of a percent -- of LASD's budget. The cost of phone calls from incarcerated people to their loved ones costs less than a third of the amount that LASD has budgeted for counterproductive law enforcement responses to homelessness and community mental health needs that should be led by service providers instead.
