**APPROVE SUBMISSION OF GRANT APPLICATION
AND AUTHORIZE SHERIFF TO ACCEPT GRANT AWARD
FROM THE GOVERNOR'S OFFICE OF EMERGENCY SERVICES
(ALL DISTRICTS) (3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Authorize the Sheriff to submit a grant application to the Governor's Office of Emergency Services (OES) for a noncompetitive grant amount of \$550,620 in state funding, with a 25 percent local match requirement.
2. Instruct the Chairperson of the Board of Supervisors to provide a wet signature on the following grant application document: Certification of Assurance of Compliance form (Attachment).
3. Upon grant award notification, authorize the Sheriff of Los Angeles County, as an agent for the County, to sign and accept the forthcoming grant award amount of \$550,620 from OES, to secure continued investigation and prosecution for identity theft crimes committed within the County through the Southern California High Technology Task Force Identity Theft Detail (SCHTTFID).
4. Authorize the Sheriff to execute all future amendments, modifications, extensions, and/or augmentations to said grant, which do not impact net County cost should such action(s) be required during the term of the forthcoming grant.

A Tradition of Service

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Senate Bill 438 and Penal Code Section 13848 established a program of financial and technical assistance in OES, which is administered by the High Technology Theft Apprehension and Prosecution (HTTAP) program. Through this program, OES awards an annual grant to the Counties of Los Angeles, Orange, and Ventura, which are the jurisdictions within the SCHTTFID.

The Los Angeles County Sheriff's Department (LASD) has received a Request for Application for the HTTAP program, Identity Theft Component. OES recognizes LASD as a recipient for this grant funding as it has been selected by the SCHTTFID committee as the lead agency. Upon submitting an application to OES, LASD will receive up to \$550,620 in grant funding to be utilized for SCHTTFID operations, specifically for the function of investigating and prosecuting identity theft crimes. The investigations/prosecutions may include Internet tracing and detailed computer forensics, conducting "sting" operations, and shutting down fraudulent document printers employed as paper mills, as well as following traditional paper trails.

SCHTTFID includes participants from the United States Secret Service, United States Postal Service, and the Office of Inspector General. SCHTTFID also anticipates an investigator from the Department of Motor Vehicles. From this collaboration, one (1) lieutenant, three (3) sergeants, twenty-five (25) investigators, and three (3) clerks comprise SCHTTFID staff to serve the member Counties.

LASD and other agencies will provide grant funded, cash match, and in-kind support staff for the SCHTTFID. All participating agencies will donate at least forty (40) hours per month to assist in Task Force and Identity Theft investigations.

Implementation of Strategic Plan Goals

The HTTAP grant program assists the County and LASD in achieving several goals of the "County of Los Angeles Strategic Plan." With its support, LASD will realize the achievement of Goal #1: Service Excellence, Goal #2: Workforce Excellence, and Goal #5: Children and Families' Well-Being.

"Service Excellence" will be accomplished as SCHTTFID works to provide the public with quality information and services concerning identity theft and the prevention thereof. "Workforce Excellence" will be attained as the forthcoming grant allows for retention of committed/dedicated employees of SCHTTFID, thereby enhancing the quality and productivity of the County workforce. Lastly, "Children and Families'

Well-Being" will be realized overall through the reduction of identity theft crimes and thus, improving the quality of life for County residents, as well as for those residing in the Counties of Orange, and Ventura.

FISCAL IMPACT/FINANCING

The HTTAP program will provide \$550,620 in state grant funding, or 75 percent of the program costs, to LASD. Under this program, LASD will contribute matching funds of \$137,165 (equal to 25 percent of the award amount). To satisfy the match requirement, LASD is donating a portion of four (4) Bonus II Investigators from existing budgeted funds, as well as cash match benefits for one (1) sergeant and one (1) clerk. Funding for this program has been included in LASD's budget for Fiscal Year 2005-2006.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The end of Fiscal Year 2004-2005 marked the fourth year of participation in the HTTAP program. The program will be effective for another 12 months, commencing on July 1, 2005, and ending June 30, 2006. The application documents have been reviewed and approved as to form by County Counsel.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The HTTAP program has just completed its seventh year and does not propose staff augmentation; therefore, LASD is not subject to the Board motion of December 15, 1998, requiring clearance with the District Attorney, Alternate Public Defender, Public Defender, and Probation Departments.

Upon approval, LASD requests that your Board provide four (4) individually adopted copies of this action and one (1) executed original of the attached Certification of Assurance of Compliance to LASD.
