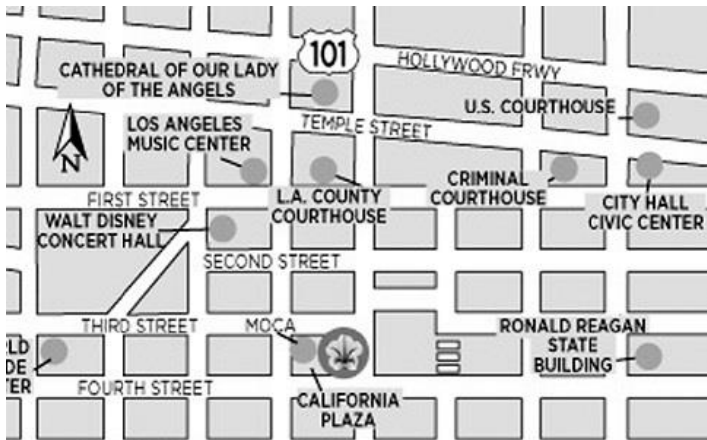

## Directions

### From Hollywood Fwy./San Fernando Valley:

- Take 101 South to Harbor Fwy. 110 South.
- Exit on 4th Street and follow (this is a one-way street) for about 1/3 mile.
- Turn left on Olive Street and the hotel is on the left.

### From Harbor Fwy. North/San Pedro:

- Take the Harbor Fwy. I-110 North toward downtown.
- Exit on 4th Street and follow (this is a one-way street) for about 1/3 mile.
- Turn left on Olive Street and the hotel is on the left.

### From Santa Monica/West Los Angeles:

- Take the Santa Monica Fwy. I-10 East and transfer to the Pasadena Fwy. I-110 North toward downtown
- Exit 4th Street and follow for about 1/3 mile.
- Turn left on Olive Street and the hotel is on the left.

### From Valencia / Burbank / Glendale:

- Take the Golden State Fwy. I-5 South to the Harbor Fwy. I-110 South.
- Exit 4th Street and follow for about 1/3 mile.
- Turn left on Olive Street and the hotel is on the left.

### From Orange County:

- Take the Santa Ana Fwy. I-5 North to the Hollywood Fwy. I-101 North.
- Exit on Grand Avenue. Turn right onto 1st Street heading East. Turn right on Olive Street.
- After 1 1/2 blocks, the hotel is on the right.
