**IT IS RECOMMENDED THAT YOUR BOARD AS THE GOVERNING BODY OF THE
COUNTY OF LOS ANGELES WATERWORKS DISTRICT NO. 36, VAL VERDE:**

1. Renominate Mr. Dean D. Efstathiou to represent the County of Los Angeles Waterworks District No. 36, Val Verde, as a Director on the Board of the Castaic Lake Water Agency.
2. Adopt the enclosed Resolution submitting Mr. Efstathiou's name to the Castaic Lake Water Agency for appointment as Director.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

On January 2, 2007, Mr. Efstathiou's term on the Board of Directors will expire. Mr. Efstathiou is an appointed Director to the Castaic Lake Water Agency representing the County of Los Angeles Waterworks District No. 36, Val Verde. Mr. Efstathiou has served on the Board of Directors of the Castaic Lake Water Agency continuously since he was first nominated by your Board on November 10, 1992. Mr. Efstathiou, as an Assistant Director of Public Works, oversees the operations of the Waterworks and

Sewer Maintenance Division, including the County of Los Angeles Waterworks District No. 36, Val Verde. He is very knowledgeable and has many years of extensive water experience in that field. He is currently working to enhance and protect the quantity and quality of available water resources for the Santa Clarita Valley.

Implementation of Strategic Plan Goals

This action meets the County Strategic Plan Goal of Service Excellence since the appointment will fill the vacancy on the Castaic Lake Water Agency's Board of Directors.

FISCAL IMPACT/FINANCING

There will be no negative impact or increase in net County cost.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Section 5.2 of Castaic Lake Water Agency Law and California Water Code-Appendix, Act 9099b, Water Uncodified Acts, provides that the County of Los Angeles Board of Supervisors shall, as the governing Board of the County of Los Angeles Waterworks District No. 36, Val Verde, nominate a person to serve as an appointed Director of the Castaic Lake Water Agency.

The enclosed Resolution has been approved as to form by County Counsel.

DEAN D. EFSTATHIOU TO SERVE AS AN APPOINTED DIRECTOR OF
THE CASTAIC LAKE WATER AGENCY REPRESENTING LOS ANGELES COUNTY
WATERWORKS DISTRICT NO. 36, VAL VERDE

WHEREAS, Section 5.2 of the Castaic Lake Water Agency Law provides that the Los Angeles County Board of Supervisors shall, on behalf of Los Angeles County Waterworks District No. 36, Val Verde, nominate a person to serve as an appointed Director of the Castaic Lake Water Agency; and

WHEREAS, Mr. Dean D. Efstathiou was nominated to serve as Director of said Water Agency by your Board on November 10, 1992, and again on December 6, 1994, December 15, 1998, and December 3, 2002; and

WHEREAS, the term of Mr. Dean D. Efstathiou as Director of said Water Agency will expire on January 2, 2007.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Los Angeles does hereby renominate Mr. Dean D. Efstathiou on behalf of the said Waterworks District to continue as an appointed Director of the said Water Agency.

BE IT FURTHER RESOLVED that the Executive Officer of the Board of Supervisors be instructed to notify the Castaic Lake Water Agency of this action.


