At its meeting held November 14, 2006, the Board took the following action:

Supervisor Knabe made the following statement:

“On November 19, 2004, Kristine Holmstedt, was murdered on the front porch of her home on Jeanette Avenue in the City of Cerritos. The Los Angeles County Sheriff’s Department’s Homicide Bureau detectives are investigating this murder; however, to date they have received no viable clues regarding the incident and the reward is slated to expire by November 25, 2006.

“Investigators believe it would be beneficial to extend the reward in this case which may prompt otherwise reluctant witnesses to come forward and provide information to identify the individual(s) responsible for this crime.”

Therefore, on motion of Supervisor Knabe, seconded by Supervisor Antonovich, unanimously carried, the Board extended the \$10,000 reward offered for any information leading to the arrest and conviction of the person or persons responsible for the murder of Kristine Holmstedt, who sustained a gunshot wound to her head while on the front porch of her home on Jeanette Avenue in the City of Cerritos on November 19, 2004, at approximately 8:30 p.m.

**NOTICE OF \$10,000 REWARD
OFFERED BY THE
LOS ANGELES COUNTY BOARD OF SUPERVISORS**

Notice is hereby given that the Board of Supervisors of the County of Los Angeles has extended the \$10,000 reward offered for any information leading to the arrest and conviction of the person or persons responsible for the murder of Kristine Holmstedt, who sustained a gunshot wound to her head while on the front porch of her home on Jeanette Avenue in the City of Cerritos on November 19, 2004, at approximately 8:30 p.m.

Any person having any information related to this crime is requested to call Detective Karen Lee Shonka at the Los Angeles County Sheriff's Homicide Bureau at (323) 890-5621 and refer to Report No. 004-06057-2318-011.

The terms of the reward provide that:

- The information given that leads to the determination of the identity, the apprehension and conviction of any person or persons must be given no later than February 23, 2007. All reward claims must be in writing and shall be received no later than April 24, 2007.
- The total County payment of any and all rewards shall in no event exceed \$10,000 and no claim shall be paid prior to conviction unless the Board of Supervisors makes a finding of impossibility of conviction due to the death or incapacity of the person or persons responsible for the crime or crimes.
- The County reward may be apportioned between various persons and/or paid for the conviction of various persons as the circumstances fairly dictate.

Any claims for the reward funds should be filed no later than April 24, 2007 with the Executive Officer of the Board of Supervisors, 500 West Temple Street, Room 383 Kenneth Hahn Hall of Administration, Los Angeles, California 90012, Attention: Kristine Holmstedt Reward Fund.
