At its meeting held April 1, 2008, the Board took the following action:

Supervisor Burke made the following statement:

“On Friday, March 28, 2008, at approximately 1:50 a.m., 22-year old Clifton Hibbert, Jr. and 23-year old Kenneth Patterson were fatally shot in front of an apartment building in Exposition Park near Figueroa Street and 43<sup>rd</sup> Street.

“Hibbert’s father, whose son attended Cal State Northridge, said both young men were in college and uninvolved in gangs.

“Witnesses only heard gunshots, but did not see the shooters. Suspects and motives for the killing of these two college students are unknown. The gunman remains at large.”

Therefore, on motion of Supervisor Burke, seconded by Supervisor Yaroslavsky, unanimously carried (Supervisor Molina being absent), the Board established a \$10,000 reward for any information leading to the arrest and/or conviction of the person or persons responsible for the murder of Clifton Hibbert, Jr. and Kenneth Patterson, who were fatally shot in front of an apartment building in Exposition Park near Figueroa Street and 43<sup>rd</sup> Street on Friday, March 28, 2008 at approximately 1:50 a.m.

**NOTICE OF \$10,000 REWARD  
OFFERED BY THE  
LOS ANGELES COUNTY BOARD OF SUPERVISORS**

Notice is hereby given that the Board of Supervisors of the County of Los Angeles is offering a \$10,000 reward for any information leading to the arrest and/or conviction of the person or persons responsible for the murder of Clifton Hibbert, Jr. and Kenneth Patterson, who were fatally shot in front of an apartment building in Exposition Park near Figueroa Street and 43<sup>rd</sup> Street on Friday, March 28, 2008 at approximately 1:50 a.m.

Any person having any information related to this crime is requested to call Detective Geiger at the Los Angeles Police Department, Homicide Division at (213) 485-1383 and refer to Report Nos. 08-0311210 and 08-0311211.

The terms of the reward provide that:

- The information given that leads to the determination of the identity, the apprehension and conviction of any person or persons must be given no later than June 30, 2008. All reward claims must be in writing and shall be received no later than August 29, 2008.
- The total County payment of any and all rewards shall in no event exceed \$10,000 and no claim shall be paid prior to conviction unless the Board of Supervisors makes a finding of impossibility of conviction due to the death or incapacity of the person or persons responsible for the crime or crimes.
- The County reward may be apportioned between various persons and/or paid for the conviction of various persons as the circumstances fairly dictate.

Any claims for the reward funds should be filed no later than August 29, 2008 with the Executive Officer of the Board of Supervisors, 500 West Temple Street, Room 383 Kenneth Hahn Hall of Administration, Los Angeles, California 90012, Attention: Clifton Hibbert Jr. and Kenneth Patterson Reward Fund.
