**DEPARTMENT OF PUBLIC WORKS: NEGOTIATED
EXCHANGE OF PROPERTY TAX REVENUES RESULTING
FROM ANNEXATIONS TO THE MALIBU LIGHTING DISTRICT AND
THE CALABASAS LIGHTING DISTRICT
(SUPERVISORIAL DISTRICT 3)
(3 VOTES)**

SUBJECT

This action is to approve and accept the negotiated exchange of property tax revenues resulting from the annexation of territories to the Malibu Lighting District and the Calabasas Lighting District.

IT IS RECOMMENDED THAT YOUR BOARD:

1. Adopt Joint Resolutions Approving and Accepting the Negotiated Exchange of Property Tax Revenues resulting from the annexation of territories listed in Appendix A to the Malibu Lighting District and the Calabasas Lighting District, respectively, as approved by the Cities of Malibu and Calabasas and other nonexempt taxing agencies.
2. Adopt Resolutions Approving and Accepting the Exchange of Property Tax Revenues resulting from the Annexation of Tract Nos. 36929, 32658, and L 089-9 to the Malibu Lighting District, and Tract Nos. 32960, 44436, and 44949 to the Calabasas Lighting District, on behalf of the Los Angeles County West Vector Control District, pursuant to Section 99.01(a)(4) of the California Revenue and Taxation Code.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

These recommended actions are for your Board to approve respective property tax exchange resolutions between affected taxing entities and the Malibu Lighting District and Calabasas Lighting District. In addition, your Board must adopt the resolutions on behalf of the Los Angeles County West Vector Control District (Vector Control District), since the Vector Control District failed to adopt the respective resolutions.

Implementation of Strategic Plan Goals

The Countywide Strategic Plan directs that we provide Fiscal Responsibility (Goal 4) as the exchange of property tax revenue provides the funding necessary for the operation and maintenance of street lighting facilities within the annexed territories.

FISCAL IMPACT/FINANCING

The adoption of the resolutions will result in a minimal property tax growth transfer from the affected taxing entities including the Los Angeles County General Fund, the Los Angeles County Library, the Consolidated Fire Protection District of Los Angeles County, the Los Angeles County Flood Control District, and the Los Angeles County Water Works District No. 29. The property tax, coupled with assessments collected from benefited property owners, will fund the operation and maintenance of the street lights in the affected areas.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Your Board previously approved the annexation of territories listed in Appendix A to the Malibu Lighting District and the Calabasas Lighting District, and County Lighting District LLA-1 (CLD LLA-1), Malibu and Calabasas Zones, and the levying of assessments for the purpose of installing and maintaining the street lights within the annexed territories. It is necessary for your Board to adopt the attached Joint Resolutions pursuant to Section 99.01 of the Revenue and Taxation Code (R&T Code) in order to provide property tax revenues for the operation and maintenance of street lights within the annexed territories.

Section 99.01(a)(4) of the R&T Code provides that affected agencies must approve and accept the negotiated exchange of property tax revenues by resolution. For those agencies with their own governing boards who fail to adopt a Joint Resolution providing for the exchange of property tax revenues, your Board can approve the exchange of property tax revenue for that agency.

The Joint Resolutions Approving and Accepting the Negotiated Exchange of Property Tax Revenues for those projects identified in Appendix A are attached for your consideration. With the exception of the Vector Control District, the Joint Resolutions have been approved by the Cities of Malibu and Calabasas, and other nonexempt taxing agencies. The Board of Directors of the Vector Control District failed to return adopted Joint Resolutions.

Since it is equitable that each local agency participate in the exchange of property tax revenue generated in the area subject to the jurisdictional change, we recommend that your Board adopt the attached Resolutions Approving and Accepting the Exchange of Property Tax Revenue on behalf of the Vector Control District for those projects identified in Appendix A, pursuant to Section 99.01(a)(4) of the R&T Code.

Following your Board's approval of the attached resolutions for the exchange of property tax revenues, the Department of Public Works (Public Works) will file the statement of boundary changes with the State Board of Equalization as required by Section 54900 et seq. of the California Government Code.

The attached resolutions have been approved as to form by County Counsel.

ENVIRONMENTAL DOCUMENTATION

These projects are categorically exempt from the provisions of the California Environmental Quality Act (CEQA) in that they meet the criteria set forth in Section 15301 of the CEQA Guidelines and Class 1(x)27 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The Negotiated Exchange of Property Tax Revenues to the Malibu and Calabasas Lighting Districts will have no impact on other services or projects.

TO MALIBU LIGHTING DISTRICT**

WHEREAS, pursuant to Section 99.01 of the Revenue and taxation Code, prior to the effective date of any jurisdictional change that will result in a special district providing one or more services to an area where those services have not previously been provided by any local agency, the special district and each local agency that receives and apportionment of property tax revenue from the area must negotiate an exchange of property tax increment generated in the area subject to the jurisdictional change and attributable to those local agencies; and

WHEREAS, the Board of Supervisors of the County of Los Angeles, acting on behalf of the Malibu Lighting District, the Los Angeles County General Fund, the Los Angeles County Library, the Consolidated Fire Protection District of Los Angeles County, the Los Angeles County Flood Control Drainage Improvement District, the Los Angeles County Flood Control District, the Los Angeles County Water Works District No. 29, and the Los Angeles County Water Works District No. 29 Accumulative Capital Outlay; the City Council of the City of Malibu; and the Board of Directors of the Los Angeles County West Vector Control District have determined that the amount of property tax revenue to be exchanged between their respective agencies as a result of the annexation identified as Tract No. 36929, Tract No. 32658, and L 089-9 to the Malibu Lighting District is as set forth below:

RESOLUTION NO. 07-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MALIBU APPROVING AND ACCEPTING THE NEGOTIATED EXCHANGE OF PROPERTY TAX REVENUES RESULTING FROM ANNEXATION OF TRACT NO. 36929, TRACT NO. 32658, AND L089-9 TO MALIBU LIGHTING DISTRICT

The City Council of the City of Malibu does hereby find, order and resolve as follows:

SECTION 1. Recitals.

- A. Pursuant to Section 99.01 of the Revenue and Taxation Code, prior to the effective date of any jurisdictional change that will result in a special district providing one or more services to an area where those services have not previously been provided by any local agency, the special district and each local agency that receives an apportionment of property tax revenue from the area must negotiate an exchange of property tax increment generated in the area subject to the jurisdictional change and attributable to those local agencies.
- B. The Board of Supervisors of the County of Los Angeles, acting on behalf of the County of Los Angeles, the Los Angeles County Library, the Consolidated Fire Protection District of Los Angeles County, the Los Angeles County Flood Control Drainage Improvement District, the Los Angeles County Flood Control District, the Los Angeles County Water Works District No. 29, and the Los Angeles County Water Works District No. 29 Accumulative Capital Outlay; the City Council of the City of Malibu; and the Board of Directors of the Los Angeles County West Vector Control District have determined that the amount of property tax revenue to be exchanged between their respective agencies as a result of the annexation proposal identified as Tract No. 36929, Tract No. 32658, and L089-9 to the Malibu Lighting District is as set forth below.

SECTION 2. Negotiated Exchange of Property Tax Revenues.

The negotiated exchange of property tax revenues between the County of Los Angeles, County Library, Consolidated Fire Protection District, County Flood Control Drainage Improvement District, the Los Angeles County Flood Control District, the Los Angeles County Water Works District No. 29, and the Los Angeles County Water Works District No. 29 Accumulative Capital Outlay; the City of Malibu; and the Los Angeles County West Vector Control District resulting from the annexation proposal identified as Tract No. 36929, Tract No. 32658, and L089-9 to the Malibu Lighting District is approved and accepted.

- B. For fiscal years commencing on or after July 1, 2004, or the July 1 after the effective date of this jurisdictional change, whichever is later, the property tax revenue increment generated from the area within Tract No. 36929, Tract No. 32658, and L089-9 (Tax Rate Area 10853), shall be allocated to the affected agencies as indicated in the enclosed Worksheets.



If at any time after the effective date of this Resolution, the calculations used herein to determine initial property tax transfers or the data used to perform those calculations are found to be incorrect, thus producing an improper or inaccurate property tax transfer, the property tax transfer shall be recalculated and the corrected transfer shall be implemented for the next fiscal year, and any amounts of property tax received in excess of that which is proper shall be refunded to the appropriate agency.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


