At its meeting held July 15, 2008, the Board took the following action:

Supervisor Antonovich made the following statement:

“On July 12, 2008 at approximately 2:00 a.m., Lucy Preciado was stabbed to death with a sword by her boyfriend, Jesus Humberto Canales, in her Quartz Hill apartment in front of their children. Canales, the 28-year-old suspect, is outstanding and considered to be very dangerous. His vehicle is described as a bronze 2002 GMC Safari Van, license plate number 6CBY663.

“Sheriff’s Homicide Bureau is seeking the public’s help with information that will lead to the arrest and conviction of Canales.”

Therefore, on motion of Supervisor Antonovich, and by common consent, there being no objection (Supervisor Yaroslavsky being absent), the Board established a \$10,000 reward for any information leading to the arrest and/or conviction of Jesus Humberto Canales who was responsible for the murder of his girlfriend Lucy Preciado, who was stabbed to death with a sword in her Quartz Hill apartment on Saturday, July 12, 2008, at approximately 2:00 a.m. in Lancaster.

**NOTICE OF \$10,000 REWARD
OFFERED BY THE
LOS ANGELES COUNTY BOARD OF SUPERVISORS**

Notice is hereby given that the Board of Supervisors of the County of Los Angeles has establish a \$10,000 reward for any information leading to the arrest and/or conviction of Jesus Humberto Canales who is responsible for the murder of his girlfriend Lucy Preciado, who was stabbed to death with a sword in her Quartz Hill apartment on Saturday, July 12, 2008, at approximately 2:00 a.m. in Lancaster.

Any person having any information related to this crime is requested to call Sergeant Kevin Lloyd and Detective Jeff Leslie at the Los Angeles County Sheriff's Homicide Bureau at (323) 890-5500 and refer to Report No. 008-17913-1182-011.

The terms of the reward provide that:

- The information given that leads to the determination of the identity, the apprehension and conviction of any person or persons must be given no later than October 13, 2008. All reward claims must be in writing and shall be received no later than December 12, 2008.
- The total County payment of any and all rewards shall in no event exceed \$10,000 and no claim shall be paid prior to conviction unless the Board of Supervisors makes a finding of impossibility of conviction due to the death or incapacity of the person or persons responsible for the crime or crimes.
- The County reward may be apportioned between various persons and/or paid for the conviction of various persons as the circumstances fairly dictate.

Any claims for the reward funds should be filed no later than December 12, 2008, with the Executive Office of the Board of Supervisors, 500 West Temple Street, Room 383 Kenneth Hahn Hall of Administration, Los Angeles, California 90012, Attention: Lucy Preciado Reward Fund.
