RESOLUTION NO. 08-2108

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARTESIA, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO (1) APPROVE A CHANGE IN THE DATE OF THE GENERAL MUNICIPAL ELECTION DATE FOR THE CITY OF ARTESIA; (2) TO CONSOLIDATE THE ARTESIA GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 3, 2009 WITH THE REGULAR ELECTION OF THE ABC UNIFIED SCHOOL DISTRICT AND THE CERRITOS COMMUNITY COLLEGE DISTRICT ON THAT DATE; AND (3) REQUESTING THE LOS ANGELES COUNTY REGISTRAR OF VOTERS TO PERFORM CERTAIN RELATED SERVICES IN CONNECTION WITH THE CONSOLIDATED ELECTION

THE CITY COUNCIL OF THE CITY OF ARTESIA DOES HEREBY FIND, ORDER AND RESOLVE AS FOLLOWS:

**Section 1.** On October 13, 2008 and pursuant to California Elections Code Sections 1301 and 10403.5, the City Council of the City of Artesia adopted Ordinance No. 08-734 to change the date of the City of Artesia's general municipal election from the first Tuesday after the first Monday of March of odd number years to the first Tuesday after the first Monday in November of odd-number years.

**Section 2.** Pursuant to California Elections Code Section 10403.5, the City Council of the City of Artesia hereby requests the Board of Supervisors to approve of the change in the date of the City of Artesia's general municipal election from the first Tuesday after the first Monday of March of odd number years to the first Tuesday after the first Monday in November of odd-number years.

**Section 3.** In accordance with City of Artesia Ordinance No. 08-734 and upon the approval of the Board of Supervisors, the City's next regular municipal election at which it will elect councilmembers will be moved from March 3, 2009 to November 3, 2009. At the November 3, 2009 election, the voters of Artesia will elect three persons to serve new four-year terms on the Artesia City Council.

**Section 4.** The Artesia City Council has determined that it is desirable that, if the Board of Supervisors approves of the change in the City of Artesia's general municipal election date, that such election be consolidated with the regular election being held by the ABC Unified School District and the Cerritos Community College District and conducted by the Los Angeles County Registrar of Voters and that the precincts, polling places and election officers of the three elections within the City of Artesia be the same, with the County of Los Angeles Elections Department preparing the canvass the returns.

**Section 5.** Pursuant to the requirements of Section 10403 of the California Elections Code, the Artesia City Council requests the Board of Supervisors of the County of Los Angeles to consolidate the Artesia General Municipal Election with the ABC Unified School District and the Cerritos Community College District elections to be held on Tuesday, November 3, 2009.

**Section 6.** Upon the County's approval of the change in election date and the request for consolidation, the County Elections Department is authorized to canvass the returns of the Artesia General Municipal Election. The elections shall be held in all respects as if there were only one election, and only one form of ballot shall be used.


**Section 7.** The Board of Supervisors is requested to issue instructions to the County Elections Department to take any and all steps necessary for the holding of the consolidated elections.

**Section 8.** The City of Artesia recognizes that additional costs will be incurred by the County by reason of this consolidation and agrees to reimburse the County for any costs.

**Section 9.** The City Clerk is hereby directed to file a certified copy of this resolution forthwith with the Board of Supervisors and the County Elections Department of the County of Los Angeles, not later than Tuesday, October 21, 2008.

**Section 10.** That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

ORDINANCE NO. 08-734

AN ORDINANCE OF THE CITY OF ARTESIA, CALIFORNIA, MOVING THE DATE OF THE CITY'S GENERAL MUNICIPAL ELECTION FROM THE FIRST TUESDAY AFTER THE FIRST MONDAY IN MARCH OF ODD-NUMBERED YEARS TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER OF ODD-NUMBERED YEARS AND REPEALING ORDINANCE NO. 508

WHEREAS, the City's General Municipal Election is currently scheduled for the first Tuesday after the first Monday in March of odd-numbered years;

WHEREAS, Election Code §1301 and §10403.5 authorize the City to change the date of the City's General Municipal Election;

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ARTESIA DOES ORDAIN AS FOLLOWS:**

Section 1. Pursuant to Elections Code §1301 and §10403.5, the date of the General Municipal Election of the City of Artesia, California is moved from the first Tuesday after the first Monday in March of odd-numbered years to the first Tuesday in November of each odd-numbered years.

Section 2. In accordance with the change of election date, the terms of office of those members of the City Council presently serving shall be extended for a period of approximately six (6) months until election results are declared by the City Council.

Section 3. Pursuant to Elections Code §10403.5, this ordinance shall take effect on the latter of (i) thirty (30) days after its final passage by the Artesia City Council, or (ii) upon approval by the Los Angeles County Board of Supervisors. Within 30 days after the ordinance becomes effective, the City Clerk/Treasurer shall cause a notice to be mailed to all registered voters of the city informing them of the change in the election date and, that as a result of the change in election date, the new terms of office of the elected city officeholders.

Section 4. The City Clerk/Treasurer shall, without delay, forward two (2) certified copies of said Ordinance to the Executive Director of the Los Angeles County Board of Supervisors, at 383 Hall of Administration, Los Angeles, California 90012.


Section 5. Ordinance 508 is hereby repealed in its entirety.

THE CITY COUNCIL OF THE CITY OF ARTESIA DOES HEREBY FIND, ORDER AND RESOLVE AS FOLLOWS:

**Section 1.** On October 13, 2008 and pursuant to California Elections Code Sections 1301 and 10403.5, the City Council of the City of Artesia adopted Ordinance No. 08-734 to change the date of the City of Artesia's general municipal election from the first Tuesday after the first Monday of March of odd number years to the first Tuesday after the first Monday in November of odd-number years.

At the November 3, 2009 election, the voters of Artesia will elect three persons to serve new four-year terms on the Artesia City Council.

**Section 4.** The Artesia City Council has determined that it is desirable that, if the Board of Supervisors approves of the change in the City of Artesia's general municipal election date, that such election be consolidated with the regular election being held by the ABC Unified School District and the Cerritos Community College District and conducted by the Los Angeles County Registrar of Voters and that the precincts, polling places and election officers of the three elections within the City of Artesia be the same, with the County of Los Angeles Elections Department preparing the canvass the returns.



AN ORDINANCE OF THE CITY OF ARTESIA, CALIFORNIA, MOVING THE DATE OF THE CITY'S GENERAL MUNICIPAL ELECTION FROM THE FIRST TUESDAY AFTER THE FIRST MONDAY IN MARCH OF ODD-NUMBERED YEARS TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER OF ODD-NUMBERED YEARS AND REPEALING ORDINANCE NO. 508

WHEREAS, the City's General Municipal Election is currently scheduled for the first Tuesday after the first Monday in March of odd-numbered years;

WHEREAS, Election Code §1301 and §10403.5 authorize the City to change the date of the City's General Municipal Election;

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ARTESIA DOES ORDAIN AS FOLLOWS:**

Section 1. Pursuant to Elections Code §1301 and §10403.5, the date of the General Municipal Election of the City of Artesia, California is moved from the first Tuesday after the first Monday in March of odd-numbered years to the first Tuesday in November of each odd-numbered years.

Section 2. In accordance with the change of election date, the terms of office of those members of the City Council presently serving shall be extended for a period of approximately six (6) months until election results are declared by the City Council.

Section 3. Pursuant to Elections Code §10403.5, this ordinance shall take effect on the latter of (i) thirty (30) days after its final passage by the Artesia City Council, or (ii) upon approval by the Los Angeles County Board of Supervisors. Within 30 days after the ordinance becomes effective, the City Clerk/Treasurer shall cause a notice to be mailed to all registered voters of the city informing them of the change in the election date and, that as a result of the change in election date, the new terms of office of the elected city officeholders.

Section 4. The City Clerk/Treasurer shall, without delay, forward two (2) certified copies of said Ordinance to the Executive Director of the Los Angeles County Board of Supervisors, at 383 Hall of Administration, Los Angeles, California 90012.

Section 5. Ordinance 508 is hereby repealed in its entirety.

Section 6. The City Clerk/Treasurer shall certify to the passage and adoption of this Ordinance and shall cause the same to be posted or published according to law.
