REQUEST FOR EXTENSION OF REPORT FOR A TEN-YEAR GRATIS LEASE WITH MOMENTUM LA, INC. TO OPERATE A BIOTECH INCUBATOR (ITEM NO. 4, APRIL 20, 2010 AGENDA)

On May 26, 2010, the Chief Executive Office (CEO) requested an extension to August 20, 2010, to report back for the Board's consideration a lease with Momentum LA Inc. (Momentum) for the gratis use of County space at the former LAC+USC General Hospital (Hospital) to establish a biotech incubator pilot program.

Due to the slow delivery of Momentum's business plan and the complexity of negotiations, we are respectfully requesting an extension of the due date for our report to October 4, 2010. This extension will allow the CEO additional time to evaluate and negotiate a business structure that would allow the County to participate in obtaining an equity interest or other identifiable revenue stream created by the start-up incubator companies at the time of success, without potential liability. The CEO is also working toward identifying the location and extent of tenant improvements that may be required by Momentum that must be consistent with the LAC+USC Medical Center's General Hospital Reuse and Protective Storage Plan. The CEO continues to work with Momentum and the appropriate County departments to verify that the scope and location of the proposed tenant improvements can be completed to conform to the Hospital's State Historical Preservation standards, and within Momentum's construction budget.

REQUEST FOR EXTENSION OF REPORT FOR A TEN-YEAR GRATIS LEASE WITH MOMENTUM LA, INC. TO OPERATE A BIOTECH INCUBATOR (ITEM NO. 4, APRIL 20, 2010 AGENDA)

On August 18, 2010, the Chief Executive Office (CEO) requested an extension to October 4, 2010, to report back for the Board's consideration of a lease with Momentum LA Inc. (Momentum) for the gratis use of County space at the former LAC+USC General Hospital (Hospital) to establish a biotech incubator pilot program.

Because of initial deficiencies in Momentum's business plan, which has delayed its completion, and the complexity of ongoing negotiations, we are respectfully requesting an extension of the due date for our next report to January 15, 2011. This extension will allow the CEO and County Counsel time to evaluative and complete negotiations of a business structure that will enable the County to participate in obtaining equity or other identifiable revenue streams created by the start-up incubator companies at the time of success, without potential liability. It is anticipated that royalty or warrant agreements will be used to secure the County's long-term goal in obtaining potential revenue streams from the start-up biotech companies.

As information, the CEO and Momentum have been able to agree on a substantial number of terms and conditions relating to the use of a portion of the second floor of the Hospital. In addition, the CEO and County Counsel have made progress towards developing a comprehensive contract with Momentum, which will include a detailed operating plan that defines benchmarks, a governance structure, and an educational component.

The CEO has enlisted the assistance of consultants who are specialized in the field of biotech development. These advisors include Dr. Mark Lieberman, who manages the business incubator program operated by the County's Community Development Commission. Dr. Lieberman has assembled a team of renowned experts in the biotech field, who include Dr. Kevin J. Scanlon, Dr. Ananth Natarajan, MD and Richard Morganstern. They have formed a small outside advisory committee to assist CEO staff with this complex transaction.

In addition, County Counsel has retained outside specialized legal counsel to assist in the development of Momentum's operating agreement, the compensation-related documentation, and ancillary documents to complete the proposed contract. It is anticipated that CEO staff will present the details of the transaction at the appropriate cluster group meeting upon its completion to provide the Board offices with the opportunity to discuss the matter in detail.

REPORT UPDATE FOR A TEN-YEAR GRATIS LEASE WITH MOMENTUM LA, INC. TO OPERATE A BIOTECH INCUBATOR (ITEM NO. 4, APRIL 20, 2010 AGENDA)

On October 14, 2010, the Chief Executive Office (CEO) requested an extension to January 15, 2011, to report back for your Board's consideration of a lease with Momentum LA Inc. (Momentum) for the gratis use of County space at the former LAC+USC General Hospital (Hospital) to establish a biotech incubator pilot program.

As previously reported, initial deficiencies in Momentum's business plan has delayed its completion, however, the recent addition of new information and data requested by the CEO in January 2011 has been provided by Momentum, rendering the business plan complete.

In light of this recent development, County Counsel, with the assistance of outside legal counsel is in the process of completing all of the transactional documents consisting of a lease, a purchase warrant agreement, and an incubator program agreement. These documents collectively will ensure the County's opportunity to participate in potential revenue streams of the start-up incubators, if they achieve success at some later time, and outline Momentum's responsibility to maintain and operate both the gratis space in the Hospital and the incubator program.
