


ANALYSIS

This ordinance amends Title 6 – Salaries, of the Los Angeles County Code, relating to the Los Angeles County Employees Retirement Association (LACERA) only, by

- Adding and establishing the salary for three (3) employee classifications, applicable only to LACERA;
- Adding the number of ordinance positions for the new employee classifications, applicable only to LACERA;
- Providing for a certification bonus for persons holding the position of Quality Auditor I, LACERA; Quality Auditor II, LACERA; and Senior Quality Auditor, LACERA;
- Adjusting the salary for one (1) non-represented employee classification;
- Correcting salaries for four (4) non-represented employee classifications which were inadvertently omitted from a previous ordinance approved by the Board of Supervisors on April 7, 2009.

ORDINANCE NO. 2010-0026

An ordinance amending Title 6 – Salaries of the Los Angeles County Code, relating to personnel of the Los Angeles County Employees Retirement Association (LACERA).

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 6.28.050 (Table of Classes of Positions) is hereby amended to add the following classes:
