SUBJECT

This action is to amend the Florence-Firestone/Walnut Park Shuttle Service Contract 77635 with Diversified Transportation L.L.C., d.b.a. Keolis Transit America to add transit service to the unincorporated County of Los Angeles community of Baldwin Hills.

IT IS RECOMMENDED THAT THE BOARD:

1. Find that the contract work is statutorily exempt from the California Environmental Quality Act.
2. Find that this service can be more economically performed by an independent contractor than by County employees.
3. Approve and instruct the Chairman of the Board to execute Amendment 24 to the Florence-Firestone/Walnut Park Shuttle Service Contract 77635 with Diversified Transportation L.L.C., d.b.a. Keolis Transit America to add operation and management of transit service for the Baldwin Hills

Parklands Shuttle Service commencing upon the Board's approval through August 31, 2013, at an estimated cost of \$40,000 for the current first contract term and remaining three 1-year renewal options at an annual amount of \$60,000 with an additional \$20,000 annually for major vehicle repair work and graphics for County-provided service vehicles in accordance with the amended contract and a month-to-month extension up to 6 months, increasing the annual contract amount to \$367,525 for the current contract term and increasing the annual contract amount to \$387,525 for the remaining option years. ~~for a maximum potential total contract term of 50 months and a potential maximum contract sum of \$340,000.~~

4. Authorize the Director of Public Works or her designee to annually increase the contract amount up to an additional 10 percent of the annual contract sum for unforeseen additional work within the scope of the amended contract, if required.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended action is to amend Contract 77635 with Diversified Transportation L.L.C., d.b.a. Keolis Transit America to add transit service to the unincorporated County community of Baldwin Hills.

Implementation of Strategic Plan Goals

The Countywide Strategic Plan directs the provisions of Operational Effectiveness (Goal 1) and Integrated Services Delivery (Goal 3). Having a contractor that has the specialized expertise to provide this service accurately, efficiently, timely, and in a responsive manner will support the Department of Public Works in meeting these goals.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

The annual cost for the Baldwin Hills Parklands Shuttle Service is \$40,000 for the remainder of the first contract term and \$60,000 annually for the renewal options with an additional \$20,000 per year for major vehicle repair work and graphics to County-provided service vehicles in accordance with the amended contract plus 10 percent of the annual contract sum for unforeseen additional work within the scope of the amended contract. This amount is based on Public Works' estimated annual requirements for the service at the hourly rates quoted by the contractor.

The necessary funds are available in the Second Supervisorial District's Proposition A Local Return Transit Program and included in the Fiscal Year 2012-13 Transit Enterprise Fund Budget. Funds to finance the service's option years, including 10 percent additional funding for contingencies, will be requested through the annual budget process.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

On August 16, 2011, the Board approved Contract 77635 with Diversified Transportation L.L.C., d.b.a. Keolis Transit America for the operation and management of the Florence-Firestone/Walnut Park Shuttle Service. The contract is for an initial 1-year period that began on September 1, 2011, with four 1-year renewal options. This amendment to Contract 77635 will provide connections to Baldwin Hills Scenic Overlook and Kenneth Hahn State Recreation Area from Metro Expo Line. The Baldwin Hills Parklands Shuttle Service is scheduled to operate Saturday, Sunday, and holidays from 8 a.m. to 6 p.m.

The enclosed amendment has been executed by the contractor and approved as to form by County Counsel. Except as modified in this amendment, all remaining terms, conditions, requirements, prices, and specifications of Contract 77635 will remain unchanged.

The contractor has agreed to pay its full-time employees the current Living Wage Rate approved by the Board on February 6, 2007, and to comply with the County's Living Wage reporting requirements. The County's Proposition A and Living Wage Ordinance provisions apply to this proposed contract, as County employees can perform this contracted service. The contract complies with all of the requirements of the Los Angeles County Code, Section 2.201. The contractor will pay its full-time employees the required minimum rates of \$11.84 per hour without health benefits or \$9.64 per hour with health benefits of \$2.20 per hour, as specified in the Living Wage Ordinance adopted by the Board and will comply with the County's Living Wage reporting requirements.

ENVIRONMENTAL DOCUMENTATION

This service is statutorily exempt from the California Environmental Quality Act pursuant to Section 21080 (b)(10) of the Public Resources Code. This exemption provides for the implementation of passenger or commuter transit services.

The approval of this amendment will add the Baldwin Hills Parklands Shuttle Service and will not result in the displacement of any County employees ~~since the existing service is contracted with the private sector.~~

AMENDMENT 24 TO CONTRACT 77635

FLORENCE-FIRESTONE/WALNUT PARK
SHUTTLE SERVICE

BALDWIN HILLS PARKLANDS SHUTTLE SERVICE

THIS AMENDMENT, made and entered into as of this 8th day of January, 2013~~2~~, by and between the COUNTY OF LOS ANGELES, a subdivision of the State of California, a body corporate and politic (hereinafter referred to as COUNTY), and Diversified Transportation, L.L.C., d.b.a. Keolis Transit America (hereinafter referred to as CONTRACTOR).

WITNESSETH

WHEREAS, Contract 77635 was entered into between the COUNTY and the CONTRACTOR on August 16, 2011, for the Florence-Firestone/Walnut Park Shuttle Service; and

WHEREAS, in accordance with the Contract's Exhibit B, Standard Terms and Conditions Pertaining to Contract Administration, Section 2, the COUNTY desires to add additional service in the unincorporated Baldwin Hills area to Contract 77635; and

WHEREAS, CONTRACTOR is willing to provide the additional transit service.

NOW, THEREFORE, in consideration of these facts and payment to be made by COUNTY, COUNTY and the CONTRACTOR agree that Contract 77635 between them shall be amended as follows:

FIRST: That Contract 77635 is hereby amended and modified to include shuttle service in the Baldwin Hills area for the current contract period expiring on August 31, 2013, at such times and places specified along the established operating route as shown in Exhibit O.

SECOND: That CONTRACTOR shall be compensated at the rates provided in Form PW-2 (Schedule of Prices) previously approved under Contract 77635. The cost for these additional services shall not exceed \$60,000 per year pro-rated for the remaining contract year, from January 12, 2013 to August 31, 2013, plus \$20,000 for major vehicle repair and graphics, increasing this Contract's not-to-exceed amount from \$307,525 to \$367,525, and from \$307,525 to \$387,525 for each of the remaining three 1-year renewal options or such greater amount that the COUNTY Board of Supervisors may approve.

THIRD: Contract 77635 is amended to include the attached Exhibit O, Baldwin Hills Parklands Shuttle Service Route, Schedule, and Fare.




