Dear Chairman Louie and Commissioners:

The Studio City Neighborhood Council is pleased to lend our support to the NBCUniversal Evolution Plan as presented to us. Both our assigned representatives to the DEIR and our Board recommend that the Regional Planning Commission vote to approve the project.

NBCUniversal's commitment to more than \$100 million in transit and transportation improvements is unprecedented, particularly since the company jettisoned the residential component of their project that would have created the most traffic impacts.

Further, we are supportive of the company's reduction of future building heights (from 19 stories to 14 and 12) and their revised signage proposals which state that there will be (no additional digital signs) within the project site or within the sign district which would be visible outside the project site. Specifically, there will be no additional digital signs along Lankershim Boulevard, Barham Blvd or the South side of the project which would be visible from the 101 Freeway in response to our community's concerns. We would like these changes incorporated into a revised Evolution Plan Specific Plan. With these changes, we are supportive of a Specific Plan for the County area of the property.

NBCUniversal's pledge to provide resources to Studio City for much-needed Neighborhood Protection and Beautification efforts demonstrates their intention of being an involved and participative member of the community in the years to come.

Dear Chairman Louie and Commissioners:

Portions of NBCUniversal are located within the City of Los Angeles, and thus within the geographic boundaries of the Hollywood Hills West Neighborhood Council (HHWNC).

When first proposed in 2007, the magnitude of the NBCUniversal project raised a number of strong concerns on the part of our stakeholders. Of particular concern was the proposal to build nearly 3,000 residential units, many in multi-level towers, on a portion of the studio's backlot. Density, view and traffic impacts and the increased burden on schools and libraries, were just some of the problem areas. Additionally, the lack of specificity about mitigation measures to address increased traffic was highly problematic.

However, the decision by NBCUniversal to eliminate the residential component of the Evolution Plan and instead focus on investment in their production and tourism businesses has allayed our concerns related to housing on the property.

Additionally, NBCUniversal's commitment to invest more than \$100 million in traffic and transit improvements and a comprehensive traffic study contained in the Final EIR which details specific improvements to targeted intersections, freeway sections, on- and off-ramps and other infrastructure improvements, has significantly reduced our traffic-related concerns.

Finally, NBCUniversal's commitment to allow no digital signage at the corner of Barham and Buddy Holly Drive has addressed our concern about signage at that gateway location. And, we applaud the company's decision to keep their two-acre parcel at Barham within the boundaries of the Mulholland Scenic Corridor Specific Plan.

At our meeting on September 19, 2012, the Board of Directors of the Hollywood Hills West Neighborhood Council voted to support the NBCUniversal Evolution Plan – No Residential Alternative. We believe the benefits the project will bring to local communities, the county and the region, outweigh any negatives that may remain.

Dear Chair Louie and Planning Commissioners:

On behalf of the Los Angeles County Economic Development Corporation (LAEDC), an organization dedicated to promoting job growth, economic expansion and preserving the overall global competitiveness of Los Angeles County, I am writing to express our strong support for the NBCUniversal Evolution Plan (the "Evolution Plan"). We believe that the Evolution Plan creates new and innovative private sector solutions for transportation and transit improvements as well as environmental stewardship, while also supporting tens of thousands of much-needed construction jobs and promoting two of Los Angeles County's most important industry clusters: hospitality and tourism, which supports more than 360,000 jobs in L.A. County; and entertainment, which supports more than 160,000 high-value jobs in the County.

The Evolution Plan sets out a 20-year blueprint for NBCUniversal's 391-acre Universal City property. The project will include a number of new attractions at the Universal Studios Hollywood theme park, tens of thousands of new square feet of retail and dining options, and two 500-room hotels. The plan also includes about \$100 million in mobility, congestion-relief and environmental improvements achieved through enhanced connectivity to a number of intermodal transit options along with other transportation demand management and environmental impact mitigation measures.

In addition to the improved transportation, transit and environmentally-beneficial aspects of this project, the economic and job creation potential benefits for Los Angeles County are also considerable. NBCUniversal estimates that the proposed Evolution Plan would create more than 30,000 high-wage jobs during construction and operations. Additionally, the project's new attractions, destination spots and recreational options will not only enhance the economic impacts around the Universal City facility, but they will significantly stimulate our entire region's hospitality and tourism industry as substantially more visitors from around the United States and the world visit the Los Angeles region to take in these exciting new additions.

The Evolution Plan will also add much-needed production capacity and studio spaces, demonstrating NBCUniversal's commitment to investing in the entertainment business here in

Southern California at a time when our world-leading film and television production sector faces an existential threat from other states and nations actively pursuing, enticing, and poaching these productions out of our own backyard – and with them, many billions of dollars in lost economic activity, wages, local spending and tax revenue as well. Right now, there is great demand and need for additional production, studio and soundstage spaces, which during peak production periods can have vacancies near one percent.

As a result, we must encourage long-term investments in studio infrastructure by building and/or upgrading production facilities to support and strengthen Los Angeles County's overall entertainment industry. It is our view that only by approving and accelerating the development and delivery of critical entertainment infrastructure projects such as the NBCUniversal Evolution Plan – along with other film-friendly initiatives – can we effectively combat, slow, and hopefully reverse the flight of film and television productions out of Los Angeles County and California.

We hope that you will adequately consider all of the above when assessing the bona fides of the Evolution Plan as well as other similarly critical development projects that can help position and prepare L.A. County for economic recovery, growth, and long-term success. We look forward to working with you to ensure that this project is approved, built, and fully operational as quickly as possible to create much-needed construction and entertainment-related jobs, grow our local, county and regional economies, and strengthen our region's leading employment clusters and thus the overall quality of life for all our residents.

For all of these reasons, the LAEDC strongly supports the NBCUniversal Evolution Plan.


Dear Chairman Louie and Commissioners:

Our coalition has been participating in the planning process for the NBCUniversal Evolution Plan for many years because of the project's importance to the region and because of the project's critical relationship to the Los Angeles River. We were greatly encouraged by the announcement at the September 27, 2012 City Planning Commission meeting of NBCUniversal's major commitment to river revitalization as part of its project.

NBCUniversal has represented to our coalition that as a community benefit of the project:

- NBCUniversal will provide funding in the amount of \$500,000 to the Los Angeles County Flood Control District River Construction Trust Fund for planning and design of the regional river bikeway between the existing bikeway at Griffith Park and Whitsett Avenue/Studio City. The funding will be provided within ninety (90) days of the effective date of the Development Agreement(s). We would very much like to be an active participant in the design and planning process.
- NBCUniversal also will provide funding in the amount of \$3,000,000 to the Los Angeles County Flood Control District River Construction Trust Fund to be used for construction of the regional river bikeway on the County property adjacent to the NBCUniversal property. The amount will be contributed by NBCUniversal following the completion of the design and approval by the City and County of Los Angeles of a regional river bikeway plan between the existing bikeway at Griffith Park and at Whitsett Avenue/Studio City, including compliance with CEQA and NEPA, understanding that in no event will the contribution be paid prior to June 30, 2016.
- NBCUniversal will also provide \$375,000 to the City of Los Angeles Bicycle Plan Trust Fund toward study and implementation of on-street bicycle facilities in the vicinity of NBCUniversal, including Lankershim Boulevard, Cahuenga Boulevard and Barham Boulevard. The funding will be provided within ninety (90) days of the effective date of the Development Agreement.

These commitments will create a significant regional benefit and will safeguard and support the public interest by incorporating the LA River greenway as part of the Evolution Plan. Based on these commitments, which are requesting be made conditions of the project Development Agreements with both the City and County of Los Angeles, we are writing to strongly support the Regional Planning Commission's approval of the NBCUniversal Evolution Plan.



In regards to the proposed Universal Studios property expansion (Plan TR068565), I have lived in Burbank for 17 years and I have a solution to help reduce the potentially increased traffic that will be brought upon Barham Blvd., Olive Ave., Alameda Ave. and Forest Lawn Drive with the proposed expansion. I work in the Entertainment business and I have used Barham Blvd. every day for 17 years to get to my place of work in Hollywood and West L.A. If you look at the current traffic pattern of Barham Blvd., Olive Ave., Alameda Ave. and Forest Lawn Drive, they currently absorb all traffic for those daily commuters who need to get into Hollywood, Los Angeles and West Los Angeles from points East of Universal, such as Pasadena, Glendale and Burbank. Adding a lane to Barham won't help much with decreasing the current daily traffic jams, and the added lane certainly won't help the current traffic jamb on Olive, Alameda and Forest Lawn Drive.

My suggestion is to add connection lanes to the 101 Freeway and 134 Freeways that will allow much of this side-street traffic to remain on the Freeways where it should be. Please take a look at the current 101 and 134 Freeway lanes: Anyone traveling Westbound on the 134 Fwy must exit and use side streets to get access to the 101 Fwy South, and the same holds true for Northbound 101 Fwy traffic for those who need to get to points East. These Freeway lane connections would help tremendously to reducing the current heavy traffic loads on the side streets mentioned that will certainly see increased traffic if the Universal expansion happens.

Thank you for the opportunity to comment on this matter. In August of last year, I submitted detailed comments on the Final EIR—to Mariana Salazar, of L.A. City Planning.

I applaud the thrust of the latest version of the Evolution Plan—especially NBC/Universal’s long-term commitment to local entertainment production.

However, as a near-by resident (and “sensitive receptor”), I cannot support a plan that will generate numerous significant and unavoidable negative environmental impacts—during both the construction and operational phases.

Additional mitigation measures and/or a downsizing of the plan would help to balance regional goals with the existing quality-of-life of the area.

The number one mitigation, for me, would be completion of the two “missing connectors” to the 101/134 Freeway interchange:

Westbound SR 134 to Southbound US 101
Northbound US 101 to Eastbound SR 134

This major traffic infrastructure improvement should precede large-scale projects, such as the NBC/Universal Evolution Plan, and the inevitable development of the properties near Lankershim Boulevard and the 101 Freeway.
