II. PUBLIC HEARINGS

3. Hearing on application for Annual Dance/SC for the City of Santa Clarita, Business License ID# 140917, to issue a new license to Carla Hunt Smallwood, owner of Dance Studio 84, located at 27889 Smyth Drive, Valencia, CA 91355 in the Fifth District. (14-1678)

Rita Bowman, Treasurer and Tax Collector's Office (TTC), reported that the application is for an Annual Dance business license and the hearing is being held for the City of Santa Clarita. The applicant has obtained all the necessary County approvals; the City of Santa Clarita has no objection to the issuance of the license.

Carla Hunt Smallwood, owner of Dance Studio 84, provided a brief overview of the business. Ms. Hunt Smallwood indicated that the studio offers lessons in various dance styles such as tap, jazz, ballet, hip hop, step and tumbling to patrons three years of age to adult with approximately 745 patrons.

In response to questions posed by President Afriat, Ms. Hunt Smallwood confirmed the existence of a Conditional Use Permit (CUP).

On motion of Secretary Vasquez, seconded by Commissioner Campbell, and unanimously carried by the following vote, the Commission approved the aforementioned license with the condition that they comply with the existing Conditional Use Permit.

4. Hearing on application for Annual Dance/SC for the City of Santa Clarita, Business License ID# 139851, to issue a new license to NMP Inc./Jacqueline Hill, President of Elite Dance Studios, located at 28368 Constellation Road #330, Santa Clarita, CA 91355 in the Fifth District. (14-1679)

Rita Bowman, Treasurer and Tax Collector's Office (TTC), reported that the application is for an Annual Dance business license and the hearing is being held for the City of Santa Clarita. The applicant has obtained all the necessary County approvals; the City of Santa Clarita has no objection to the issuance of the license.

Jacqueline Hill, representative for Elite Dance Studios, provided a brief overview of the business. Ms. Hill indicated that the studio offers lessons in various dance styles such as tap, jazz, ballet and lyrical to approximately 400 patrons, 2 - 18 years of age. Hours of operation are generally Monday through Sunday, 9:30 a.m. to 12:00 p.m.; however, Saturday classes are held from 3:00 p.m. to 8:00 p.m. Ms. Hill also stated that the facility is approximately 4,100 square feet and 2 - 3 classes are held at once with 4 - 6 classes per day.

In response to questions posed by the Commission, Ms. Hill confirmed that most staff and applicants are professional dancers pursuing careers in teaching choreography.

On motion of Commissioner Campbell, seconded by President Afriat, and unanimously carried by the following vote, the Commission approved the aforementioned license with the condition that they comply with the existing Conditional Use Permit.

5. Hearing on application for Entertainment-General, Business License ID# 140916, to issue a new license to Marie Callender's #97, Marie Callender's Pie Shop, LLC, John Charles Bowler, Senior Vice President of Operations, located at 27630 The Old Road, Valencia, CA 91355 in the Fifth District. (14-1680)

Rita Bowman, Treasurer and Tax Collector's Office (TTC), reported that the application is for an Entertainment-General business license. The applicant has obtained all the necessary County approvals; TTC has no objection to the issuance of the license.

John Charles Bowler, representative for Marie Callender's Pie Shop, LLC, provided a brief overview of the business. Mr. Bowler indicated that entertainment will consist of a family friendly, Comedy Show Night. The show is held in the bar area; Friday and Saturday nights from 7:00 p.m. to 11:00 p.m. Mr. Bowler confirmed that the facility does have a stage however, there is no dressing room.

President Afriat explained that a licensed manager must be present when utilizing the license; in Mr. Bowler's absence, another manager must be licensed during the show.

The Commission asked TTC to ensure they inform applicants of the license requirements.

On motion of President Afriat, seconded by Commissioner Campbell, and unanimously carried by the following vote, the Commission approved the aforementioned license with the following conditions:

1. Comply with the existing Conditional Use Permit; and
2. Stage and dressing room waiver.
