This ordinance amends Title 6 – Salaries of the Los Angeles County Code to make a technical correction relating to the Los Angeles County Employees Retirement Association (LACERA) only, by:

Amending Section 6.28.050 to change the salaries and/or effective dates of one non-represented LACERA classification that was previously omitted to reflect a 3 percent general salary adjustment effective January 16, 2014; a 3 percent general salary adjustment effective January 1, 2015; and a 3 percent general salary adjustment effective January 1, 2016.
