**APPROVAL FOR INCIDENTAL EXPENSES IN EXCESS OF \$5,000 FOR THE 2016 SUCCESS IS
OUR FUTURE ACADEMIC ACHIEVEMENT AWARDS CEREMONY**

(ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

SUBJECT

The County of Los Angeles Probation Department (Probation) is seeking approval to fund expenses incurred at the 2016 Success is Our Future Academic Achievement Awards Ceremony (Ceremony) which will be held on May 19, 2016, at the Almansor Court in the City of Alhambra.

IT IS RECOMMENDED THAT THE BOARD:

Authorize the Chief Probation Officer to work with the Director of Internal Services to allocate a purchase order in an amount not to exceed \$24,000 for food and related costs for the 2016 Success is Our Future Academic Achievement Awards Ceremony.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended actions will allow Probation to work with the Internal Services Department (ISD) to allocate a purchase order in an amount not to exceed \$24,000 for food and related costs for the Ceremony. Board approval is required for incidental expenditures in excess of \$5,000 (L.A.C.C. 5.40.097).

The Ceremony will provide resources, networking opportunities, and financial support to older youth, which will improve self-sufficiency outcomes and assist them as they move forward into college and higher education. The Ceremony is an annual event that is part of the State-mandated System

Improvement Plan (SIP) goals, which include increasing permanency and self-sufficiency for transition-aged youth. It has assisted many youth in not only graduating from college, but going on to achieve even higher degrees. The main focus of the Ceremony is to acknowledge, celebrate, and reward the academic achievement of Probation foster youth in Los Angeles County and honor these youth with scholarship and monetary awards for college. Invited guests include representatives from the Superior Court, Los Angeles County Office of Education, Public Defender's Office, District Attorney's Office, group home providers, parents, and friends. Highlights of the Ceremony include talents displayed by current and former Probation foster youth, guest speakers, presentations of scholarships, and media presentations.

Implementation of Strategic Plan Goals

The recommended action is consistent with the County of Los Angeles Strategic Plan Goal 1, Operational Effectiveness, and Goal 3, Integrated Service Delivery.

FISCAL IMPACT/FINANCING

The estimated total for food and related costs of the Ceremony is in an amount not to exceed \$24,000. Sufficient funding is included in Probation's Placement Bureau budget and there is no additional net County cost. Approximately 58% of the actual costs incurred will be claimed from Child Welfare Services Outcome Improvement Project (CWSOIP) funding.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The estimated expense of \$24,000 exceeds \$5,000 and must be approved by your Board. The Ceremony is an annual event that will benefit and improve outcomes for all participating youth. The Ceremony is necessary to fulfill the strategies and goals of the State-mandated and Board-approved SIP. The State provides CWSOIP funding with the expectation that the counties will use the funding in order to successfully complete the SIP goals with effective results.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Approval of this action will allow Probation to meet the State-mandated SIP goals.
