

1 A I saw it on a shirt, I believe.

8 was wearing it.

9 Q Okay. Have you seen other people with that
10 tattoo on their bodies?

11 A Yes.

12 Q Who? Name all the people you've seen that
13 tattoo on.

14 A Okay. Let me see. Jose Sandoval, Jessie
15 Sandoval, Omar Covarrubias. Let me think. James
16 Cross, Ruben Jimenez, Edwin Barajas, Taylor
17 Ingersoll, Samuel Aldama, Mizrain -- that's
18 M-I-Z-R-A-I-N -- Orrego.

19 And that's it from the top of my head, sir.

20 Q Have you ever been present when another
21 deputy got that tattoo?

22 MR. PETERSON: You mean as it was being
23 administered?

24 MR. ROMERO: Yes.

25 MR. PETERSON: Okay.

2 Q Okay. Did you ever refer to those as
3 inking parties?

4 A No.

5 Q Have you ever heard anyone refer to those
6 events as inking parties?

7 A Yes.


