SUBJECT: PROGRESS ON IMPLEMENTATION OF THE ELIMINATION OF THE

USE OF OLEORESIN CAPSICUM (OC) SPRAY (14th MONTHLY

REPORT)

On July 8, 2021, the Los Angeles County Probation Oversight Commission (POC) requested that the Probation Department provide a written report to the POC every 30 days to report on the progress on implementation of the elimination of the use of Oleoresin Capsicum (OC) Spray, including a timeline with dates for key interim benchmarks and steps towards elimination, including the specific target date when the use of OC spray will be eliminated.

TRAINING PLAN

The Probation Department continues to conduct block week in-person trainings for the employees of the Detention Services Bureau (DSB) at the Probation Training Center.

There has been a total of 58 cohort trainings conducted since September 21, 2021. The training completion has continued to be monitored and tracked to ensure full compliance. Employees are reporting to the Probation Training Center and participating in week two of the training.

Although training efforts have remained steady since September 21, 2021, the staffing patterns in DSB have continued to experience challenges. Staffing instabilities have caused a decline in attendance rates that impacted the Staff Training Office from running concurrent cohorts during this reporting period.

The Probation Department started a Deputy Probation Officer (DPO) II re-assignment training that began on April 3, 2023. As of May 4, 2023, there are 96 DPO IIs who have received 40 hours of training (week two). These employees also received 40 hours of on-site training upon arrival at Barry J. Nidorf (BJNJH) and Central Juvenile Hall (CJH).

The chart below illustrates the total number of DSB staff that reported to block week one training and week two by facility through May 3, 2023.



As of May 4, 2023, there have been 685 DSB employees training in the Physical Intervention Policy Review training. There were 68 employees who received Basic Handcuffing training on-site at CJH. In addition, there were also 98 employees who received the Supervision of Developmentally Disabled Youth training at CJH. Deescalation training has been provided in Cohort week one and on-site at CJH. Department-wide, there have been 527 employees trained in De-escalation Institutions training.


The chart below illustrates the DSB OC Spray Incident totals by month from June 2021 through April 2023.
