This note was written quickly and therefore may not be exhaustive. It may also contain syntax or typographical errors which I hope will not detract from its message.

The memorandum by Mr. Kennedy brings up some important points. Unfortunately the ostensibly reasonable points in the memorandum are rendered suspect by the fact that it appears to be no better (and perhaps far worse) than what it criticizes. It is in no way an even-handed and skeptical document, using suggestive and illogical language that reads like a political smear and an attempted character assassination. Moreover, the timing of the memorandum makes it even more suspicious. We have to wonder why Kennedy didn't bring these concerns up (some dating back two years or more) at the time. Instead he waited until the Sheriff took a public stand against the corrupt city council, county supervisors, and the pet NGOs of some of their largest donors. Coincidence or indicative of his own ulterior motives?

The saddest part is that I'm sympathetic to the general premise of the memorandum. And if written differently, by a different person, under different circumstances it very well could have been something worth supporting. I agree wholeheartedly that announcing an 'investigation' in order to smear a political rival is a tactic that must be strongly denounced. I also agree that there has been an extremely troubling recent history of law enforcement being used for political intimidation (just look into what happened to the former mayor of Malibu Jefferson Wagner when he dared oppose a Villaraigosa crony Reva Feldman's installation as city manager). If Kennedy would have stuck to facts he might have retained some credibility. Instead here are a few instances where he shows himself to be less trustworthy than his target and unworthy of serious consideration:

1. The fact that charges were never filed in investigations does not, as Kennedy claims 'suggest an ulterior motive'. It may raise Kennedys suspicion and it may be a good reason not to announce an investigation regardless of whether or not charges are filed, but surely there are often investigations made (and even announced) that don't wind up resulting in charges. Do they all raise similar suspicions in Kennedy or is he only suspicious when the investigations announced are against certain people?

2. Kennedy writes "The Los Angeles County Sheriff Civilian Oversight Commission (COC) should call for an investigation to ascertain whether Sheriff Alex Villanueva is abusing his power or extorting public officials." This sentence in the first paragraph seems to expose the author's bias succinctly. He doesn't call for an oversight committee investigation into 'whether or not' the sheriff is abusing his power and/or extorting public officials'. For him it is a choice between abusing power and extorting officials. An investigation that leaves no space for innocence is not an honest investigation.

3. Kennedy writes an entire section called 'Legal Analysis' without once referencing a criminal code or a law broken. It refers in footnote to DOJ manuals. It isn't clear that the sheriff's department is legally beholden to such manuals (or indeed that anyone is). The manual he refers to states that " It is not intended to, does not, and may not be relied upon to create any rights, substantive or procedural, enforceable at law by any party in any matter civil or criminal." So much for 'legal analysis'... Perhaps that's why there are countless examples of the guidelines being broken both officially and through strategic 'leaks'. Perhaps that's also why the manual says that it will 'generally' not disclose details of ongoing investigations. I have already established that I agree that this should not be done and that in light of it being done nobody should take announcements of 'investigations' seriously. But it nevertheless happens routinely and it serves as no basis for presuming the violation of laws. For him legal analysis seems to consist of footnoting 'general' guidelines with no legal teeth and allegations made in various press pieces. It might also be worth digging into the polarization of the publications and journalists quoted, but that would require more time than I have and I'm not entirely sure that it is necessary to establish Kennedy's hypocrisy.

4. Kennedy, makes the misstep of equating stated FBI investigation with reason for suspicion. The FBI has its own checkered (and potentially criminal) past when it comes to selectively investigating for political reasons — and announcing those investigations publicly even when they do not lead to prosecutions. Just as no announcement of a sheriff's department investigation should be taken as evidence of guilt (or even genuine evidence of wrongdoing), nothing the FBI does should be taken as prima-facie evidence that the sheriff's department is up to no good. That's a misstep that Maya Lau of the LA Times seems to make as well. It can be filed either under naiveté or political motivation. I hope it's the former.

5. Kennedy uses the absence of an FBI confirmation of FBI involvement as evidence that the allegation of FBI is unfounded. That presumes that a) the FBI would be under some legal obligation to confirm or deny the allegation and b) that any confirmation or denial by the FBI would itself be trustworthy. The notion that an allegation is false merely because it was neither confirmed nor denied by the accused is ridiculous and has no place in a serious critique of the department's actions. That isn't legal evidence of anything and it certainly isn't 'legal analysis'. Moreover it doesn't acknowledge the history of the FBI and its role in politics.

6. Kennedy seems to obsess over a deputy's tattoo as if the existence of a tattoo on a deputy somehow proves that the sheriff is 'abusing his power or extorting public officials). Surely the existence or nature of a tattoo on a deputy isn't smoking gun evidence that the deputy in question has broken a law or that the department has broken the law by having deputies with tattoos. This doesn't mean that gang-like behavior by law enforcement shouldn't be investigated if and when it does break the law. But that should be its own discussion and doesn't relate in any concrete way to the abuse of power or extortion allegations.

7. Kennedy paints the sheriff as 'resentful' ostensibly as a way to introduce a motive for the alleged misconduct. Is there any evidence that the sheriff was in fact 'resentful' or that his objections to being removed from a role and having his budget cut were born of a feeling of resentment and not some other more reasonable? Might it not be reasonable for a sheriff or anyone facing budget cuts to object without 'resentment'?

8. Kennedy quotes from the mission statements of the United Way and Peace Over Violence mission statements as evidence that the organization must be beyond reproach and that any investigation into them would be de-facto wrong. This is illogical. No organizations' mission statement preclude it from violating it and/or participating in unrelated activities for unrelated reasons. Moreover the idea that collusion can only occur between public officials and NGOs when there is financial remuneration directly from the NGO to the official in question is naive at best. It may be true that in Hamai's failing to take compensation from United Way resulted in his avoidance of explicit criminal behavior. But it is not clear that simply because he doesn't take direct monetary compensation Hamai's involvement on the board of United Way is somehow noble, ethical, or even lawful. His involvement may well be of value to his political allies, and their donors. And he may be remunerated in other ways for his 'volunteer' service. An honest assessment of the situation would be appropriately even-handed and skeptical of Hamai and the United Way. Kennedy's analysis is neither of those things. An even-handed analysis might call for the prohibition on the participation of public officials in

politically active NGOs regardless of their mission statements. How is one inclined on the one hand to think that Hamai's NGO 'volunteer' work must be presumed innocent while the sheriff's investigations must be 'extortion'. While both are suspicious and should be prohibited, neither seem to meet the threshold for legal proof of wrongdoing.

9. Kennedy twice uses the fact that an investigation is 'uncommon' to cast doubt over its validity. This is another illogical claim. Certainly there are many investigations are both uncommon and valid. Kennedy should stick to evidence that the investigations are unfounded or malicious and not uncommon. This could be why he introduces the specter of 'resentment' — something that seems itself to be unfounded.

10. Kennedy has plenty of objections for how the sheriff proposes to investigate uphold the law and investigate political corruption. He uses reportage of the DA's refusal to cooperate in investigations as a way to paint the the sheriff's desire for investigation as somehow invalid. Couldn't the DA's refusal to cooperate just as easily say more about the DA's continuing role in colluding with potentially corrupt politicians and its numerous policies that make neighborhood law enforcement impossibly difficult than it does about the sheriff? And while DA Gascon might be especially flagrant in his institution of policies that make law enforcement more difficult, This is not something exclusive to him. Indeed his predecessor DA Lacey's department seemed to use law enforcement for political intimidation in Malibu (and perhaps elsewhere). In light of a pattern of DA collusion with corrupt politicians why would it be any surprise that the DA doesn't want to investigate wrongdoing by politicians? An even-handed analysis might wonder if the sheriff has a point. Do the DA and politicians the sheriff seeks to investigate share any donors or political allies? Might there be corruption afoot in the DA's office that better explains the DA's unwillingness to assist law enforcement in their mandate to uphold laws?

It is also laughable that where Kennedy presumes without skepticism that NGOs are somehow beholden to their noble mandates the sheriff MUST be acting in contrivance of his own mandate. NGOs, politicians, and the DAs office should be taken at their word, but the sheriff should be presumed to be acting out of self-serving 'resentment'. Why would this be the case for the sheriff and not his opponents?

11. Kennedy's appeal to 'experts' is one-sided and far from exhaustive. Surely there are 'experts' who have derided the very corruption that the sheriff is standing up to. Surely their points would easily paint a different picture than the one you've presented. An appeal to a handful of cherrypicked 'experts' and that quotes LA Times Article that admittedly wishes the sheriff were politically 'progressive' hardly makes for a balanced case or a compelling argument.

12. For all of his accusations of 'extortion' there is no evidence that the sheriff's publicity of any investigation resulted in the 'obtaining of an act from any sitting public official' or that such an act was induced by fear. There is likewise no evidence that 'consequences' refer to illegal activity or that the supposed 'consequences' would necessarily not occur even if the report were not published. In order to establish that the 'consequences' were in fact extortion one would presumably need to prove that there was 'attempted extortion' which would require proving something unprovable. This is not evidence of extortion but even stronger evidence of why publicizing investigations is such a serious issue and must be prohibited.

13. Kennedy writes that the COC should initiate an investigation by an 'independent entity' such as the US DOJ or or the CA Attorney General. In order for those investigations to be truly independent one would have to prove that there are no ties either direct or indirect between the sheriff's political opponents and the 'independent entities'. Are those in the suggested entities (both elected and unelected) share donors, (donors' pet NGOs) and political allies with the sheriff's political adversaries? If so how can they be called 'independent'? The suggestion of appointing potentially interested parties (both of whom also have histories of using public investigations as political tools) is a ridiculous situation. Would someone who truly wants to investigate the sheriff suggest such a course of action?

What are we left with?

It is possible that the sheriff has acted unethically in publicizing investigations. It would be completely reasonable to ask the sheriff not to do so in the future, to publicize such behavior, and even to work on creating guidelines and laws that would prohibit it by law. But any investigation launched on the back of or involving the author of such an illogical,

hypocritical, and political memorandum would itself be suspect. And if I were Kennedy, I'd resign my position immediately over this embarrassing memorandum. The oversight committee should be staffed by people with a genuine interest in investigating honestly and even-handedly and not by incompetent and intentionally-misleading political operatives.

My wife and I fully support LASD's recent actions to address the massive public safety and health hazards presented by encampments, and sincerely hope that this will be instituted as a permanent strategy and applied to ALL of LA County.

In April of this year an intoxicated unhoused individual literally broke in the front door of our residence using a fire extinguisher as a bludgeon at 3:30 AM after first vandalizing a restaurant, and was removed from our home at gunpoint by LAPD. We were completely random targets of this person, who has an extensive felony record in addition to a clearly severe substance abuse problem. He had been living in a nearby encampment for several weeks before this attack.

Civilization requires rules to function. It is glaringly obvious now that failing to enforce these rules produces chaos and danger to the public...to say nothing of danger to individuals incapable of understanding or refusing to follow these rules, which we call laws. He was recovering from a severe sunburn that had reduced his eyes to slits because one of us had gotten him a sunhat and ointments. But he still had several other very serious health conditions, including one that threatened his life. That day he talked about the traumas he'd experienced living in Venice's beachside encampments, which had ballooned to well over 200 tents and makeshift structures. He told us that he never felt safe because the encampments were riddled with criminal activity, including outsiders who preyed on the unhoused. The worst incident for him was this: in the middle of the night he had witnessed the brutal gang rape of a mentally impaired woman. His guilt at being able to do nothing to help because of the number of men involved continued to haunt him. He told us that he moved locations after that, and felt safer in his new spot. However, just a few weeks later, another unhoused resident was viciously murdered in that very same "safer" spot. This is the cruel reality of the Venice encampments. We as nearby residents are the only people who understand the depth of the problems because we are the only people with a 24/7 view, 365 days a year. St. Josephs staff seem to mean well, but they are young and often do not spend much time talking with the homeless. - Why does law enforcement need to justify its actions when enforcing the law to protect law abiding citizens?
- Why is the COC questioning jurisdictional issues when the goal is to enforce the law and protect law abiding citizens?
- As a stakeholder, why does law enforcement enforcement need to engage with law abiding citizens before enforcing the law that we have agreed to enact, now enforce?

I am in agreement in with the COC questioning LASD about prioritization of enforcement and what method is used to prioritize targets, but my feeling is that there may be a statistically higher percentage of violent crime attributed to Venice encampments than "skid row."

I have been a victim of Sheriff harassment, retaliation & abuse since 2017 coming to a head in April of last year 2020. I was targeted for several reason: personal vendetta for civil grievance against a friend/ family member of the Duarte sub station and 2) sheriff working with business retaliating against employees and patrons with civil rights grievances. Several of my civil rights & basic human rights were violated by deputies including sexual assault. While I was not a threat, semi conscious unable to move due to a medical emergency and unable to defend my modesty, my pants where pull down to my private area and my breast exposed by a female officer AFTER I was already settled on the gurney. She had to say " wait" so she could stop them from wheeling me away before she did it. During my arrest I was berated for my disabilities, kicked, pinched, locked in a vehicle with Windows up on a 80 degree day until I passed out. When moving me from the vehicle. I woke up to the same female officer cut my right arm with something. My body was left with many bruises. The deputies retaliation involved civilians in their lies and character assassination inciting others in the community to harass and assault me leading to this incident. I was targeted for seeking remedy through legitimate government channels of grievances. Deputy supervisor referenced my appeal to the sheriff oversight committee in 2018. He said I being targeted because he thought I was " being a professional victim" and a "trouble maker". Already in handcuffs He said to me, " I hope you hit someone or break a window so I can lock your a\*\*
