Robert Ray	Both Gooden and Tardy spent time at the Compton Station, but neither of them were asked what they witnessed with regard to "Deputy Gangs" while they were assigned to Compton. I think that question needs to be asked.
Robert Ray	Ms. Tardy stated she did a survey of calls for service. Did that survey include Compton Station? Did that survey include both 911 calls and calls that came in on the station phone number? I know for a FACT that not all calls to the Compton station phone are logged. I have called for service, and when I called back for ETA was told no record of my previous call.
Joseph Prosceno	I'm still homeless four years after the LAPD West Traffic Division refused to provide me vital information in regards to the identity of a Hit & Run and Battery Suspect who turned out to be a Film Production Security Guard. The Detective assigned to the case stated, "Get the information yourself". They then obtained an arrest warrant and arrested me at gunpoint after I said that I would do that and come in and forcefully take the information from them given that they were in violation of Penal Codes that prohibit anyone including police from refusing to provide vital information in the case of a hit & run involving physical injury. I later learned that they never arrested nor charged the suspect despite having him go to the station to provide his statement. I had and still have videos of the altercation of him refusing to provide his information and then attacking me and attempting to steal my phone. I lost my dream job, relationship with my family, the possibility of affording an apartment, and all trust in the Police. I was arrested a year later due to still sleeping in my car simply for sleeping in my car, was released the next day, but not before having my car towed. I was also subjected to Solitary Confinement for three days, being placed into a large holding cell alone for over 15 hours, with the air conditioning set to max to accommodate 12+ people, and being surrounded by the existing Hispanic gang members. Another arrest that resulted thi is a domino effect result of this arrest resulted in being placed into a smaller holding cell, built to hold approximately 8-10 people, with 15+ people immediately after showering, with no ventilation and 2/2 cameras removed, including one from the external hallway. This resulted in an unsurvivable humidity environment where other men in the cell began to pass out, the window completely fogged up, and I had to desperately bang on the door to have them open the food slot, which then the other men desperately crowded around for fresh air. Ron	Sandy Jo MacArthur presented useful and insightful information for changing the direction of police agencies. Essentially, she advocates focused and energized top leadership (as was change agent William Bratton), lesser or no time deputies spend in jail as they were trained to patrol, and rotating deputies out of stations after 5 years (some deputies in Compton have stayed up to 12 or more years but for deputies such as retired Rafer Owens that was a good thing for the city), the idea of an inspection/audit unit (I recommended and Sheriff Lee Baca adopted an internal audit unit some time back. The unit, albeit non-functional, still appears on the LASD org chart), and MacArthur emphasized the importance of key personnel such as sergeants and lieutenants.

She says, "we are doing a service to the justice system." In the case of Compton, police are to service the residents per their \$24.5 million contract. What's absent from Dr. MacArthur's presentation is that, like social workers and nurses, police are public servants there to serve communities. She never mentioned a role for the community. She never speaks about how communities differ and have different service needs. This is where LASD is a "complete failure" using their one size fits all approach. The city of Compton's non-progressive leadership aids and abets this failure by not holding LASD accountable.

Compton has never accessed the kind and quality of policing services that it needs. To do so means a serious discussion with its residents which may be long-term and ongoing. Should services delivered in Compton be the same as those rendered in Palos Verdes? Cerritos? Or Lakewood? NO. A serious assessment would then dictate the kind of services specifically tailored for Compton. For example, Compton has a serious problem with dumping, illegal cannabis dispensaries, and street shutdowns. Residents often complain about the quality-of-life issues that routinely go unaddressed. Many residents admit feeling unsafe and unwilling to shop locally because of those feelings. The allegations that rogue deputies run Compton's sheriff's station, and have for years, only increase those feelings. Compton is ground zero for deputy "cliques" yet the city's leadership does not address the problem.

Dr. MacArthur's presentation is excellent but for places like Compton, Willowbrook, and Rosewood,

does not go deep enough. Compton for example has sacrificed other services such as Recreation to pay for so-called law enforcement. Senior and youth services have been curtailed in favor of unaccountable sheriff services. Maybe Compton should take a page from West Hollywood's playbook and forgo two or three deputy positions in order to provide basic community services since there appears to be little objectively verifiable return on the LASD investment.

Moreover, LASD is in a downward spiral and appears unlikely to ever adequately serve the needs of the people of Compton. For the sake of Compton's public safety, the city must consider its options. For example, since there is no clear-cut organizational reporting relationship between city management and LASD, for accountability, LASD could report to the head of Code Enforcement as identified in the city charter as the Chief of Police. Code Enforcement could develop assessment tools and monitor and regularly report to residents on LASD service deliverables. Compton could require that all policing entities including school police join CALEA.

What's needed in Compton and probably for Los Angeles County is Bratton change-agent type leadership. Movies in the parks won't get there nor will Stetson hat-wearing cowboys. Compton4COPS & Teen Intervention Program

I was too disgusted to give public comment at the hearing today. That's the problem with white supremacy, those of us benefiting from it continue to prop it up.

When the Sheriff will raid a Supervisor & Civilian Oversight Committee members home in retaliation for calling for transparency in his department, when the Sheriff sends deputies to surveil and intimidate Sheriff Deputies who testify in front of the Oversight commission- what are doing to protect our community members who have been telling you this week after week? When will we protect our community members from the Sheriff and his deputies who harass and intimidate them when they speak out after their loved ones lives are stolen by LA Sheriff deputies; when they're followed, when they're harassed, when they're put in danger by the LASD?

The families shouldn't have to stand in front of you pleading for protection; the trauma of recounting their story each and every time.

Not only did I fall asleep during MacArthur's drawn out presentation, but we shouldn't exactly be taking

best practices from LAPD. How many people has LAPD killed this year? 27. Last weekend LAPD murdered a kid who called them for help. On Tuesday's Police Commission meeting Chief Moore acknowledged that LAPD has shot 27 so far this year, an increase from 25 last year, with a 4 year average just over 22. It's not a stretch to say that we shouldn't be looking to LAPD for tips when trying to address misconduct and reduce killings by LASD.

OIR Genako suggested that it would be unlikely to change the culture with seasoned deputies but that it would potentially be possible to change the culture with new deputies. How do you expect new deputies to change the culture of the old guard while working under them? Why do you think they are joining LASD, the current Sheriff advertises the dept as the old Wild West..

Tell the BoS to stop increasing LASD funding. In February the board approved \$1.3 million for an armored vehicle for LASD. They haven't done enough damage with the weapons they already have? LASD can't figure out how to stop killing our community members, what do they need a tank for? So that they can wage an all out war on our communities?! What are they going to do with a tank? Patrol East LA with it? Does a tank need to show up in front of the Vargas family home for you to do something to protect them? With a \$3.6 billion budget... surely they can find room in their current budget to fund such frivolities.

LA County lawyers just recommended an \$8 million settlement for the parents of 18 year old Andres Guardado, murdered by a sheriff's deputy prospective Executioner gang member in 2020. (A small piece of the \$86 million a year taxpayers spend in settlements for LASD misconduct.) When LASD has to finance their own misconduct, will they change? Tell the BoS to stop approving LASD budget increases & stop funding LASD misconduct; it's an insult to taxpayers. Why reward LASD for bad behavior? Textbook kindercare negative reinforcement. When is enough, enough?
