## A. <u>Authorization to Relocate and Lease New Office Space</u>

LACRIS is requesting approval to fund tenant improvements and pay for an eight (8) year lease agreement for new office space. The cost of the improvements and lease for the term of 8 years is approximately \$5,000,000.

On November 21, 2019, this RAN Board approved the LACRIS 10 year Strategic Plan which included the goal to expand LACRIS service capabilities by obtaining a larger office space to accommodate additional personnel and resources. The Sheriff's Department has also raised concerns regarding paying for LACRIS office space while other Cal-ID Programs, such as Riverside and Alameda, pay for their office space with Cal-ID funds.

The proposed office space will be able to staff our current personnel and is designed to accommodate our future growth. It will include two flexible training rooms that can be turned into one large conference room and can accommodate our Technical Subcommittee meetings. The training rooms and conference room are designed to operate seamlessly with the LACRIS training room at LAPD Piper Tech.

The office space will adopt the Strategic Plan goal of creating an Innovation Center in order for us to maintain our leadership role in biometric identification. The Innovation Center will continue a culture of supporting creative collaboration, project teams and new ideas. We will be able to work with our federal, state and biometric identification partners across time zones and the nation.

## B. <u>Authorization to Purchase New Nexus Core Switches</u>

LACRIS is requesting approval to fund the purchase of four (4) Cisco Nexus 9000 Core Switches, including all hardware, software, support and maintenance required for three (3) years (Solution). The solution will replace the existing switches at the two (2) Department of Justice (DOJ) connection points in the Sheriff's Data Network (SDN). The cost of the Solution is approximately \$982,317.10 for three (3) years. After the 3 year term the Sheriff's Department will take over the leasing, licenses and management of the switches.

The current Cisco Nexus 7000 switches do not have the bandwidth to handle the additional load LACRIS systems are putting on the SDN. The Sheriff's Body Worn Camera system tasks their network with a huge bandwidth requirement. With the addition of the LACRIS Mobile ID System's 2100 to 2500 devices utilizing the same SDN backbone, a network upgrade is required. LACRIS is seeking approval to fund the recommended replacement Solution. The Cisco Nexus switches are a vital infrastructure component to maintain network connectivity to the Los Angeles County Sheriff's Department, the Pac-50, and the Department of Justice. In addition, the Nexus 9000 will be able to support four times the bandwidth of the current switches and will allow us to migrate network traffic from one core switch to the other should a loss of function occur. This active/active failover protection is the first step in preventing unnecessary downtime should maintenance or unforeseen circumstances occur.

## C. <u>Authorization to Purchase Microsoft Active Directory and Exchange Server</u>

LACRIS is requesting approval to fund the purchase of Microsoft (MS) Active Directory and Exchange Server version 2019, including all hardware, software, support and maintenance required for five (5) years (Solution). The cost of the Active Directory and Exchange Server Solution is approximately \$118,272 for five years.

The current LACRIS 2012 AD and Exchange Servers will be reaching end of life, June 2022. Microsoft will be unable to respond to support and maintenance. In addition, security patches and updates from Microsoft will no longer be available to maintain hardware and OS compliance with the Los Angeles County Sheriff's Department's (LASD) Data Security Group. In order to maintain business continuity within LASD and outside agencies, LACRIS needs to upgrade the Active Directory and Exchange Servers to 2019. Failure to update the Solution will create a data security issue and LACRIS will no longer be able to guarantee the functionality of our systems that depend on the solution to operate.
