**a. Kenneth Kohr v. County of Los Angeles, et al.  
Los Angeles Superior Court Case No. PC 047 437**

This dangerous condition lawsuit arises from a slip and fall accident on a boat dock at Castaic Lake, which is maintained by the Department of Parks and Recreation.

**Action Taken:**

The Claims Board approved settlement of this matter in the amount of \$45,000.

b. **Basilia Vazquez v. County of Los Angeles**  
**Los Angeles Superior Court Case No. BC 467 564**

This medical negligence lawsuit arises from injuries sustained for care and treatment received by a patient while hospitalized at the LAC+USC Medical Center

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$235,000 plus waiver of the hospital bills in the estimated amount of \$20,307.

On September 17, 2012, the Claims Board authorized a statutory offer, and on October 2, 2012, the case was settled and approved by the court for \$85,000.
