ASBESTOS NOTIFICATION REQUIREMENTS

In 1993, the County of Los Angeles Board of Supervisors instructed the Chief Administrative Office (CAO) and the Internal Services Department (ISD) to immediately comply with California Health and Safety Code 25915 et. seq., which requires owners of buildings constructed prior to 1979 to notify building occupants within 15 days of becoming aware, and annually thereafter, that the building contains asbestos. Under this code, "building owner" means owner, lessee, sublessee, or agent of the owner of a building or part of a building, including, but not limited to, the state or another public entity.

County Code Section 2.81.035 vests primary authority and responsibility for the operation and maintenance of County of Los Angeles (County) facilities and grounds with department heads. The December 19, 1989, memorandum (reiterated in a September 24, 2001, memorandum) from the CAO to all department heads, which explained this decentralized authority and established the Building Proprietor Program, specifically stated:

"The [departmental building] proprietor is also fully responsible for... compliance with asbestos notification [emphasis added]..."

Consistent with this ongoing responsibility and because of the continued focus on asbestos notification, I request each department acting as a building proprietor to review current reports and/or records regarding asbestos conditions in your facility(ies) and take appropriate action consistent with asbestos notification requirements.

Section 25915 et. seq. of the California Health and Safety Code sets forth the following minimum notification requirements:

- Building owners must notify building occupants within 15 days after receiving information that the building contains asbestos;
- Building occupants should be annually notified of asbestos conditions; and
- New building occupants and new employees should be notified of asbestos conditions within 15 days after occupying the building.

Note: There are circumstances described in California Health and Safety Code 25915.2(f) and 25915.2(g) where asbestos containing materials (ACM) may exist in a building and notification requirements do not apply to all employees in the building. Refer to the California Code sections for details.

Attached is a sample asbestos notification letter. Notification must be in writing and directly provided to all employees in the building; posting such notification is not adequate. Notification requirements are triggered only upon receipt of information that a building contains asbestos; existing code does not require that an asbestos survey be conducted.

The Auditor-Controller includes asbestos notification reporting as one of the issues addressed in the biennial internal control certification program.

There are additional requirements relating to asbestos exposure included in California Code of Regulations, Title 8, Section 1529, regarding construction activities, including "routine facility maintenance." Refer to the California Code for details.

In Compliance with California Health and Safety Code 25915 et. seq., you are hereby notified that, based on the Asbestos Assessment Survey Report conducted by (Insert name of firm that conducted the survey), the (insert the name of the building/facility), contains asbestos containing material (ACM) in certain areas.

ACM poses no threat to your health unless asbestos fibers become airborne due to material aging, deterioration or damage. While extensive media attention has been given to asbestos, statistical data indicates that the annual incidence of asbestos related illness is relatively low. Given the widespread use of asbestos prior to 1979, the low incidence of asbestos related illness indicates that health risks are minimal.

SAMPLE NOTIFICATION LETTER (Cont.)

Employees should follow proper work procedures to minimize the release of and exposure to ACM. Do not damage, drill holes, or attach objects to walls, floor tiles, fire rated doors or ceilings which contain asbestos. Do not disturb ACM when replacing light bulbs. Only persons authorized and properly trained should perform any work which may disturb ACM. In the event you encounter material which you believe may contain asbestos, do not disturb it in any way; immediately report the situation to your supervisor.
