## COMMUNITY FORUMS - ROOSTER ORDINANCE (ONE MEETING DATE CHANGED)

LONG BEACH, Calif. – On Tuesday, December 19, 2017, a motion was introduced at the weekly Board of Supervisors meeting to limit the keeping of roosters in the unincorporated areas of Los Angeles County. The purpose of the motion is to improve quality of life for residents, reduce complaints of noise and odor, and reduce illegal cockfighting. This does not mean that laws have changed and there is no immediate impact to residents. Many cities in Los Angeles County already prohibit or limit the number of roosters allowed and several counties in California are enacting or have already enacted similar ordinances. As part of the review process, the Department of Animal Care and Control will host eight community forums open to the public. Department representatives will be available at each forum to meet with residents and hear comments, concerns and suggestions. We welcome public input to ensure the most effective and fair ordinance possible. We encourage community members to attend these forums and participate in the discussion of the keeping of roosters, or to send their suggestions in mail or e-mail.
