Dear Mr. Jones,

Please consider this package our formal request for review by the Design Control Board of the Los Angeles County Department of Beaches & Harbors. Enclosed is our proposed exterior signage plans for AMLI Marina Del Rey. As you know, we are currently underway with construction of an exciting new multi-family project on our leasehold, pursuant to plans previously approved by you, the Design Control Board (DCB) Feb. 19, 2016 and the Department of Regional Planning on June 17, 2014. This submittal focuses solely on the exterior signage program for the complex. We seek the DCB's approval of the enclosed signage package at its September 2016 meeting, and look forward to presenting these plans to the DCB and answering any questions the DCB members may have at the September DCB meeting.

Description of Exterior Signage Program:

The proposed signage program has been designed to meet the functional, aesthetic and marketing needs of the property. Our intent is to create graphic imagery that is an artistic extension of our new modern architecture buildings. The purpose of the exterior signage is to guide visitors and residents around the various outdoor features and marina promenade as well as to create a cohesive brand for the project and give the small retail businesses located within our property some exposure.

Upon approach to the site, visitors will observe our Main Logo Signage S1 and S2 (see enclosed sheets numbered 9-11 for detail.) With the Architectural Design and materials in mind, these signs clearly identify the site and sets the tone for this unique eye-catching environment. The S1 Wall Sign is on the main building in this six building property and is used to link together this property as one community. As this is the entrance to the welcome center and a pathway to the promenade for visitors and residents it is high up on the wall of the building to give the impression of a main entrance. The sign is constructed of the same all weather wood material as the building. A slight contrast is achieved with the wood of the

sign at a perpendicular pattern to the building's wood pattern. The logo and project identity are pin mounted to the wood surface and are fabricated out of hollow stainless steel 3D letterforms. These letterforms are illuminated from 6pm to 6am daily by a white LED light from within the letterform. The illumination will not be directly visible to the eye on the street or from within the building — but creates a soft glow around the identity at night. The sign hugs the corner of the building and wraps the corner slightly — a motif found throughout the projects signs.

The S2 Freestanding Sign is a low ground and pedestrian level sign constructed of the same all weather wood material and stone base — the same materials as the architectural design. The identity is illuminated halo lit Letterforms similar to the wall sign, which will have a soft glow around the letterforms at night. The retail tenants within the property will have a small un-illuminated stainless steel letterform that is pin-mounted to the wood surface for identity purposes. The stone base has a recessed LED strip light that is mounted down within the structure and angled at 45 degrees to softly wash light over the sign at night. While proposed colors and material types for the signs are indicated on the enclosed plans, we will bring representative color chips to the September 2016 DCB meeting. The other building will not have identity signs as we wish to be very quiet with our signage and feel the two main signs and the architecture will link the buildings together as a community.

Signs S3 and S4 are the amenities and retail, for example Leasing, SiP CoffeeBar, The Den, Dog Spa, etc are very simple 12" high, 3D Stainless Steel letterforms attached to the awning and washed with a 45 degree angled LED light that washes the letterforms at night. See enclosed sheet number 16, 17 for details and renderings)

Our Retail Signs with 8,001 SQ FT of retail space available. We want our tenants to have the opportunity to call attention to themselves and their business, but also to follow guidelines of



the architectural design intent. Each tenant space has the ability to have an awing sign that is 12" high letterform and identity icon similar to S3 signs, but allows for some creativity.

Signs S5 – S11 reflect our parking and access information. We have designed a color into the signage and wayfinding to help guests and shoppers find parking, retail offerings, and how to access the public gardens, vistas and marina promenade. You will notice that the public parking, wayfinding / coastal access signs and marina signage are a bright pop of color — guests and visitors can use the color cues to enhance everything AMLI Marina Del Rey has to offer. See enclosed details and renderings on pages 28 and 41.

Our Wayfinding / Directory Signs S14 throughout the property are small directory maps that are placed at the entrances off the street and promenade. They are located within the landscape and do not obstruct views or exiting, very similar to an information sign in a park or public trail. — where the public can access the gardens, marina promenade and vistas throughout the property. The wayfinding map serves several functions: emergency exiting, location of promenade, public vistas, amenities within the property, and identity.

The address number signs S15 and S16 are also 3D stainless steel fabricated numbers that are on the lobby awning on the Marina side and on the wall of each building on the street side. Enabling easy access for fire and visitors. See enclosed details and renderings on page 43-49.

Signs S17 - S19 are the Marina and Dock Signs. The identity of the Boathouse is similar to the rest of the signage for the whole property with a simple halo illuminated 3D stainless steel letterform facing the promenade, marina and boat docks. The wayfinding for AMLI's Boathouse Marina uses color and shell names to give a unique and branded identity to the property's marina. Each dock finger is named after a shell, listed in alphabetical order, and has a custom illustration that is simple to remember and separates this marina from others. The signs use the same wayfinding color as the rest of the property to create a cohesive, beautiful environment for visitors and residents.

It is our hope that the DCB will consider this Request at their September 2016 Meeting. On behalf of the AMLI MDR team, we thank you and the staff at the Department of Beaches &



VICINITY MAP Marina del Rey

Many consider Marina Del Rey as the jewel of Los Angeles County, home to the largest man-made pleasure boat harbor in the world and a recreational site for county residents. Visitors are attracted with lively shops and restaurants, allowing them to stroll on the promenade. Residents enjoy an exceptional view of the bay and the marina in the background. However, the view is not the only characteristic of this location, as luxury apartments represent a dominant feature of the coastline. Thus the architectural task at hand brings at least two important challenges. First, it is necessary to design and create a quality living environment for the future residents, and second, the project provides an opportunity to redefine the look of the marina and through architecture enhance the surrounding context.

ARCHITECTURE DESIGN NARRATIVE

Responding to site context plays an important role in determining the architecture of the buildings. This creates a strong link between the buildings and the community.

The updated Architectural character of the project is based on a maritime theme, influenced by waterfront 'boathouse' structures. The rustic nature of the boathouse has been re-interpreted in a sophisticated application utilizing the warmth of wood siding with the permanence of a stone base, gently sloping roof forms and glass invoke a place-making aesthetic that feels very much a part of the marina Ultimately the design is about living close to the water where people experience their surroundings - the sound of the water, the breeze of the sea, even the salty taste in the air - as if they were on a Boathouse.





SIGNAGE + WAYFINDING CONCEPT

Signage and wayfinding for this upscale ocean side community is a natural extension of the architectural vision. Working closely with the owner, architect, landscape designer and interior design firm allowed signage and property to pair well.

Building on the boathouse theme, textures are reminiscent of nautical materials. Wood planks of the boathouse boardwalk, smooth surface of a boat, and bright playful pops of color from sailing flags become rich wood brushed aluminum and polished pops of color in this large scale signage and wayfinding project.

Custom typography further supports the theme referencing sailing rigs in a sophisticated unexpected manner. The end result is signage system—including marketing and code signage—that complements the property motifs without overwhelming the architectural design.



- 2. Marina del Rey is a NO DISCHARGE HARBOR! All marine and port-a-potty waste must be retained on board for disposal at a designated pump out station or mobile pump out service.
- 3. Contaminated bilge water, fuel, oil, solvents, etc. are not to be discharged into harbor waters.
- 4. Anchoring is not permitted.
- 5. Mooring buoys are not available.
- 6. Motorcycle riding, bicycle riding, roller blading and skateboarding are prohibited on all docks and gangways.
- 7. Yacht/dock repair technicians must register with the Harbor Master to receive a commercial service identification card.
- 8. Fishing is not permitted on the docks. Fishing is allowed on berthed vessels and at designated fishing piers.
- 9. No items are to be left or stored on the docks at any time.
- 10. Vessels shall not extend over 3 feet from the vessel's dock slip.
- 11. Only minor emergency repairs and normal wash-downs are allowed on vessels in slips.
- 12. Pets must be on a leash at all times when on the docks.
- 13. Noise must be kept to a minimum between 10 p.m. and 7 a.m. daily.


