# 1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Beach Commission Minutes Meeting of October 25, 2017 Page 2 of 6

Chair Margaret Levy called the meeting to order at 9:39 a.m. Chair Levy asked Commissioner Leslie Cortez to lead everyone in the Pledge of Allegiance.

# 2. APPROVAL OF MINUTES

Chair Levy asked for approval of the June 28 and July 26, 2017, minutes. Commissioner Francine Oschin motioned for approval. The motion was seconded by Commissioner Al Lav.

The minutes were unanimously approved.

### 3. OLD BUSINESS

# A. VENICE LIFEGUARD HEADQUARTERS STATUS

Mr. John Kelly stated that the Department of Beaches and Harbors (DBH) has begun a feasibility analysis of different plans for the Venice Lifeguard Headquarters building and would provide details during Item 3B – Measure A's Rollout & DBH's Priorities for the Funding presentation.

### B. MEASURE A'S ROLLOUTS & DBH'S PRIORITIES FOR THE FUNDING

Mr. Stefan Popescu provided a PowerPoint presentation about Measure A, which was approved in November 2016 to provide funding for County parks. Of the \$93 million funds that Measure A will provide annually, DBH will receive about \$4.5 million each year for beach projects. Prior to Measure A's passage, DBH completed a beach needs analysis and submitted \$428 million worth of projects for approval.

Commissioner Campbell asked for clarification on DBH's expenditures of approximately \$4.5 million annually versus the \$428 million in needs. Mr. Popescu responded that the \$4.5 million is an allocation, and that the Department can apply for competitive grants. Nevertheless, high-need areas have priority for competitive grants, and none of the Department's projects have been designated as high-need. Mr. Kelly clarified that the \$428 million cost identified in the needs assessment was spread out over Measure A's 35-year lifetime.

Commissioner Goldberg asked why the categories were so broad and requested details for specific categories. She also inquired about the grant process. Mr. Popescu responded that the Implementation Steering Committee will be working on the details. Commissioners

Goldberg and Campbell requested Implementation Steering Committee members' information and the committee's meeting schedule. Mr. Popescu said he would provide the Commission with the Measure A Implementation Steering Committee roster and schedule.

Mr. Kelly presented a PowerPoint about the Department's Measure A Priority Projects. At this time, projects are planned for Nicholas Canyon Beach, the Venice Maintenance Yard and Lifeguard Headquarters building, the Rosecrans Maintenance Yard and Lifeguard Building/Public Restrooms, and White Point Park and Royal Palms Beach.

Commissioner Goldberg asked if the cost of the Nicholas Canyon Beach project matches the service the beach provides to visitors. Mr. Kelly responded that Nicholas Canyon is a very popular beach for kite surfing and educational events.

Chair Levy asked if the City of Los Angeles would be contributing to the Lifeguard Headquarters project, since the building is owned by the city. According to Mr. Kelly, the County leases the Lifeguard Headquarters building for \$1. As part of the lease, the County is responsible for maintenance operations for the life of the building, but not necessarily for replacing the building. The preferred alternative in terms of feasibility would be to replace the building; however, the Department would need to negotiate with the City regarding the cost. Chair Levy asked if the City and County would consider a joint grant proposal for funds to replace the building. Ms. Christina Angeles from County Counsel indicated that this would probably not be considered because the County would prefer to keep its allocations separate from the City.

Commissioner Goldberg asked about ongoing issues with adding and refurbishing restrooms across all County beaches. Mr. Kelly responded that the Department has a list of about 20 capital projects planned for the 2017-18 fiscal year. Several of these capital projects are restroom refurbishments. Most recently, the Department completed three major restroom refurbishment projects at Zuma Beach, and three more are planned. Mr. Kelly added that the Department is constantly refurbishing and upgrading beach restrooms, which are a standard part of the DBH's budget.

# 4. NEW BUSINESS

### A. MARINA BEACH REDEVELOPMENT

Ms. Mie Joness gave a PowerPoint presentation about the Marina Beach Improvement Project.

Commissioner Dagit asked if there were plans to recycle the current picnic tables. Mr. Kelly said that the old picnic tables have been placed on a Mobi-Mat along the beach for the duration of construction. This configuration may become permanent.

Chair Levy asked about the funding source for this specific project. Mr. Kelly said the funding comes from the Accumulative Capital Outlay (ACO) Fund. Money in this fund can only be used for projects within the Marina that add to public access and infrastructure.

Commissioner Campbell expressed concern that having additional picnic tables would bring more trash, exacerbating issues with the birds at Marina Beach. Mr. Kelly said the Department is doing everything possible to control the bird issue and address trash concerns through multiple methods, including cleaning the beach twice per day and positioning trash cans with bird-proof lids all over the beach.

# 5. STAFF REPORTS

### A. ONGOING ACTIVITIES REPORT

Ms. Baker submitted the written report.

Chair Levy expressed concern about the waiver of \$100,015 in gross receipts for the Malibu Triathlon at Zuma Beach. She said the Triathlon is a for-profit operation and that the amount of money going to charity is minimal compared to the promoter's profits. Ms. Baker clarified that the Department does not propose fee waivers—they are requests made directly by event organizers to the Board of Supervisors. Chair Levy suggested that the Department relay her concerns to the Board of Supervisors. Ms. Baker said the Department can notify the Board of Chair Levy's concerns. Mr. Jones said the fee waivers are public record and that he would pass on Chair Levy's concern. Commissioner Campbell said she seconded Chair Levy's concern about waiving large amounts of gross receipts, particularly for forprofit ventures.

### B. BEACH AND MARINA DEL REY SPECIAL EVENTS

Ms. Baker presented the written report, which highlighted a very successful summer.

### C. OPERATIONAL SERVICES DIVISION REPORT

Mr. Foreman submitted the written report.

Commissioner Cortez expressed concern regarding the restroom project at Torrance Beach near Miramar Park. She said that during a recent beach cleanup with 450 volunteers, the restroom was out of service. Mr. Foreman responded that this restroom is one of the renovation project that is in progress and it should be completed by the end of the year.

Mr. Foreman informed the Commission that the Department, through Supervisor Janice Hahn's office, partnered with Los Angeles City Councilman Mike Bonin's office to help

address the traffic issue on Vista del Mar by absorbing street parking spaces into the County's existing parking lots. As part of the plan, the first 300 vehicles to enter the Dockweiler State Beach parking lots at Imperial Highway will pay a reduced parking rate.

Commissioner Campbell asked whether the reduced price parking at Dockweiler State Beach due to the Vista del Mar reconfiguration would affect revenue projections for parking. Mr. Jones said the impact on revenue is not currently known; however, the Department is monitoring the number of users and revenue generated. The Department will continue to report to the Commission on the status of this arrangement, which will continue as the Los Angeles Department of Transportation (LADOT) pursues a long-term solution.

Mr. Jones informed the Commission of the progress on the Request for Proposals process for the Gladstones site. Proposals were due September 28, 2017.

Mr. Kelly informed the Commission that the Department received a letter from Broad Beach Geological Hazard Abatement District announcing that it does not intend to proceed with the beach replenishment project this year.

Chair Levy asked about the construction signs and narrowed roadway on Via Marina and its effects on the Independence Day celebration. Mr. Kelly responded that the signs and closures are part of the City of Los Angeles' Venice Dual Force Main Project. The project will affect Via Marina for the next year and a half. Ms. Baker said the Department works with LADOT and other agencies on traffic control throughout the year and will discuss mitigation efforts before the celebration.

### D. LIFEGUARD REPORT

Assistant Chief Fernando Boiteux submitted the Los Angeles County Fire Department Lifeguard Division Statistics for the months of July and August. He also spoke about an injured lifeguard and the Lifeguard Division's Diversity Force Report for the Board of Supervisors. He said that the report will be issued to the Board before it is presented to the Beach Commission.

Chair Levy asked for clarification on the statistics report. Mr. Boiteux said that the report shows statistics for July and August for this year as compared to last year. He also stated that estimated beach attendance has increased by 1 million visitors since last year.

Vice Chair Jeff Duclos asked about the International Surf Festival. Chief Boiteux responded that the event was a success.

### 6. COMMISSIONER COMMENTS

Commissioner Lay asked about the possibility of restoring or clearing out a staircase near the parking lot by Veterans Park in Redondo Beach. Mr. Kelly responded that the staircase

is one of the structures that was considered on the needs assessment and it is one of several ramps, stairways, and access ways that are old and in need of either repair or replacement.

# 7. COMMUNICATION FROM THE PUBLIC

Ricky Horwitz shared that he is starting a beach website called SANDEE, which includes a database of information on beaches in every country in the world so visitors can choose the beach that's right for them. He said one of his goals is to drive traffic to Los Angeles area beaches.

The next Beach Commission Meeting is scheduled for October 25, 2017, at BURTON CHACE PARK COMMUNITY ROOM located at 13650 Mindanao Way, Marina del Rey, California 90292.

Jon Christensen is an adjunct assistant professor in the Institute of the Environment and Sustainability (IoES), the Department of History, and the Center for Digital Humanities at the University of California, Los Angeles. He is a journalist-in-residence at the Institute of the Environment and Sustainability, a founder of the Laboratory for Environmental Narrative Strategies in the IoES, and a senior fellow in UCLA's cityLAB. He is a regular columnist at LA Observed and editor of Boom: A Journal of California, a quarterly magazine published by the University of California Press, from 2013 to 2016. He is also a partner and strategic adviser at Stamen Design, an interactive design studio specializing in mapping, data visualization, and strategic communications.

SUBJECT: ITEM 5A - ONGOING ACTIVITIES REPORT

### **BOARD ACTIONS ON ITEMS RELATING TO BEACHES**

On September 12, 2017, the Board waived the parking fees for 40 vehicles in a total amount not to exceed \$11,600 at Torrance Beach, excluding the cost of liability insurance, for students and teachers attending surf classes sponsored by Torrance High School, held September 5, 2017, through March 30, 2018, from 6:30 a.m. to 8:30 a.m.

Also on September 12, 2017, the Board adopted a resolution as submitted by Supervisor Sheila Kuehl proclaiming an emergency at Nicholas Canyon Beach; found, based on substantial evidence, that the danger to life and health posed by the risk of imminent collapse of the deteriorated elevated concrete access ramp at Nicholas Canyon Beach constitutes an emergency pursuant to California Public Contract Code Sections 20134 and 22050, which requires the County to procure demolition services without giving notice for bids to respond to the emergency, and that this emergency will not permit the delay resulting from a competitive solicitation of bids; found that the contracting for this demolition and the demolition of the deteriorated elevated concrete access ramp at Nicholas Canyon Beach are exempt from the California Environmental Quality Act; and took the following actions:

Authorized the Director of Beaches and Harbors, in consultation with the Director of Public Works, to select one or more specialty demolition contractors to perform the work of demolishing the deteriorated elevated concrete access ramp at Nicholas Canyon Beach, negotiate and enter into a contract with such contractors without the necessity of competitive solicitation of bids and without the need for adoption of plans and specifications, and deliver the demolition of the deteriorated elevated

concrete access ramp at Nicholas Canyon Beach for an amount not to exceed \$500,000; allocated funding to perform the necessary demolition work in an amount not to exceed \$500,000, which is currently available through one-time Net County Cost Department savings available in the Fiscal Year 2017-18 Extraordinary Maintenance Budget; and pursuant to Public Contract Code Section 22050, instructed the Director of Beaches and Harbors to report back to the Board for its review at its next regularly scheduled Board meeting, and at every subsequent Board meeting thereafter, until the work is completed or the emergency ceases, regarding the status of the situation and the work to enable the Board to determine that there is a need for this action to continue.

On September 19, 2017 the Board approved the findings that the armed security guard services can be performed more economically by an independent contractor; approved and instructed the Chairman to sign a contract with Hamilton Private Security for armed security guard services at Isidore B. Dockweiler Recreational Vehicle Park, Burton W. Chace Park, Dockweiler Youth Center and White Point/Royal Palms Beach (3 and 4), at an annual contract amount of \$511,227 for a three-year term with two one-year and twelve month-to-month extension options, for a potential aggregate amount of \$3,067,362 for the six years, to commence October 1, 2017; authorized the Director of Beaches and Harbors to exercise the two one-year renewal options and, if needed, the additional twelve month-to-month extensions if, in the opinion of the Director, Hamilton Private Security has effectively performed the services during the previous contract period and the services are still required; and authorized the Director to take the following related actions:

Approve and execute change orders and amendments to incorporate necessary changes within the Scope of Work and assign rights or delegation of duties should the contracting entity merge, be acquired or otherwise change entities; suspend or terminate the contract if, in the opinion of the Director, it is in the best interest of the County and, in the event the contractor resigns or is terminated for any reason, award service to the next highest-ranking proposer, provided that any reassignment does not exceed available funding; and increase the annual contract amount by up to 10% in any year, including any renewal option period, for any additional or unforeseen services within the scope of the contract.

Also on September 19, 2017, the Board authorized the Team Against Drugs to use Dockweiler State Beach to host the Annual Special 5K for Students Run LA; and reduced the permit fee to \$125 and the parking fee to \$5 per vehicle, and waived gross receipts in the amount of \$2,362.50 at Dockweiler State Beach, excluding the cost of liability insurance, for the event held September 24, 2017.

On October 3, 2017, the Board waived up to \$5,300 in parking fees for 650 vehicles at Dockweiler State Beach, excluding the cost of liability insurance, for participants taking the

Item 5C on your agenda provides the Commission with a listing of the Department's projects that are either planned or in progress. There were 51 service requests placed with the County's Internal Services Department to perform work that was either too large for our internal staff to handle or beyond our expertise. Listed below are the projects that exceeded \$50,000:

- Royal Palms Cliff Repair Design Royal Palms Beach estimated cost \$125,000
- Renovate restroom Torrance Beach (Burnout) estimated cost \$250,000

### Establish new sewer connection at White Point - \$820,000

This project will connect the public restroom at White Point via 500 lineal feet of the force main to a nearby trunk sewer. The former sewer line was disconnected due to a landslide that occurred in November 2011.

Status: The scope and conceptual drawings are developed and are being reviewed for CEO funding. Project will be ready to begin September 2018.

### Royal Palms Cliff Repair Design at Royal Palms Beach - \$125,000

This project will include a design to repair damage to a cliff caused by a water line break.

Status: Staff is working with LA City Building and Safety on a suitable repair.

# Renovate restroom at Torrance Beach (Burnout) - \$250,000

The scope of work includes removing and installing a new tile roof; replacing vent grid; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

### Renovate restroom at Torrance Beach Lifeguard Station – \$300,000

The scope of work includes repairing the damaged block; removing and installing a new tile roof; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

# Renovate restroom at Redondo Beach (Topaz) - \$275,000

The scope of work includes repairing the block; removing and installing a new tile roof; replacing damaged fascia; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

# Replace water line at Dockweiler Beach - \$645,000

The scope of work includes abandoning the existing water line and adding a new line, a new water main, and a second meter for the RV Park. The new water main will serve the Lifeguard station, the entrance kiosk, and the irrigation system from the existing meter to the facilities.

Status: The project is being awarded to a contractor and construction will be scheduled to begin during the annual RV renovation in January 2018.

# Annual RV Renovation at Dockweiler – \$250,000

The annual renovation will include checking and repairing the electrical service of all the pedestals; check and repair the showers and restroom fixtures; painting all three restrooms and office area; repairing damaged landscaping; slurry seal and restripe the entire lot; and general cleanup of the entire facility.

Status: Project is currently being quoted and will be completed in January 2018.

# Renovate restroom at Topanga Beach – \$150,000

The scope includes replacing old plumbing fixtures with more efficient fixtures; replacing the partitions; adding hand dryers; replacing tile; and painting the interior and exterior of the building.

Status: Project has started with the exterior of the building. The renovations are scheduled to restart late October 2017.

# Replace view pier stairs at Topanga Beach Stairs - \$125,000

The scope of work includes developing a set of plans; removing the existing stair structure; and installing a new one.

Status: Project is scheduled to begin Winter 2017/18.

# Replace fence at Dan Blocker - \$80,000

The scope of work includes removing existing fence fabric; replacing damaged posts; placing poly-coated sleeves over all the posts to protect them; and installing new poly-coated fence fabric to help protect beach patrons from entering the parking lot from steep terrain.

Status: Project is scheduled to be completed Winter 2017/18.

# Renovate restroom at Malibu Surfrider - \$179,000

The scope includes replacing old plumbing fixtures with more efficient fixtures; replacing the partitions and benches; adding hand dryers; replacing the doors and tile; repairing the damaged sewer laterals; refinishing the floors; and painting the interior and exterior of the building. ADA will be addressed during the construction.

Status: Project is scheduled to begin Winter 2017/18.

# Replace fence at Malibu Surfrider - \$88,000

The scope of work includes removing existing fence fabric; replacing damaged posts; placing poly-coated sleeve over all the posts to protect them; and installing new poly-coated fence fabric to help protect beach patrons from entering the parking lot from steep terrain.

Status: Project is scheduled to begin Winter 2017/18.

# Replace water line at Zuma Beach - \$1,500,000

The scope of work includes abandoning the existing water line; adding a new line for the nine restrooms; and installing a new backflow device.

Status: Project is scheduled to be completed December 2017.

# Replace showers at Zuma Beach - \$475,000

The scope of work includes replacing the existing floor and wall tiles; installing new shower fixtures; and new ADA benches and grab bars for the showers located at the nine restrooms.

Status: Project is completed.

### Renovate restrooms (#6 and #8) at Zuma Beach - \$1,000,000

The scope of work includes repairing the damaged block; removing and installing a new tile roof; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

# Zuma Beach Sewer Liners at Zuma Beach - \$82,000

The scope includes installing liners in the sewage lines from restrooms #1 - #9 to the septic system.

Status: Project is scheduled to begin Winter 2017/18.

# Replace stairs at Nicholas Canyon - \$200,000

The scope of work includes developing a set of plans; removing the existing stair structure; and installing new stair structure.

Status: Project has started and is due to be completed by November 2017.

# Zuma 1 & 2 Concession Stands Roll-Up Window/Doors - Zuma Beach - \$200,000

This project is to replace three metal roll-up window covers for the two food concession buildings.

Status: Project is being assigned to a craftsperson to order parts and schedule installation. Project should be completed by late winter 2017.
