1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Chair Margaret Levy called the meeting to order at 9:43 a.m. Chair Levy asked Commissioner Peter Olpe to lead everyone in the Pledge of Allegiance.

2. <u>APPROVAL OF MINUTES</u>

Chair Levy asked for approval of the September 27, 2017, minutes. Commissioner Kathryn Campbell motioned for approval. The motion was seconded.

The minutes were unanimously approved.

3. OLD BUSINESS

A. VENICE LIFEGUARD HEADQUARTERS STATUS

Mr. Kelly indicated that there were no updates to report.

4. <u>NEW BUSINESS</u>

A. UCLA REPORT ON ACCESS TO THE CALIFORNIA COAST

Mr. Jon Christensen gave a PowerPoint presentation on a new research and a policy report from the UCLA, "Access for ALL: A new Generation's Challenges on the California Coast." The report includes results from a statewide voter poll and a series of Southern California beach surveys, as well as an analysis of economic barriers to accessing the coast.

Commissioner Rosi Dagit asked if the study's authors looked at barriers to actually getting onto the beach. Mr. Christensen said that the interactive online report at https://www.ioes.ucla.edu/coastal-access includes a map showing all the public access points on the coast.

Commissioner Keren Goldberg expressed concern about beach access for elderly patrons and asked if there had ever been any surveys done regarding their needs. Mr. Christensen said that researchers have conducted surveys that included questions regarding obstacles and concerns for many different market segments.

Commissioner Anthea Raymond asked if there was anything that the Beach Commission, as a public agency, could do to support broader public access. Mr. Christensen said that the

recommendations and challenges are complex and cannot be addressed or solved by the Coastal Commission or the Coastal Conservancy alone.

Commissioner Scott Sachs asked if there was a resource that tracks residents who prevent the public from accessing the beach. Mr. Christensen said that the Coastal Commission has a couple of reports that are informative about these cases, some of which have been resolved despite a significant backlog.

Commissioner Campbell asked about public transportation access to the beaches and if the Commission has ever looked into available public transportation. Commissioner Dagit said that there has been an increase in accessibility with the Metro lines. Ms. Baker said that the Department has partnered with the Marina del Rey Convention and Visitors Bureau for the Free Ride, which provides service in Marina del Rey, Santa Monica and Venice. The free Beach Shuttle also operates in Marina del Rey, Venice and Playa Vista on weekends throughout the year, and the Department is currently working with Metro to bring the Metro Bike Share program to Marina del Rey.

Commissioner Dagit expressed the importance of informing the public of the transportation that is available to them to access the beach. She also said the Third District has been funding a free beach bus from Woodland Hills to Topanga Beach for years.

Chair Levy asked about the study's recommendation to increase the supply of low-cost overnight accommodations, especially in light of high property values along the coast. Mr. Christensen said the recommendation is complicated. State Assemblywoman Lorena Gonzalez Fletcher introduced Assembly Bill 250 earlier this year. The bill, which has since passed, calls for the Coastal Conservancy to create a Low Cost Accommodations Program. Funding to create the accommodations would come from a bond that will be on the ballot in June 2018. Other funding sources could include nonprofits, philanthropies and private individuals.

B. LA CITY BEACHES CURFEW

Mr. Michael Tripp talked about the City of Los Angeles' efforts to obtain a Coastal Development Permit that will allow the City to continue to implement City of Los Angeles Municipal Code Section 63.44.B.4. (b), which restricts access between the hours of midnight and 5 a.m. to beaches owned or controlled by the City of Los Angeles.

Chair Levy asked if it would be helpful to send a letter in support of the curfew to the City. Mr. Tripp said that if and when the city applies for coastal development permit, the Commission can submit a letter with its input.

Commissioner Dagit asked who enforces the curfew. Mr. Tripp said that it's the responsibility of the Los Angeles Police Department. Commissioner Dagit asked if the

curfew helps out with the encampment issues. Mr. Foreman said that a heavy presence of the LAPD helps at Will Rogers State Beach.

Commissioner Goldberg asked if a report on the curfew's efficacy was available. Mr. Tripp responded that he does not have such a report; however, he can request this information from the city.

Chair Levy suggested that if the Commission agrees, when the time comes, the Commission should weigh in on their stand in regard to the curfew.

No action was taken.

5. <u>STAFF REPORTS</u>

A. ONGOING ACTIVITIES REPORT

Ms. Baker submitted the written report.

Ms. Baker noted the Board's approval of the report on the Nicholas Canyon project and informed the Commission that the project was completed.

C. OPERATIONAL SERVICES DIVISION REPORT

Mr. Foreman submitted the written report.

D. LIFEGUARD REPORT

Assistant Chief Boiteux delivered his verbal report and provided the Lifeguard Division September 2017 Statistics Report.

Commissioner Saito asked if there was a demographics report. Assistant Chief Boiteux said the Division is working on a report for the Board of Supervisors. As soon as the report is public, it will be shared with the Commission.

6. <u>COMMISSIONER COMMENTS</u>

Commissioner Campbell asked if the Department would explore whether the Beach Shuttle could stop at Loyola Marymount University. She also said that constituents had concerns regarding the environmental effects of the noise created by the Fourth of July and New Year's Eve fireworks in Marina del Rey. She asked if the Department could look into using silent fireworks.

Commissioner Raymond seconded Commissioner Campbell's comment regarding fireworks and the stress on animals. She also expressed concerns regarding the impact of private fireworks.

Commissioner Dagit clarified that the Coastal Commission's Explore the Coast app is not currently available. She said she would inform the Commission when the app is available in 2018.

7. <u>COMMUNICATION FROM THE PUBLIC</u>

Ms. Noel Johnston asked about the status of the Venice Lifeguard Headquarters. Mr. Kelly said that there has not been significant progress, but it is a high priority project on the Department's list of unfunded beach needs. Funds from Measure A will help the Department address high priority needs from the assessment beginning in Fiscal Year 2018-2019. The Department has formed a design team to develop a conceptual scope of repairs necessary for the building. Once the conceptual scope of repairs is finished, the Department will present it to the Commission with the Department's recommendation.

Mr. Peter John Ruiz spoke about homeless issues at Venice Beach. He asked if the Commission would write a letter to the City of Los Angeles in support of keeping some restrooms open throughout the night. Mr. Kelly said that the Department is working with Los Angeles City Councilman Mike Bonin's office to keep people away from dangerous areas at Venice Beach. Also, Mr. Kelly said that Councilman Bonin is interested in identifying a restroom at the beach that could stay open overnight. All Venice Beach restrooms are maintained by the city.

About the Beach Commission

The Los Angeles County Beach Commission (Commission) is an advisory commission for the Director of the Los Angeles County Department of Beaches and Harbors (Department) and the Los Angeles County Board of Supervisors (Board). During their monthly meetings, Commissioners hear presentations on various issues that may affect Los Angeles County's iconic beaches. The Commission will also occasionally approve items pertaining to beaches owned, managed and/or maintained by the Department before the items are submitted to the Board.

Initially formed by Board Order No. 184 on May 25, 1971, the Commission consists of 20 members who serve at the pleasure of the Board. The majority of the Commissioners are appointed by the coastal supervisorial districts; of those, 10 Commissioners represent the Fourth District, while seven Commissioners are from the Third District. The First, Second and Fifth Districts each appoint one representative. Members include experts, laypersons and representatives for groups and individuals who are interested in beach-related issues.

The Commission generally meets at 9:30 a.m. on the fourth Wednesday of each month at the Burton W. Chace Park Community Building in Marina del Rey. Per its charter, the Commission does not have meetings in August and December.

At each meeting, Commissioners hear one or more presentations about issues affecting local beaches in addition to staff reports from the Department's Operational Services Division and the Los Angeles County Fire Department Lifeguard Division. Past presentations have examined beach access for underserved populations, water quality sampling, local wildlife habitat restoration, sea level rise, marine mammal rescue, and earthquake and tsunami preparedness.

In past years, the Commission has been briefed on and discussed the Request for Proposals (RFP) process for the Gladstones restaurant site at Will Rogers State Beach, establishment of a dog beach in Los Angeles County, and Measure A - the "Los Angeles County Safe, Clean Neighborhood Parks and Beaches Protection Measure of 2016." The successful ballot measure called for a property tax assessment that would

generate \$94 million per year for local parks and open space areas, including \$7 million set aside annually for improvement projects and deferred maintenance at local beaches from San Pedro to Malibu. The Commission successfully advocated to include capital projects at the beaches as part of Measure A, and subsequently acted by unanimous vote to support the measure's passage.

The Commission's support for Measure A is an example of how it helps the County support Strategic Plan Goal II under Strategy II.2: Support the Wellness of Our Communities. Part of this strategy calls for increasing access to recreational opportunities, including beaches. The capital projects planned for Measure A funding will improve beach facilities to make them more accessible to all residents of Los Angeles County.

Annual Work Plan

The Commission generally determines topics for each meeting's presentation at the first meeting of the year and votes on "action items" prior to the Department bringing them to Board of Supervisors.

Prior Year Accomplishments

During the 2017 calendar year, the Commission made recommendations to the Director on two items—the Adopt A Highway Beach Trash Barrel Sponsorship Program and a new Parking Management Services Contract. The Commission agreed with the staff recommendation and approved both items, which were subsequently presented to the Board of Supervisors.

In addition to hearing standing staff reports focused on operations, capital projects and other ongoing issues on County beaches, Commissioners learned about Heal The Bay's water quality testing programs; The Bay Foundation's restoration projects at Malibu Lagoon, Ballona Wetlands and Santa Monica Beach; the planned expansion of the Dockweiler State Beach RV Park; the proposed removal of the Malibu Rindge Dam; the renovation of Marina Beach facilities in Marina del Rey; the Gladstones RFP process; and a UCLA report on public access to the California coast for underserved communities. The Commission also toured the Dockweiler Youth Center and Dockweiler State Beach RV Park following its July meeting.

Finally, 10 new Commissioners from the Fourth District were appointed in 2017. As part of the onboarding process, each Commissioner attended one of several detailed briefings held by the Department on current issues pertaining to beaches owned, managed and/or maintained by the County.

Ongoing Long-Term Projects

The Department anticipates receiving significant funding from Measure A for capital projects on the County's beaches. The Commission will have the opportunity to review and approve a number of these projects once they are developed.

Additionally, the Gladstones RFP process is ongoing. Once the Department recommends a concessionaire, the Commission will review the recommendation before it is presented to the Board.

BOARD ACTIONS ON ITEMS RELATING TO BEACHES

On October 24, 2017, the Board waived gross receipts in the amount of \$17,850, reduce the permit fee to \$125 and the parking fee to \$5 per vehicle for approximately 2,500 vehicles at Zuma Beach, excluding the cost of liability insurance, for the Malibu Race Series Association's Half Marathon and 5K event, to be held November 4 and 5, 2017.

On October 31, 2017, the Board waived up to \$2,500 in parking fees for 20 vehicles at Torrance Beach, excluding the cost of liability insurance, for students and teachers participating in surf classes sponsored by San Pedro High School, to be held November 1, 2017 through December 18, 2017 from 6:00 a.m. to 9:00 a.m.

SUBJECT: ITEM 5C - OPERATIONAL SERVICES DIVISION PROJECTS REPORT

Item 5C on your agenda provides the Commission with a listing of the Department's projects that are either planned or in progress. There were 60 service requests placed with the County's Internal Services Department to perform work that was either too large for our internal staff to handle or beyond our expertise. Listed below are the projects that exceeded \$50,000:

- Establish new sewer connection White Point estimated cost \$820,000
- Renovate restroom Torrance Beach (Burnout) estimated cost \$250,000
- Renovate restroom Torrance Lifeguard Station estimated cost \$300,000
- Renovate restroom Redondo Beach (Topaz) estimated cost \$275,000
- Replace water line Dockweiler Beach estimated cost \$645,000
- Annual RV renovation Dockweiler Beach estimated cost \$250,000
- Renovate restroom Topanga Beach estimated cost \$150,000
- Replace view pier stairs Topanga Beach Stairs estimated cost \$125,000
- Replace fence Dan Blocker estimated cost \$80,000
- Renovate restroom Malibu Surfrider estimated cost \$179,000
- Replace fence Malibu Surfrider estimated cost \$88,000
- Replace restrooms (#1 and #3) Point Dume Beach estimated cost \$1,000,000
- Replace water line Zuma Beach estimated cost \$1,500,000
- Renovate restrooms (#6 and #8) Zuma Beach estimated cost \$1,000,000
- Install sewer liners Zuma Beach estimated cost \$82,000
- Replace stairs Nicholas Canyon estimated cost \$200,000
- Repair concession window covers Zuma Beach estimated cost \$200,000



Establish new sewer connection at White Point - \$820,000

This project will connect the public restroom at White Point via 500 lineal feet of the force main to a nearby trunk sewer. The former sewer line was disconnected due to a landslide that occurred in November 2011.

Status: The scope and conceptual drawings are developed and are being reviewed for CEO funding. Project will be ready to begin September 2018.

Renovate restroom at Torrance Beach (Burnout) - \$250,000

The scope of work includes removing and installing a new tile roof; replacing vent grid; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

Renovate restroom at Torrance Beach Lifeguard Station - \$300,000

The scope of work includes repairing the damaged block; removing and installing a new tile roof; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

Renovate restroom at Redondo Beach (Topaz) - \$275,000

The scope of work includes repairing the block; removing and installing a new tile roof; replacing damaged fascia; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

Replace water line at Dockweiler Beach – \$645,000

The scope of work includes abandoning the existing water line and adding a new line, a new water main, and a second meter for the RV Park. The new water main will serve the Lifeguard station, the entrance kiosk, and the irrigation system from the existing meter to the facilities.

Status: The project is being awarded to a contractor and construction will be scheduled to begin during the annual RV renovation in January 2018.

Annual RV Renovation at Dockweiler – \$250,000

The annual renovation will include electrical maintenance of all the pedestals; repair showers and restroom fixtures as required; painting all three restrooms and office area; repairing damaged landscaping; slurry seal and restripe the entire lot; and general cleanup of the facility and restrooms.

Status: Project is currently being quoted and will be completed in January 2018.

Renovate restroom at Topanga Beach - \$150,000

The scope includes replacing old plumbing fixtures with more efficient fixtures; replacing the partitions; adding hand dryers; replacing tile; and painting the interior and exterior of the building.

Status: Project has started with the exterior of the building. The renovations are scheduled to start November 2017.

Replace view pier stairs at Topanga Beach Stairs - \$125,000

The scope of work includes developing a set of plans; removing the existing stair structure; and installing a new one.

Status: Project is scheduled to begin Winter 2017/18.

Replace fence at Dan Blocker - \$80,000

The scope of work includes removing existing fence fabric; replacing damaged posts; placing poly-coated sleeves over all the posts to protect them; and installing new poly-coated fence fabric to help protect beach patrons from entering the parking lot from steep terrain.

Status: Project is scheduled to be completed Winter 2017/18.

Renovate restroom at Malibu Surfrider - \$179,000

The scope includes replacing old plumbing fixtures with more efficient fixtures; replacing the partitions and benches; adding hand dryers; replacing the doors and tile; repairing the damaged sewer laterals; refinishing the floors; and painting the interior and exterior of the building. ADA will be addressed during the construction.

Status: Project is scheduled to begin Winter 2017/18.

Replace fence at Malibu Surfrider - \$88,000

The scope of work includes removing existing fence fabric; replacing damaged posts; placing poly-coated sleeve over all the posts to protect them; and installing new poly-coated fence fabric to help protect beach patrons from entering the parking lot from steep terrain.

Status: Project is scheduled to begin Winter 2017/18.

Replace restrooms (#1 and #3) at Point Dume Beach - \$1,000,000

The scope of work includes demolishing existing buildings; installing new prefab restrooms; and tie into existing utilities.

Status: Project is scheduled to begin Winter 2017/18.

Replace water line at Zuma Beach - \$1,500,000

The scope of work includes abandoning the existing water line; adding a new line for the nine restrooms; and installing a new backflow device.

Status: Project is scheduled to be completed December 2017.

Renovate restrooms (#6 and #8) at Zuma Beach - \$1,000,000

The scope of work includes repairing the damaged block; removing and installing a new tile roof; replacing the existing floor and wall tiles; installing new toilet and sink fixtures; and installing new partitions with ADA benches and grab bars as required for ADA compliance.

Status: Project is scheduled to begin Winter 2017/18.

Zuma Beach Sewer Liners at Zuma Beach – \$82,000

The scope includes installing liners in the sewage lines from restrooms #1 – #9 to the septic system.

Status: Project is scheduled to begin Winter 2017/18.

Replace stairs at Nicholas Canyon - \$200,000

The scope of work includes developing a set of plans; removing the existing stair structure; and installing new stair structure.

Status: Project has been completed.

Repair Concession Window Covers at Zuma Beach - \$200,000

This project is to replace three metal roll-up window covers; replace doors; and vent/ducting for the two food concession buildings.

Status: Project is being assigned to a craftsperson to order parts and schedule installation. Project to be completed by late winter 2017/18.
