**WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

In consideration of being allowed to participate in any way in the Los Angeles County Beaches and Harbors recreation programs, and related events and activities, the undersigned:

1. Agrees that prior to participating he or she should inspect the facilities and equipment that will be used, and if the participant believes anything is unsafe, he or she should immediately advise the Park Director of such condition(s) and refuse to participate.
2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability, death, severe social and economic losses. This might result from not only their own actions, inactions, or negligence, but also the action, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at the time.
3. Assumes all of the foregoing risk and accepts personal responsibility for the damages following such injury, permanent disability or death.
4. Releases, waives, and discharges the County of Los Angeles, its special districts, elected and appointed officers, employees, agents, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of any premises used to conduct the event(s). In which hereinafter referred to as "releaser", from all liability for, the following. His or her heirs, next of kin, personal representatives or assigns for any and all claims, demands, losses or damages on account of injury, including death or damage to property caused or alleged to be caused in whole or in part by any act or omission of the releaser or otherwise, and hereby covenants not to sue releaser for same.
5. Agrees to indemnify, defend, and hold releaser harmless from and against any and all liability, including but not limited to demands, claims, actions, fees, costs, and expenses (including attorney and expert witness fees), arising from or connected with the undersigned's participation in the event(s).
6. Agrees that the foregoing waiver, assumption of risk and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion thereof is held invalid, agrees that the balance shall, notwithstanding, continue in full legal force and effect.

*I have read the above waiver and release, understand that I have given up substantial rights, including my right to sue, by signing it and sign it freely and voluntarily, and intend by my signature for this to be a complete and unconditional release of all liability to the greatest extent allowed by law.*
