AMENDMENT TO LEASE

THIS AMENDMENT TO LEASE made this

WHEREAS, the parties hereto have heretofore, on the

abrogate the right of Lessee to receive any and all proceed
which are attributable to the taking in eminent domain of
business installations, improvements, structures and build-
ings belonging to Lessee immediately prior to the taking of
possession by the condemning authority as said rights are

 - Structures, buildings, or other improvements belonging to Lessee immediately prior to the taking of possession by the condemning authority.
