SUBJECT: **2011 SUMMER CAMP CANCELLATION**

Thank you for your interest in the Department's Water Awareness, Training, Education and Recreation (W.A.T.E.R.) Program summer camps. While I am very proud of the summer beach camps that my staff and the County lifeguards have offered over the years, I unfortunately must inform you that, due to budget constraints, the Department will not be able to offer the summer camps this year.

Last year, the W.A.T.E.R. Program served over 6,600 children, yet our summer camp participants comprised only 9% of the youth served. The summer camps also happen to be one of the most costly portions of the program, as the number of children served is low relative to the number of lifeguards we must contract with to instruct the weeklong activity. The main goal of the W.A.T.E.R. Program is to educate Los Angeles County youth and raise awareness of ocean and beach safety through organized activities, which not only provide skills and knowledge, but also create positive lifetime experiences for our participants. Accordingly, a major goal of this Department is to provide outreach services to those with limited access or opportunity, including inner city and/or low-income children, who would otherwise not have the ability to participate in this worthwhile program. Many of our participants visit the beach for the first time through our program's Ocean Safety Days, which are made available to schools and youth groups throughout Los Angeles County and are the vehicle we use for our outreach efforts. These participants also comprise over 80% of the children we serve.

Our Ocean Safety Days are unique to us and are not made readily available to schools and youth groups by other providers throughout the year. These are all factors that were used in assessing which aspects of the W.A.T.E.R. Program to cut, as it is no longer feasible to fund the full Program as in years past. This was a difficult decision to come by, as I am well aware of the W.A.T.E.R. Program's popularity and importance in children's lives. However, I strongly believe that focusing our resources to a year-round program will allow us to serve the largest and most diverse segment of the youth population in Los Angeles County.

Fortunately, summer beach camps are not unique to our W.A.T.E.R. Program and are readily offered by other providers, both public and private, along Los Angeles County beaches every year. For your convenience, we have attached a list of camps offered by local cities you may want to consider patronizing. I remain hopeful that we will be able to offer our summer camps in the future.

Thank you again for your continued support and interest in our wonderful youth program.
