SMALL CRAFT HARBOR COMMISSION MINUTES July 9, 2014 – 10:07 a.m.

Commissioners: Allyn Rifkin, Chair; Dennis Alfieri, Vice Chair; Russ Lesser, Commissioner; David Lumian, Commissioner; Vanessa Delgado, Commissioner (excused absence).

Department of Beaches and Harbors: Gary Jones, Director; Steve Penn, Acting Chief, Asset Management Division; Linda Nava, Real Property Agent II, Asset Management Division; Charlotte Miyamoto, Chief, Planning Division; Michael Tripp, Planning Specialist, Planning Division; Carol Baker, Chief, Community and Marketing Division; Debra Talbot, Manager, Community and Marketing Division.

County: Jill Jones, County Counsel; Sergeant Anthony Easter, Sheriff's Department.

Chair Rifkin called the meeting to order at 10:07 a.m. followed by the Pledge of Allegiance, and read the Commission's policy on public comments.

Approval of Minutes:

Chair Rifkin noted there are three meeting minutes pending approval, and each one will be approved separately.

Chair Rifkin stated he is abstaining from approving the April 9th minutes because he was not at the meeting.

Motion to approve the April 9, 2014 minutes by Commissioner Alfieri, seconded by Commissioner Lesser, unanimously approved.

Ayes: 3 - Mr. Alfieri, Mr. Lesser, Mr. Lumian

Jon Nahhas commented on the May minutes and played a piece of the audio recording from the prior meeting.

Commissioner Lesser stated that the minutes quoted him accurately and moved to approve the minutes. Commissioner Lumian seconded and stated the minutes accurately reflected the meeting.

Commissioner Alfieri stated that the minutes documented accurately what he said.

Chair Rifkin requested the minutes to include his statement that 'nothing in the Visioning statement stated changes in height or density, but if it was implied he would like to see an EIR'.

Chair Rifkin motion to approve the amended May 28, 2014 minutes. The Commission unanimously approved.

Ayes: 4 - Chair Rifkin, Mr. Alfieri, Mr. Lesser, Mr. Lumian

Motion to approve the June 11, 2014 minutes by Commissioner Lesser, seconded by Commissioner Alfieri, unanimously approved.

Item 3 – Communication from the Public:

Jon Nahhas spoke about public record act request and visioning process.

Nancy Vernon Marino expressed concern with lack of communication, and the need for full transparency.

Item 4 – Communication with the Commissioners

Commissioner Lumian reported that he attended the Navigation Safety Advisory Council meeting in which a bill was signed for funding dredging of recreational harbors. And also at the NAVSAC meeting, the Coast Guard agreed not to eliminate the lights in the Channel Island.

Commissioner Lesser reported that he attended the 50th Anniversary Committee meeting, and was excited about the activities that are being planned for the County residents.

Chair Rifkin visited Dana Point and Ventura Marinas; expressed how impressed he was with the development at Ventura Marina Village.

Item 5a – Marina Sheriff

Sergeant Easter presented both the Liveaboard and Crime Stats reports. He also discussed the events that took place on May 16th at the Del Rey Yacht Club, and the homicide that took place on Mindanao Way and the 90 Freeway.

Commissioner Lumian asked about the condition of the victims.

Sergeant Easter replied that both victims are doing fine.

Nancy Vernon Marino thanked the Sheriff's Department for their report. She mentioned a regulation called "No Drinking and Boating" and would like to see the statistic report of it.

Jon Nahhas expressed concerns with the homicide incidents, homeless issues, and the Coast Guard eliminating the anchorage in Marina del Rey.

Chair Rifkin asked if staff has any information on the Coast Guard anchorage issue.

Mr. Jones replied he was not aware of the anchorage issue, but was aware of the collateral issues on a boat that was swept ashore onto Dockweiler Beach a couple of months ago.

Commissioner Lumian stated that when the Coast Guard makes a change they always publish those changes in local notices to mariners. He has not seen any notices and asked if Mr. Nahhas has seen any.

Mr. Nahhas responded yes.

Chair Rifkin asked staff to provide a report at the next meeting.

Chair Rifkin wanted to know if there has been any discussion on a bike sharing system for Marina del Rey.

Mr. Jones responded that these types of facilities have been discussed within the Visioning process under the Mobility Hubs concept.

Commissioner Alfieri suggested that Mr. Jones contact the Coast Guard and introduce himself.

Mr. Jones agreed to reach out to the Coast Guard and use this topic as a point of conversation.

Commissioner Lumian reported that at the NAVSAC Long Beach meeting he invited representatives from the Coast Guard, NOAA, and Army Corps of Engineers to visit the Marina.

Item 5b – Marina del Rey and Beach Special Events

Ms. Baker spoke on the 4th of July traffic and highlighted a few of the special events.

Item 5c – Marina Boating Section Report

Ms. Talbot reported on the Waterbus program, the opening of Parcel 77, and filming at Anchorage 47.

Jon Nahhas commented on the 4th of July firework show, the closure of public promenade and suggested having more Latin music at the summer concert series.

Nancy Vernon Marino complimented the expansion of Waterbus program and suggested having it all year round. She also expressed the need for more recreational land.

Item 6a – Update on Marina del Rey Toxics Total Maximum Daily Load (TMDL)

Ms. Miyamoto presented the staff report.

Mr. Tripp reported the Department's activities in the TMDL process.

Commissioner Lumian heard that Bay Area was successful in lifting the TMDL and wanted to know if the Department could approach in the similar manner.

Mr. Tripp stated it is similar and that they would like to do a site specific objective study to look at the water quality and a sediment study.

Commissioner Lumian wanted to know how the \$4 million figure which was approved by the Board was determined.

Ms. Miyamoto responded that the estimate came from the Department of Public Works (DPW).

Commissioner Lumian asked if staff would report back on the specifics of what approach was taken, what studies could be done, and who was hired as the consultant.

Ms. Miyamoto replied that staff will continue to provide the Commission with updates.

Commissioner Lumian felt that this is a critical issue. He would like to have as much information as possible, and be provided with more specific information as it becomes available.

Ms. Miyamoto reported that DPW is targeting August for the submission of the Board letter for approval of selection of consultants and the scope of work.

Mr. Tripp noted that when the date is set for the State Board to consider the TMDL revisions, it would be reported to the Commission.

Commissioner Lumian noted the EPA has a list of "No Discharge Zone" harbors, and Marina del Rey is not on it. He wanted to know if that program would be beneficial for the Department.

Mr. Tripp stated that he is not familiar with the program, but will look into it.

Commissioner Lesser asked staff to elaborate on what was learned from the harbors that went through this process.

Mr. Tripp stated that they have been talking to San Diego who has a TMDL for copper.

Commissioner Lesser asked which harbors are being affected.

Ms. Miyamoto replied that San Diego was the first; now Marina del Rey; and next would be Newport Beach. She stated that not all harbors are affected because some have good flushing system.

Captain Wendy Kornbecx commented on ways copper may be getting into the marina, the effects on small boaters and recommended a study on the sediments that flow down Ballona Creek.

Jon Nahhas talked about boat facilities, do it yourself boatyard, and water quality.

Nancy Vernon Marino commented on creating a system for circulation, small boaters and development.

Commissioner Lumian asked if there was anything written about the electrolysis and construction of the docks.

Captain Wendy Kornbecx stated she does not know if a study has been done.

Chair Rifkin stated that he went to testify at the Board of Supervisors. He asked if a member of the boating community can be involved in selecting the consultants and preparing scope of work.

Mr. Jones explained that the consultants would be selected from a County approved list that is held by the Department of Public Works (DPW), and the selection is done by those with experience and education in scientific fields.

Ms. Miyamoto added that the Regional Water Quality Board would not dictate the methodology, but is involved in the process. She will provide updates on the scope, and invite the DPW and consultants to speak at a Commission meeting.

Chair Rifkin asked input from the Commissioners about those comments made by members of public who appeared to have scientific background.

Commissioner Lesser would like to have an update monthly or quarterly.

Mr. Jones reported there will be a consultant advising and working at the Department who has education and experience in the subject matter to provide updates to the Commission.

Commissioner Lumian asked that since San Francisco was successful in their site specific study, has staff contacted them in this regard.

Mr. Jones responded not directly, but he has reached out to the division within the EPA who is currently evaluating the Biotic Ligand Model, a methodology that was similar to what was used in San Francisco.

Commissioner Lumian suggested finding out who worked on the project and who the consultants were. He is interested in obtaining information on what they actually did, what was studied, and how successful it was.

Commissioner Alfieri would like to monitor and understand what pollutants that are coming in from other sources.

Mr. Jones stated that there is a permit with the Regional Water Board permitting discharge that comes from the adjacent cities. The DPW is working with the Regional Board on the issues of discharge from storm drains and is to address improvements to prevent rain water from flowing directly into the harbor.

Commissioner Alfieri would like to see an example or a study to know what is being discharge.

Ms. Jones noted that there is a U.S. Supreme Court case where the County was involved that addressed the allocation and responsibility of the County.

Ms. Miyamoto stated that there have been presentations on the Oxford Basin. The project is expected to be completed by the end of next year.

Chair Rifkin thanked staff for offering to provide regular reports on this item.

Commissioner Lumian requested that staff invite representatives from the DPW who are involved with TMDL to provide more specific information on what the plan is.

Item 6b – Resolution No. 2014-07-09 regarding the Marina del Rey Visioning Statement

Mr. Jones reported that at the last meeting the Commission requested to receive the minutes as well as a written confirmation of the resolution that was passed unanimously on May 28. The document as drafted is on record and can be used by the Commission as a point of reference. No further action is needed.

Patricia Younis representing the lessee of Fisherman's Village expressed concern with the language in item 2 of the resolution.

Chair Rifkin asked if she has suggestions.

Patricia Younis would like to add the word "conceptually"

Captain Alex Balian spoke on Fisherman's Village.

Nancy Vernon Marino commented on Fisherman's Village and the need for recreation.

Jon Nahhas talked about the Visioning process, Fisherman's Village, and the LCP.

Commissioner Lesser agreed to change the word "previously" to "conceptually", and in light of the recent change of the plan to relocate the launch ramp, he wanted to know what would happen next.

Chair Rifkin asked staff to provide information on what was on Supervisor Knabe's blog.

Mr. Jones advised the Commission that they could not change a motion that has already been passed. He reported that a status update on the Visioning process will be provided at the July 16 DCB meeting. The Visioning Statement will be revised, and a draft will be presented to the Regional Planning Commission.

Commissioner Lesser acknowledged that changes could not be done.

Commissioner Lumain stated that it is a recommendation and should be taken as a general statement.

Ms. Jones noted that the lessee is not legally bound to the action.

Commissioner Lumian mentioned that Supervisor Knabe is aware of the discussion at the May 28 meeting, and not only listened to the various agencies input but also to the public. He suggested going on record to thank Supervisor Knabe for his leadership and staff for doing a great job.

Commissioner Lesser seconded the motion.

Chair Rifkin stated that there are good parts in the Visioning Statement and would like to somehow transmit the resolution to the Board of Supervisors.

Mr. Jones stated that the May 28 minutes along with the resolution would become part of the record that goes with the Visioning Statement. He suggested drafting a cover letter for the Chair's signature and confirmed that writing an administrative cover letter to be part of the public record would not be an issue.

Chair Rifkin was in favor of staff drafting the cover letter referencing the minutes and resolution for his signature, and asked if staff had sufficient information.

Mr. Jones responded that with respect to the minutes and resolution no other information would be required, but if the Commission has additional information that they would like to highlight in the letter then that would need to be provided.

Chair Rifkin asked if there was anything they wanted to highlight, or if they were in favor of drafting an administrative letter indicating the Commission meetings were well attended and the important issues were raised.

Commissioner Lumian felt that excluding the Fisherman's Village and the launch ramp issues, the Visioning Statement would not be complete. He would like this Commission to be more involved in the Visioning.

Chair Rifkin agreed that the Visioning process is not over.

Commissioner Lesser stated the Commission unanimously felt that there is no need for increase in density or height limit.

Mr. Jones stated the Commissioners' statements at the meeting were documented in the minutes.

Chair Rifkin noted that the minutes reflected the feelings of the Commission regarding density and height.

Commissioner Alfieri asked if there was time for further discussion or drafting an administrative letter highlighting what was already discussed.

Mr. Jones responded that initially the Visioning Statement was to go to the Board in September, but in light of the recent updates, the initial timeline may have changed.

Commissioner Alfieri suggested staff write a letter for the Chair's signature.

Ms. Jones noted that since the Regional Planning Commission meeting is a public meeting the Chair can either attend or submit a letter for the meeting.

Commissioner Lumian requested that DRP come to the next meeting to provide an update.

Commissioner Lesser expressed that the reason for moving things around was to beautify the entrance to the Marina, and agreed it is a great idea for the DRP to come and present.

Chair Rifkin confirmed that a letter would be drafted for his signature to the Regional Planning Commission referencing the resolution and the minutes, and another letter thanking Supervisor Knabe.

Mr. Jones clarified the Commission's request to have a follow-up presentation of Visioning process by the DRP.

Commissioner Lesser asked to have a monthly update on the Fisherman's Village project.

Mr. Jones replied if there is anything to report he will put it on the agenda.

Commissioner Alfieri suggested inviting the lessee to come and provide an update.

Item 7a- Recreational Boating Strategy

Ms. Baker stated that staff will provide an outline of the boating strategy and explained that the document will be updated to be consistent with the Department Strategic Plan, and input from the public and Commission.

Ms. Talbot provided a PowerPoint presentation on the main details of the Recreational Boating Strategy.

Commissioner Lumian asked the location of the new dining docks.

Ms. Talbot replied Pier 44, and more locations to be added as redevelopment occurs in Marina del Rey.

Ms. Baker added that staff from Boating, Asset Management, and Planning have been working together to look for opportunities that may arise to provide this type of recreation.

Chair Rifkin stated that this is a good start but that an outline of specific steps is needed for a road map, and asked what would be the next step.

Ms. Baker explained how the plan is part of a larger goal, and discussed the various elements that would go into the process.

Nancy Vernon Marino commented on the creation of the Boating Section, and writing of the boating strategy.

Jon Nahhas commented on the priority of the boating strategy, the goals and objectives of the boating access.

Captain Alex Balian talked about a plan of action and milestones, staffing issues, and commended Ms. Talbot for her work.

Commissioner Lesser stated this is a start with great ideas for step one, and step two would be to develop a timetable for implementation. He also mentioned that the County has programs to bring inner city kids to the Marina. He requested that staff report back with action plan and steps.

Commissioner Lumian felt that this was a report of current status but was expecting more. He stated that when the resolution was passed the first step was to inventory all the programs and assets in the Marina. He wanted to inventory governmental and non-governmental efforts that are being made for boating, conduct a needs survey by interviewing the entities, and identify what the challenges and opportunities to meet the goals. He suggested the docks that are no longer being used by Catalina Ferry be reverted back to a public dock. This is one of many other ideas he has.

Ms. Baker spoke on the move of the Boating Section, staffing issues, and asked Commissioner Lumian for a list of items he raised.

Chair Rifkin expressed that this is a priority program and asked Ms. Baker to think about how the Commission can help obtain additional resources.

Commissioner Lumian stated he was hoping to see recreational boating in the Visioning plan because a lot of ideas were given during the Visioning process, also a number of ideas discussed over the years to this Commission.

Ms. Baker replied that there are plans in the next two years to redo Marina Beach and that staff could provide a report on the capital projects.

Commissioner Lumian would like to see what is being done to improve recreational boating and to get more people out into the water.

Chair Rifkin suggested this item be brought back at the next meeting and to focus on the next step.

Item 8 – Staff Reports

Mr. Penn provided the staff report.

Jon Nahhas talked about displacement plans and vacancies, the General Fund, and creating an EIR.

Nancy Vernon Marino commented on devoting resources to boating and recreational development.

Adjournment

Chair Rifkin adjourned the meeting at 12:48 p.m.

BOARD ACTIONS ON ITEMS RELATING TO MARINA DEL REY

On June 24, 2014, the Board of Supervisors authorized the Chief Executive Officer to amend an agreement with Monger, Tolles & Olson LLP, to extend the term of the contract to June 30, 2015, for the provision of real property consultation and negotiation services and intermittent work advising on strategy for development and leasing in Marina del Rey.

On July 1, 2014, the Board of Supervisors approved and instructed the Chairman to sign an amendment to the lease for the Marina del Rey Parcel 41, Catalina Yacht Anchorage, located at 13505 Bali Way, in Marina del Rey, pertaining to the readjustment of rents and insurance for a ten-year term ending May 31, 2022.

On July 8, 2014, the Board of Supervisors approved the revised Project scope and budget of \$15,520,000 for the Anchorage 47 Dock Replacement Project, Capital Project No. 88987 (Project) and approved the following actions:

Approve an appropriation adjustment transferring \$600,000 from the Marina Accumulative Capital Outlay Services and Supplies budget, \$1,600,000 prior year Net County Cost from the completed Redondo Beach Erosion Mitigation Project, and \$1,700,00 from Anchorage 47 Trust Fund to revised Project;

Adopt plans and specifications for the construction of the Project at an estimated construction cost of \$12,000,000; advertise and set August 5, 2014 at 2:00 p.m. for bid opening;

Authorize the Director of Public Works to execute a consultant services agreement with the lowest responsive bidder to prepare a baseline construction schedule for an amount not to exceed \$5,000, funded by the existing Project funds; and

Authorize the Director of Beaches and Harbors to close escrow to acquire a portion of the adjacent Parcel 44 dock area leasehold as part of the Project.

On July 15, 2014, the Board of Supervisors authorized the Director of Beaches and Harbors to execute amendments to increase annual contract totals to the Department's existing contracts for WaterBus Service and the Marina del Rey Convention and Visitor's Bureau to support activities commemorating Marina del Rey's 50th birthday throughout 2015; and authorize the Director to execute amendments to increase funding for existing service contracts, as needed, related to the Marina's 50th birthday for anticipated higher usage of Marina del Rey's public areas and facilities during the yearlong celebration.

REGIONAL PLANNING COMMISSION'S CALENDAR

No items relating to Marina del Rey were heard by the Regional Planning Commission during meetings for the month of July 2014.

CALIFORNIA COASTAL COMMISSION CALENDAR

No items relating to Marina del Rey were heard by the California Coastal Commission during meetings for the month of August 2014.

VENICE PUMPING PLANT DUAL FORCE MAIN PROJECT UPDATE

There has been no update on this item since the last meeting. On June 18, 2014, representatives from the City of Los Angeles and the County Departments of Regional Planning, and Beaches and Harbors met to discuss the Coastal Development Permit (CDP) from the County required for the Venice Dual Force Main project. The representatives from the various departments discussed how best to coordinate the Dual Force Main Project with other planned projects in the Marina, to minimize impacts to Marina visitors and residents. A CDP for the project was filed with the Department of Regional Planning on May 21, 2014. The City will also need to secure a CDP from the California Coastal Commission for the segment under the Marina's main channel.

REDEVELOPMENT PROJECT STATUS REPORT

The updated Marina del Rey Redevelopment Projects Descriptions and Status of Regulatory/Proprietary Approvals report is attached.

DESIGN CONTROL BOARD MINUTES

MARINA DEL REY SLIP REPORT

The overall vacancy rate across all anchorages in Marina del Rey stood at 16.9% for June 2014, and after adjustment to remove out-of-service slips and 50% of available double slips, the vacancy rate at 15.8%. The vacancy data by anchorage and slip length can be found in the document attached.



5. Old Business

A. <u>Parcel 13 – Villa del Mar Apartments – Final consideration of site renovation project and</u> <u>Design Control Board Review related thereto – DCB #13-009-B</u>

Mr. Lopez presented the project staff report.

Aaron Clark stated that a Mitigated Negative Declaration (MND) had been completed for this project, and that Regional Planning had already completed their review.

Brian Tichenor discussed some project changes that conflicted with the staff report specifically, that the promenade will not be widened, the permeable material will no longer be used, and there will not be installation of the two drinking fountains. Another change mentioned was the loss of eucalyptus trees and that more will be planted to replace them. He also added that the awning was changed due to structural issues.

Public Comment

Patricia Younis expressed her support for the project and complimented the Lessee on their design.

Board Comment

Vice Chair Jubany requested to see the parking structure renderings and asked applicant to explain how it is changing.

Brian Tichenor stated that the entire side façade of the parking structure is covered by mature ficus repens vines, which they would like to protect. In addition, they would like to install some green screens along the Marina side of the structure, to mitigate the feeling of the garage face.

Chair Phinney asked about the ficus tree that needs to be removed.

Brian Tichenor replied that it obstructs access to the pool area and needs to be removed to meet ADA standards.

Chair Phinney asked about the use of permeable pavers turf block?

Annette Reardon explained that the turf stone would be isolated to the sides of the promenade so that the majority of the surface would be easily passable by pedestrians and the occasional emergency vehicle.

Mr. Lopez presented the project staff report.

Mr. Wong asked if the request was a repeat of previously approved signage

Mr. Lopez replied that the applicant was requesting additional signage on Via Marina and Fiji Way.

Mr. Tripp stated additional signage was also being requested for a separate event, "Beach Eats".

Mr. Wong asked if the signs were intended to remain in place permanently, and if there were any other events in the Marina that would need to use the poles.

Catrina Love stated that Admiralty Way, Fiji Way and Via Marina have over 90 light poles and the request was only to use 23 of them. She also stated that based on Public Works' Guidelines, only community-based events are allowed to advertise on the light poles.

Chair Phinney clarified that the request was for two signs each on 13 additional light poles, a second sign on all the previously approved light poles, and a determination by the Board between the green version or the blue version of the sign.

Catrina Love stated that the request was for 10 additional light pole signs in the road rightof-way and 8 on Lot 10 for a total of 31 signs.

Vice Chair Jubany asked for clarification regarding the amount of signage being requested for placement on Fiji Way and Via Marina .

Catrina Love replied that on Admiralty Way there are a total of 26 light poles and the request was only to place banners on 13 of them.

Mr. Wong stated he would like to make it easier on staff to handle approvals regarding changes to locations by having staff make the decisions.

Mr. Wong further stated he would like to give staff the flexibility to make changes, and that he didn't want to give an approval on a fixed location of the signs that would prohibit them from being moved.

Ms. Miyamoto asked Mr. Wong if his intention was to give staff the flexibility on which poles could have the signs.

Chair Phinney stated that it's his understanding that staff has the ability to approve for itself, temporary signage without bringing that signage to the Board for approval.

Ms. Miyamoto stated that staff can approve temporary signage for 60 days.

Vice Chair Jubany stated that the banners' design should be reviewed before they are installed.

Mr. Wong expressed his preference for the approval of the blue design.

Vice Chair Jubany expressed her preference for the approval of the green design.

Chair Phinney recommended splitting up the approval of signage and having half of the signs in each color.

On a motion of Chair Phinney, seconded by Mr. Wong, the additional signage was approved as requested with 50% blue signs and 50% green signs, with the determination of where to place each color sign at the applicant's discretion. Ayes: 3 – Chair Phinney, Vice Chair Jubany, and Mr. Wong

C. <u>Presentation by the Department of Public Works on Phase IIIB of the Marina del Rey 18-inch Watermain Replacement Project</u>

Heather Savanapridi from the Los Angeles County Department of Public Works Waterworks Division presented the informational report.

Mr. Wong inquired if both lines would be constructed simultaneously and asked approximately when the project would be completed.

Heather Savanapridi answered affirmatively and stated that the contractors would be given 130 working days to complete the project, which is approximately eight months.

Public Comment

Lynn Shapiro asked if there would be consequtive days of water shut-offs for residents and asked about lane closures on Via Marina.

Chair Phinney stated that it's his understanding that there will be one shut off, for a maximum of four hours, for each residential area and that notice will be given in advance. He also stated that there would probably be one lane of traffic closed at the determination of a flag man.

Patricia Younis stated that the department should consider the boat parade, which occurs in December, with a popular viewing location at Fisherman's Village.

Board Comment

Chair Phinney concured that the boat parade was a major event in the Marina and stated that there are three major holidays in the Marina that should be considered. He also requested the Department of Public Works consider starting the project after the Labor Day weekend.

Mr. Wong added that Fiji Way and the parking area will be busy during the boat parade.

Chair Phinney suggested starting the project in the area most impacted by the boat parade in September to allow it to be finished by December.

Ms. Miyamoto stated that the Department will discuss the concerns of the Board members and the public with the Department of Public Works.



Item 1 – Call to Order and Pledge of Allegiance

Chair Rifkin called the meeting to order at 6:04 p.m., followed by the Pledge of Allegiance.

Item 2 – Public Comment:

A few members of the public requested to have their time allotted to a person in their group to speak on their behalf. The Commissioners unanimously voted to keep the three minutes limit per person.

Dan Gottlieb asked the Commissioners if they received the book, "Chinatown County", and passed out a copy of goal six and read it out load. He also stated it was unclear what item was up for discussion on the agenda.

Jon Nahhas spoke on the fee increase proposal, slip vacancies and prices, notifying the Board of Supervisors about Commission actions, and requested the Commission to require the lessees to open public lands.

Art Ford spoke on the Mariners Village project and asked how additional land and water acreages could be added without having a public bid.

Michelle Summers spoke on ESHA, wildlife management strategy for development, edge landscape, Marina development, bike and walk paths, dingy docks and kayaks launch areas.

Item 3a – Presentation on the status of the Marina del Rey visioning process and a discussion of Commissioners and the member of the Design Control Board to identify any ideas, concerns, or issues that should be considered as part of the process.

Gina Natoli presented the report on the Visioning Statement and discussed the steps in the visioning process.

Michael Tripp presented the six boat launch ramp concept plans. He clarified that the plans are concepts only and no project had been approved.

Chair Rifkin asked about the approval process and the timeline.

Ms. Natoli stated that the visioning statement is not a legislative action and does not require a public hearing. She stated that her goal was to go the Regional Planning Commission in either June or July, to get the recommendation, then to go to the Board in August.

Commissioner Lumian asked about the second boat launch alternative. He wanted to know if the Windward Yard was to remain at the existing location where the existing mast-up storage would go, and if the existing launch ramp would remain at its current location.

Mr. Tripp responded that it had not yet been determined where the mast-up storage would go, and that the plans are only basic concepts.

Commissioner Alfieri inquired if the Visioning Statement would go to the Coastal Commission after the Board.

Ms. Natoli replied that it would not because it is not an amendment to the LCP. She stated that it was only a County guidance document.

Chair Rifkin asked if in the future the Commission would rely on the guidance document.

Ms. Natoli responded affirmatively, and explained that if there were actions that arise from the Visioning Statement that require an LCP amendment, that amendment would go through the advisory bodies, the Regional Planning Commission, the Board of Supervisor and the Coastal Commission.

DCB Chair Phinney asked staff to discuss the thought behind developing the four activity districts and how effective it would be to have the visitors' row located at the site of the current launch ramp.

Ms. Natoli stated that the idea to create activity districts is not to have exclusive zone areas. The activity districts allow for consolidating resources help identify needs for an area and create a cohesive picture of the Marina. She further explained that to develop a walkable and sustainable area you need to identify uses that are consistent with each other. This helps in creating consolidated parking and a mobility hub within each district. It is difficult to develop a continuous promenade in Marina del Rey because of safety concerns. Consolidating the uses and creating one area where the uses that create safety concerns are clustered would allow the development of a pedestrian and bicycle visitor promenade to a greater extent than is currently possible. Parcels 55 and 56 do not have the necessary space or the configuration to become a visitor-serving commercial retail area.

Public Comment

Michael Pashaie commented that constraints of the site and lack of self-sufficient parking caused the delay of the redevelopment of Fisherman's Village in the past. He then stated that this issue has been resolved and he is now ready and willing to move forward with the project. He also stated that he doesn't want to see Shanghai Red's used as a parking lot and that there is not a need for additional shopping center at Parcel 49.

David Baker stated this proposal was brought forth in 1999 with the Vestar project, and it was determined that creating a cross wind configuration launch ramp was unsafe. Mr. Baker provided a three page document to the Commissioners.

Jon Nahhas gave a brief presentation on the November 2011 Coastal Commission hearing. He commented on public participation in the visioning process, and that the process should have been open, transparent and understandable.

Dan Gottlieb and Jeff Olivares agreed with Jon Nahhas.

Roslyn Walker spoke about views, and to have boats not a commercial use on Admiralty.

Joseph Palazzolo opposed any development along the waterfront that is not water dependent and felt that the Marina was designed for boating, not shopping centers.

William Tallichet asked why the County was proposing to take out a restaurant to build a parking lot and then stated that Whiskey Reds should remain a waterfront restaurant.

Catherine Hillerman, Elisa Hicks, Lina Shanklih, William Hicks and Katherine Peterson read a letter from the Law Firm of Chatten-Brown & Carstens, LLP on behalf of the Ballona Institute.

Susanne Cummings agreed with everything that was read and submitted the letter for the record.

Commissioner Lumian wanted to confirm with staff that the Parcel 113 project, Mariners Village, was going to come before the Commission later this year or the beginning of next year

Mr. Jones responded that the project would come before the Commission and that any proposal for a lease extension would be presented to this Commission for review prior to it being submitted to the Board of Supervisors.

Michelle Summers stated that ESHA needed to be included when redevelopment occurs and that public input was not included in the presentation.

Robert Garlipp stated all proposed developments including Parcel 113 should be part of the visioning process and that the 125 foot dock would obstruct boating.

Lynne Shapiro objected to the visioning process, and felt the traffic study under estimated the traffic on Via Marina.

Sheila Ginsberg alleged the meetings were not well publicized and that the visioning lacked public input from boaters and residents.

Mike Leneman opposed all of the proposed boat launch plans.

Al Broussard stated that the boat launch plans are mathematically incorrect and flawed.

Thomas Connors spoke against relocating the boat launch ramp.

Chris Cate stated that moving the boat launch puts small craft boating opportunities at risk, and asked that the plans be removed.

Steve Hathaway asked that the County create a plan that would minimize safety concerns while accomplishing the core goals of the Marina.

Michael O'Kelly believed that the current launch ramp is the safest and best in California and should not be touched.

Tim Riley asked about the decision to relocate the launch ramp and public input. He mentioned that Fiji Way is already the boating center and stated he submitted beforehand a list of questions to the Commissioners that he would like answered.

Barry Fisher talked about the boating traffic and how dangerous it is for non-motorized boats at the mouth of H Basin.

Lamont Roberts stated that he agreed and concurred with all of the preceding speakers.

Ellen Klugman read a letter for Erika Louncle.

Mark Sewtyrz shared a video.

A signed petition was submitted to the Commission.

Sharie Green spoke against over development and submitted photos.

Patricia Younis talked about Fisherman's Village and submitted a letter from The Bridge Group.

Christine Davis read a letter from LAX Chamber of Commerce and submitted the letter.

Plinio Garcia opposed removing Fisherman's Village and relocating the public launch ramp.

Kathy Knight requested that the County protect the wildlife of the Ballona Wetlands and the blue heron, and not build a three-story parking lot across from Fisherman's Village.

Keith Lambert would like to see the other two proposals that do not include moving the boat launch ramp, and stated the government is the only one who can keep land available for public use.

Douglas Fay talked about a request to create an advisory board and House Document 389.

Sandie West showed pictures from the April 25th visioning meeting and stated that there was nothing about all the development that was presented.

Paul Lance spoke about the Visioning Statement and the role of the Commission. He asked the Commissioners to deny the plan and have the County work with the public, and then come back with a new proposal.

Gerald Sobel spoke on the vision of the 1954 Congressional Act.

Rick Oefinger spoke about his sportfishing and whale-watching business and requested adequate parking within walking distance for his customers and ample live bait facilities.

Commission Comment

Commissioner Lesser stated that after reviewing the Visioning Statement, he feels that there are a lot of good ideas in it. He then stated that none of the proposed launch ramp alternatives are better or nearly as good as the one that is already there. He also stated that Fisherman's Village is a prime visitors' spot and that to turn that it into a parking lot is criminal and he would never support that. He wrote a statement and requested to have it placed on a future meeting agenda for further discussion. It read, "Based on input received at the joint DCB and SCHC meeting, the following guidelines should be put into effect regarding redevelopment in the Marina. If the guidelines are not followed, unless there is an extremely persuasive argument in favor of changing the guidelines, this Commission will not approve the project regardless of what the terms are: (1) When residential units are remodeled it should not result in an increase in number of units; (2) When retail use is considered it should be boating related; and (3) When buildings are added or remodeled, if there is any chance that it would affect boating due to changing wind patterns, there should be no increases in existent building height."

Commissioner Lumian stated that he submitted questions to staff prior to the meeting.

Mr. Jones informed the Commissioners that responses will be provided to the questions that were submitted.

Commissioner Lumian expressed concern with Fisherman's Village during the interim, the launch ramp and cross winds. He summarized the following points heard today: Keep the launch ramp; Keep Fisherman's Village but spruce it up; Have it as an event center and small retail center; keep trees; Safeguard birds and habitat and promote boating. He would like to have the visioning plan and the strategic plan for recreational boating meld together, and put boating first. He suggested and encouraged the strategic recreational boating plan be developed, recommended the launch ramp and Fisherman's Village stay at their current locations, and suggested development of a common vision for Marina del Rey that puts boating first.

Commissioner Alfieri stated that he supported Mr. Lesser's comments. He asked how many publicly announced meetings were held during the entire process.

Ms. Natoli responded the process started April 2013, and that she did not know the exact number of meetings that were held.

Commissioner Alfieri stated that the minutes from prior public meetings were well documented and that the same arguments were heard from the public tonight. He stated that he was concerned with over development and suggested taking a step back to revisit the plan, taking into consideration public comments and the support of the Commission for the Fisherman's Village project.

DCB Chair Phinney stated that the launch ramp as it exists currently is one of the best in Southern California, and that the idea of changing it does not seem logical. As a planner and architect he understands the idea of having effective use zones, but when it is looked at as something that is entirely pure it is a mistake. He suggested thinking outside of the box. Mr. Phinney also commented on the issues of main entrance to Marina del Rey, landscaping, wildlife, publicity of meetings, and an ad hoc committee.

Chair Rifkin commented that this is not a finished product and that the launch ramp should stay. He agreed with DCB Chair Phinney that nothing in the visioning stated changes in height or density, but if it was implied he would like to see an EIR. He requested to have the "Principles" Commissioner Lesser suggested be placed on a future agenda.

Motion to approve a resolution to express the Commission's support for the following: (1) adoption of a strategic recreational boating plan; (2) Fisherman's Village staying where it is, and moving forward with the proposed redevelopment project as previously presented to the Commission by the current lessee; (3) maintaining the existing launch ramp in its current location; and (4) emphasize the Commission's support for a boating first policy for Marina del Rey. Moved by Commissioner Lumian; seconded by Comissioner Lesser; unanimously approved.

Background

On March 28, 2014, the FHWA published in the Federal Register a NPRM proposing changes to 23 CFR part 924, the regulations for the Highway Safety Improvement Program. The NPRM proposed to address provisions in the Moving Ahead for Progress in the 21st Century Act (MAP-21) as well as to incorporate clarifications to better explain existing regulatory language. Specifically, the rule proposes to amend DOT's regulations to address MAP-21 provisions that removed the requirement for States to prepare a Transparency Report, removed the High Risk Rural Roads set-aside, and removed the 10 percent flexibility provision for States to use safety funding in accordance with 23 U.S.C. 148(e). This NPRM also proposes to amend DOT's regulations to address a MAP-21 provision that requires DOT to establish a subset of roadway data elements that are useful to the inventory of roadway safety, and to ensure that States adopt and use the subset. Finally, this NPRM proposes to address MAP-21 provisions that add State Strategic Highway Safety Plan update requirements and require States to report HSIP performance targets.

The original comment period for the NPRM closes on May 27, 2014. The AASHTO has expressed concern that this closing date does not provide sufficient time to review and provide comprehensive comments on the related FHWA/FTA Statewide and Nonmetropolitan Transportation Planning; Metropolitan Transportation Planning NPRM (FHWA RIN 2125-AF52; FTA RIN 2132-AB10). The FHWA recognizes that others interested in commenting may have similar concerns and agrees that the comment period should be extended. To allow time for this organization and others to submit comprehensive comments, the closing date is changed from May 27, 2014, to June 30, 2014.

Anchorage Regulations: Special Anchorage Areas, Marina del Rey Harbor, California

AGENCY: Coast Guard, DHS. **ACTION:** Notice of proposed rulemaking.

SUMMARY: The Coast Guard proposes to disestablish the special anchorage area at the north end of the main channel in Marina del Rey Harbor, California. Several marina expansion projects have encroached upon the anchorage. Vessels rarely use the anchorage due to a high volume of traffic moving through it as vessels transit in and out of the harbor. This proposed action will remove the anchorage area from the regulations. Vessels may anchor in the harbor during storms, stress, or other emergency situations.

B. Regulatory History and Information

33 CFR 110.111 establishes a special anchorage area in the main channel of Marina del Rey Harbor. The anchorage has the following described boundaries: Beginning at the most northeasterly corner in position 33°58′58″ N, 118°26′46″ W; thence southerly to 33°58′53″ N, 118°26′46″ W; thence southeasterly to 33°58′52″ N, 118°26′45″ W; thence southerly to 33°58′39″ N, 118°26′45″ W; thence westerly to 33°58′38″ N, 118°26′55″ W; thence northerly to 33°59′00″ N, 118°26′55″ W; thence easterly to the point of beginning.

The anchorage area is reserved for yachts and other recreational craft and for all types of small craft during storm, stress, or other emergency. Single and fore-and-aft moorings are allowed in the area as permitted by the director of the Department of Small Craft Harbors, Los Angeles County.

C. Basis and Purpose

The legal basis for this proposed rule is: 33 U.S.C. 471, 1221 through 1236, 2030, 2035, 2071; 33 CFR 1.05–1; and Department of Homeland Security Delegation No. 0170.1, which collectively authorize the Coast Guard to define anchorage grounds.

The purpose of this proposed rule is to align the regulations with the current and future configuration of the main channel and docking facilities in Marina del Rey Harbor. Since this special anchorage area was established, several projects have expanded docking facilities at the north end of the channel. These docks now encroach on the anchorage area, and future projects are planned to continue this expansion. It has become necessary to either redefine the boundaries of the anchorage, or remove it from the regulations.

Vessel and facility operators in the harbor have given feedback that the anchorage is very rarely used. Since the anchorage is in the center of the main channel, a high volume of recreational vessel traffic transits through the area on a consistent basis, making it both impractical and unsafe for vessels to anchor there.

Due to its limited use, the Coast Guard proposes to disestablish the anchorage. This action will also reduce the regulatory burden on the public by eliminating an unnescessary section from the CFR.

D. Discussion of Proposed Rule

The Coast Guard is proposing to disestablish the special anchorage area at the north end of the main channel in Marina del Rey Harbor, California in 33 CFR 110.111. This action will remove 33 CFR 110.111 and reserve it for future use. The anchorage area will be removed from all charts, publications and other navigational references. This proposed rule will not prevent vessels from anchoring in the harbor during storms, stress, or other emergency situations.

E. Regulatory Analyses

We developed this proposed rule after considering numerous statutes and executive orders related to rulemaking. Below we summarize our analyses based on a number of these statutes or executive orders.

1. Regulatory Planning and Review

This proposed rule is not a significant regulatory action under section 3(f) of Executive Order 12866, Regulatory Planning and Review, as supplemented by Executive Order 13563, Improving Regulation and Regulatory Review, and does not require an assessment of potential costs and benefits under section 6(a)(3) of Executive Order 12866 or under section 1 of Executive Order 13563. The Office of Management and Budget has not reviewed it under those Orders. We anticipate that this proposed rule will not have a significant impact on vessel owners and operators, as it removes an obsolete anchorage area that is very rarely used.

2. Impact on Small Entities

The Regulatory Flexibility Act of 1980 (RFA), 5 U.S.C. 601–612, as amended, requires federal agencies to consider the potential impact of regulations on small entities during rulemaking. The term "small entities" comprises small businesses, not-for-profit organizations that are independently owned and operated and are not dominant in their fields, and governmental jurisdictions with populations of less than 50,000. The Coast Guard certifies under 5 U.S.C. 605(b) that this proposed rule will not have a significant economic impact on a substantial number of small entities.

This proposed rule would affect the following entities, some of which might be small entities: The owners or operators of recreational vessels intending to anchor in the affected area.

The disestablishment of this anchorage would not have a significant economic impact on a substantial number of small entitities for the following reasons: Due to the high volume of vessel traffic transiting through Marina del Rey's main channel, it is both impractical and unsafe to utilize this anchorage. For this reason, very few recreational vessels and other small craft anchor in the area. Vessels will not be prevented from anchoring in the harbor during storms, stress, or other emergency situations.

If you think that your business, organization, or governmental jurisdiction qualifies as a small entity and that this rule would have a significant economic impact on it, please submit a comment (see **ADDRESSES**) explaining why you think it qualifies and how and to what degree this rule would economically affect it.

3. Assistance for Small Entities

Under section 213(a) of the Small Business Regulatory Enforcement Fairness Act of 1996 (Pub. L. 104–121), we want to assist small entities in understanding this proposed rule. If the rule would affect your small business, organization, or governmental jurisdiction and you have questions concerning its provisions or options for compliance, please contact the person listed in the **FOR FURTHER INFORMATION CONTACT**, above. The Coast Guard will not retaliate against small entities that question or complain about this proposed rule or any policy or action of the Coast Guard.

4. Collection of Information

This proposed rule will not call for a new collection of information under the Paperwork Reduction Act of 1995 (44 U.S.C. 3501–3520).

5. Federalism

A rule has implications for federalism under Executive Order 13132, Federalism, if it has a substantial direct effect on the States, on the relationship between the national government and the States, or on the distribution of power and responsibilities among the various levels of government. We have analyzed this proposed rule under that Order and determined that this rule does not have implications for federalism.

6. Protest Activities

The Coast Guard respects the First Amendment rights of protesters. Protesters are asked to contact the person listed in the **FOR FURTHER INFORMATION CONTACT** section to coordinate protest activities so that your message can be received without jeopardizing the safety or security of people, places or vessels.

7. Unfunded Mandates Reform Act

The Unfunded Mandates Reform Act of 1995 (2 U.S.C. 1531–1538) requires Federal agencies to assess the effects of their discretionary regulatory actions. In particular, the Act addresses actions that may result in the expenditure by a State, local, or tribal government, in the aggregate, or by the private sector of \$100,000,000 (adjusted for inflation) or more in any one year. Though this proposed rule would not result in such an expenditure, we do discuss the effects of this rule elsewhere in this preamble.

8. Taking of Private Property

This proposed rule would not cause a taking of private property or otherwise have taking implications under Executive Order 12630, Governmental Actions and Interference with Constitutionally Protected Property Rights.

9. Civil Justice Reform

This proposed rule meets applicable standards in sections 3(a) and 3(b)(2) of Executive Order 12988, Civil Justice Reform, to minimize litigation, eliminate ambiguity, and reduce burden.

10. Protection of Children From Environmental Health Risks

We have analyzed this proposed rule under Executive Order 13045, Protection of Children from Environmental Health Risks and Safety Risks. This rule is not an economically significant rule and would not create an environmental risk to health or risk to safety that might disproportionately affect children.

11. Indian Tribal Governments

This proposed rule does not have tribal implications under Executive Order 13175, Consultation and Coordination with Indian Tribal Governments, because it would not have a substantial direct effect on one or more Indian tribes, on the relationship between the Federal Government and Indian tribes, or on the distribution of power and responsibilities between the Federal Government and Indian tribes.

12. Energy Effects

This proposed rule is not a "significant energy action" under Executive Order 13211, Actions Concerning Regulations That Significantly Affect Energy Supply, Distribution, or Use.

13. Technical Standards

This proposed rule does not use technical standards. Therefore, we did not consider the use of voluntary consensus standards.

14. Environment

We have analyzed this proposed rule under Department of Homeland Security Management Directive 023–01 and Commandant Instruction M16475.lD, which guide the Coast Guard in complying with the National Environmental Policy Act of 1969 (NEPA) (42 U.S.C. 4321–4370f), and have made a preliminary determination that this action is one of a category of actions that do not individually or cumulatively have a significant effect on the human environment. This proposed rule involves disestablishing the special anchorage area at the north end of the main channel in Marina del Rey Harbor, California. The anchorage is rarely used and has been encroached upon by several docking facilities. This rule is categorically excluded from further review under paragraph 34(f) of Figure 2–1 of the Commandant Instruction. A preliminary environmental analysis checklist supporting this determination and a Categorical Exclusion Determination are available in the docket where indicated under

ADDRESSES. We seek any comments or information that may lead to the discovery of a significant environmental impact from this proposed rule.

Medicare Program; Prior Authorization Process for Certain Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Items

AGENCY: Centers for Medicare & Medicaid Services (CMS), HHS. **ACTION:** Proposed rule.

SUMMARY: This proposed rule would establish a prior authorization process for certain durable medical equipment, prosthetics, orthotics, and supplies (DMEPOS) items that are frequently subject to unnecessary utilization and would add a contractor's decision regarding prior authorization of coverage of DMEPOS items to the list of actions that are not initial determinations and therefore not appealable.
