## **NOTICE OF PUBLIC HEARING**

This is to notify you of a public hearing scheduled for Wednesday, January 21, 2015 at 6:30 p.m.

**Location:** Westchester Senior Citizen Center, 8740 Lincoln Boulevard, Los Angeles, CA 90045

**Project Title:** Coastal Development Permit (CDP) Application No. CDP 10-04 for the  
**Venice Dual Force Main Project**

**Project Description:** The City of Los Angeles Department of Public Works is proposing to construct a new two-mile long, 54-inch diameter force main sewer to supplement the existing 48-inch diameter force main sewer built in 1960. The purpose of the project is to provide 1) additional sewage capacity to handle peak wet weather flows, 2) pipeline redundancy, and 3) the ability to assess and perform any needed maintenance on the existing force main.

Please refer to Figure 1 for the project location. The new force main would cross the Grand Canal from the Venice Pumping Plant (VPP) at 140 Hurricane Street easterly to Marquesas Way, then southerly along Via Marina crossing the Marina Del Rey and Ballona Creek Channels to an existing coastal interceptor sewer junction structure on Vista Del Mar near Waterview Street via Pacific Avenue. Construction activities require the use of 11 construction shaft sites (see Figure 1), partial closure of the County Lot 13 parking lot in Marina Del Rey, and closure of the parking lot at 62<sup>nd</sup> and Pacific Avenue in Playa Del Rey during construction. Micro-tunneling shall be used to construct the majority of the project, except for the last 900 feet in Playa Del Rey, which shall be constructed by an open-trench method.
