
#### **COMPENSATION & BENEFITS**

Compensation: The salary range for this position is \$137,414.76—\$207,988.44 annually. The starting salary will be based upon the experience and qualifications of the successful candidate. This unclassified position is subject to the provisions of Los Angeles County's Management Appraisal and Performance Plan (MAPP), and is compensated at MAPP Range R14.

#### THE COUNTY

The County of Los Angeles is the largest employer in Southern California with more than 111,000 employees across 36 departments and an operating budget of \$32 billion. With a population of over 10 million residents, the County of Los Angeles serves the needs of the 88 municipalities that lie within its boundaries. Los Angeles County is governed by a five-member Board of Supervisors elected on a nonpartisan basis to serve four-year, staggered terms. The Board of Supervisors serve as both the executive and legislative authorities of the County of Los Angeles.

## THE CHIEF EXECUTIVE OFFICE

The Chief Executive Office (CEO) is the central executive, strategic, and administrative agency serving the County of Los Angeles. The CEO is responsible for a wide range of activities including management and direction of budget and operations, employee relations, compensation, asset management, strategic integration, legislative affairs, intergovernmental relations, risk management, strategic planning, and Countywide communications.

The Chief Information Office (CIO) resides in the Strategic Integration Branch of the CEO. The CIO provides vision and strategic direction for the effective use of information technology (IT) to achieve business objectives and improve the delivery of services throughout the County of Los Angeles. The CIO supports County departments by providing business and technical analysis of IT projects and initiatives, request-for-proposals and contracts. The CIO's oversight responsibilities facilitate departments' alignment with the County's Strategic Plan and compliance with technology standards.

#### THE CHIEF ENTERPRISE ARCHITECT

The CEO of Los Angeles County is seeking well qualified candidates with a successful track record of leading the technical vision and strategy of enterprise-wide programs to serve as the Chief Enterprise Architect. This unclassified position performs under the direction of the County's Chief Information Officer and reports directly to the Chief Deputy, CIO and is responsible for creating and leading the foundation of Los Angeles County's architectural capabilities to ensure the stability, security and scalability of the enterprise architecture across the organization.

This position will lead and coordinate all aspects of the Enterprise Architecture (EA) Program, including: business architecture focused on guiding people, processes and organizational change; information architecture focused on the consistent sharing of information across the organization; solutions architecture focused on developing a direction for managing the portfolio of future solutions; and technical architecture focused on advancing enterprise platforms and solutions.

## **QUALIFYING EXPERIENCE**

The successful candidate will possess five years of leadership experience in the development and design of complex information systems, IT Design, enterprise strategies, service management, and use of architectural frameworks in at least three of the following disciplines: business, information technology, solution or technical architecture, application development, middleware, information analysis or database management.

LICENSE: A valid California Class "C" driver's license or the ability to utilize an alternative method of transportation when needed to carry out job-related essential functions.

- Knowledge of information management practices, system development life cycle management, IT services management, infrastructure and operations, and EA and IT Infrastructure Library frameworks.
- Extensive knowledge of business ecosystems such as Software as a Service (SaaS), Infrastructure as a Service (IaaS), Platform as a Service (PaaS), Service Oriented Architecture (SOA), Application Programming Interfaces (API), Open Data, microservices, event-driven IT, and predictive analytics.
- Knowledge of all components of holistic enterprise architecture, and business engineering principles and processes.
- Demonstrated experience in information strategy including strategic technology planning, execution and policy development.
- Proven track record of effective working relationships with executives and key business partners to drive change agendas.
- Demonstrated strategic thinking abilities and an enterprise-wide perspective.
- Bachelor's degree in Business, Computer Science, Computer Engineering, Electrical Engineering, System Analysis or a closely related field.

### **ESSENTIAL DUTIES**

- Provide technical leadership on infrastructure plans and projects that evaluate technologies and methods for implementing enterprise platforms.
- Lead the design of a countywide architecture that unifies current and future business systems to achieve the County's goals of comprehensive citizen services, data sharing, interoperability, and information security based on a sound proven architecture framework.
- Develop the County's existing and future IT architecture and technology portfolio by establishing guiding principles, standards, and architectural frameworks.
- Provide guidance and remediation approaches for County enterprise projects and initiatives to ensure alignment with architectural standards and guidelines.
- Oversee the application of the architectural foundation across the organization, which includes ensuring consistent integration approaches, minimal replication of data and process, consistent application of data and process security models, and usage of consistent access mechanisms.
- Maintain the County's enterprise architecture framework and work with all agencies and departments to fully develop and utilize all components.
- Develop and communicate Business Architectures, Architecture Road Maps, Technology Standards, and Enterprise Information Architecture.
