

8. Evaluation of the learning environment

8.3) The nursing courses provided logical progression.

- For role, some information was repetitive first semester was somewhat difficult and second semester it was VERY easy, third semester was also somewhat easy. And fourth semester got A LOT more difficult.
- Role repeated its content every single semester except for fourth and then it was ridiculously hard! Some of that information could be taught in other semesters.. like the Public Health Nurse stuff could totally be taught in 3rd semester considering we do ambulatory care.
- The learning environment depends on the instructor you get. Some are great teachers and some should not be teaching. 4th semester instructors have no consistency between them. Some are super easy while others make clinicals unnessarily difficult.
- The nursing courses and objectives were clear and they provided me with the knowledge needed to provide safe, quality, patient care.
- The nursing courses did provide logical progression, but as of now I just feel as if it has been all a big blur. Ironically, thinking back I feel like the skills are given at the right time. For first, was appropriate (ADLs), second (foley, NGT), third (Trach, central line) and fourth was just a huge overview.

8.5)I was encouraged to ask questions.

- I felt as if questions were not entirely encouraged... Sometimes it's as though if you do ask a question it's frowned upon. I've gotten, "You should know that." "That was lectured." "That was covered." Yes, it was covered but some of us haven't reviewed it yet. So questions weren't really a good idea. The best idea would be to LOOK for the answers ourselves FIRST and then ask our questions.
- I learned that it was best not to ask questions with some instructors, but most of the time, I agree.
- Instructors were very helpful in responding my questions
- It depends on the instructor. Some were more willing to be supportive and help the student. Whereas some did not provide enough support and would make the student feel stressed in a clinical situation. I believe all instructors should be approachable to every student.
- Overall, I would say that I strongly agree with the statement in 8.4, as most clinical instructors are open to questions and respond in an encouraging, thoughtful manner. However, there are a couple who are less than helpful when approached with questions any student of nursing would have which is not conducive to learning.

8.7)I was treated with respect for using independent judgement.

- Again, I would say that the majority of those who work with the students were both helpful and respectful. And, again, I will say that there are a couple who, while not always certainly enough for me to mention it here, are demeaning and bullying. It is inappropriate for instructors to behave that way in general but even more so in what is supposed to be a nurturing profession.
- I do agree with this. I appreciated not being followed everywhere I went. But sometimes I did feel lost, I remember first semester I was scared. But with time, it was great.
- I think the expectations of students are a little too much. A lot of times I felt like I was a nurse already and I should have known the things I didn't know and felt discouraged and sometimes reprimanded for asking questions or not knowing answers.
- I was allowed the opportunity to make decisions and use independent judgment when based on my knowledge, I think that is was necessary for the safety of the patient.
- If the instructor trust the student then there is that mutual respect. However not all instructors make the student feel calm and contribute to giving a student anxiety. I understand that pushing a student to be their best is appropriate but not to the point where the student becomes overwhelmed and can potentially harm a patient from lack of supportive faculty. Students need that nurturing and affirmation. Showing favoritism also makes it hard to approach an instructor. All students should be treated equal especially in the clinical setting.

8.11) The physical environment of the school was conducive to my learning.

- Physical can be interpreted in so many ways. The physical environment was shocking at first glimpse. I thought it was a low funded place, but it made me realize that appearances don't matter, it's what the institution has to offer. Studying on campus was never a good idea for me. It was best to study at home or at Norris. I often studied at home for the most part.
- The energy of the physical environment was dependent on the semester and particularly the instructor. Some instructors had a much better disposition than others. I will give more details later in my survey
- The only reason I disagree is because when studying in the tower hall building, the temperature did not allow me to be comfortable enough

to be able to sit there and study. Throughout the whole year and in the winter it was 60 degrees!!!!! At one point we had to bring our own heater to be able to study.

- The physical campus does not match the prestige of the school. I would like to see updated classrooms and equipment.
- The physical environment of the school could use some attention. A school of this caliber should have better curb appeal.
- To practice in a big hospital with highly diversified population is a great opportunity for us. Because I got the chance to work with different cultural group and variety of disease processes.
- With the skills labs, the library and the computer lab, learning was very conducive and was very helpful in preparing the clinical worksheet. XXX and XXX were both very awesome in teaching about both skills and patient care. It really helps the student to prepare for their clinical day.
- 8.13)I consider CONAH campus to be safe.
- I agree, I do feel safe within campus. It's walking to and from campus that I do not feel that much safe. At the end of campus, by skills lab, there's a curb and it's essentially a blind spot. No one will ever know if someone happened to grab you, assault you, cause any harm towards you, etc. That was scary, so I avoid ever having to go there and just park in the parking structure. Other than that blind spot, I do feel safe.
- I don't consider CONAH unsafe however the security on campus wasn't one that I could truly trust with my life or the lives of others. They were friendly and kind but far from intimidating.
- Parking in Lot 10 and arriving for Clinicals before 6am can be a potential problem due to lack of security, but I have not had any negative experiences.
- The campus is not a conventional campus like other colleges, but I was never scare working in it by myself. I never felt unsafe there.

^{15.2)} What would you like to see improved?

- A little more communication from instructors toward students. They are here to teach us and it feels that somewhere along the way, some instructors tend to forget that.
- Allow more time for Post Conference after clinicals. I had post conference from semester 1 but never had any actual post conferences for the other semesters. Even though we are taking off a good amount of time off the ward, I believe discussing and learning about other student's day (accomplishments and/or mistakes) will help give us a better view of not only our patient's but other patient situations too. It helps broaden our learning perspective over a short amount of time.
- Clinical worksheets. Their use is necessary to help us organize and prepare, but I feel that more training and/or guidance could go into the best and most efficient way to collect the information needed. So many students are not sleeping the night before clinicals and then feel that they may be unsafe due to the lack of sleep. Maybe doing practice worksheets using actual patients with the instructor to guide students in collecting data in the most time-efficient manner. We are told coming in to the program that the worksheets should take about an hour to 1.5 hours, but hardly anyone actually completes them that quickly.
- DDC teaching. There is no constancy. People in 4th should not be having trouble with this concept. I Think a few people didn't pass in fourth. That does not seem right.
- During 4th semester written comps review, it would be really helpful if there was some guidance given to the students rather than just Q&A. It seemed like instructors were afraid to give out answers. Students are not just looking for answers (at least not most of us), we want a discussion to get a deeper understanding of clinical scenarios.
- I do realize that the instructors have to be strict or stern, however some, in particular certain 4th semester instructors were ridiculously unapproachable. Unfortunately at times some of those instructors came off as bullies. They seemed to play head games with students either in their clinical group or in lecture. Their methods of intimidation were unnecessary. Some at times were just dismissive. Students in nursing school are already under a lot of stress and pressure. They do not need additional stress directly from their clinical instructors. At times it seemed like some of the instructors needed lecture time to discuss their own personal lives or experiences that had nothing to do with the lecture. I felt the energies change from semester to semester. The first semester was a solid team. They did a great job to set us up for the upcoming semesters. Second semester was the most bonded group of instructors with the best energy. The were a bit maternal but they made the experience very pleasant. However I don't feel like they really prepared us mentally for 3rd because they were so nice! Third semester was challenging but it catapulted us into 4th. Fourth semester was a whole other ballgame. The energy was tense. I definitely felt the segregation between the students and the instructors. I felt the tension amongst the instructors themselves. They definitely did not display the same camaraderie I had noticed in 1st and 2nd. Basically I would like to see less intimidation from certain instructors. The instructors I did not mention in my previous comment box either need an attitude adjustment or a few courses in how keep a lecture interesting and informative while staying organized and prepared.
- I hopefully would like to see more tutoring for students
- I would like to have moved away from the mailboxes and done an online grading system. Some students, like myself, don't live that close

to the school and would have to drive quite a ways to get a grade sometimes.

I did not like that some assignments feel as merely "busy work," for example, in fourth semester the windshield survey and needing to come up with a community nursing diagnosis is ridiculous because we did not have any instruction on how to do so. That assignment just seemed like a huge waste of my time.

Also, the NCP, I understand some parts of it are conducive to our learning. Such as, the 5 column, if they are in fact evaluating the nursing process.

I don't feel that the sociocultural, psychological etc was conducive to my learning, as many students just made up this portion.

- I would like to see more interaction between upperclassmen and underclassmen. It would be nice to have a mentor program where 3rd and 4th semester students can mentor 1st and 2nd semesters to help them out with coping with nursing school.
- I would like to see that all clinical groups are held to the same policies and standards of practice regardless if what location they do their rotations.
- I would like to see the school pay more attention to what is being said by the students regarding certain instructors. There are certain instructors who, semester after semester, receive negative reviews and yet nothing seems to change. In fact, XXX even stated in class to the class that she knows she receives a lot of negative reviews but she doesn't care because she knows what she's doing is in our best interest. Well, one might wonder, what exactly is the point of any review if it is not going to be looked at and thought about? Why, exactly, am I wasting my time writing this review? I guess hope springs eternal (as the saying goes). Perhaps someone will be brave enough to listen to what is being said, look closely at how often these same things are being said, and make the adjustments to the system that need to be made.
- It would be amazing if this school offered a BSN program!
- It would be better for all students of they were to receive the same clinical opportunities. For example, on third semester only the first Ambulatory group of the semester did their rotation at LAC-USC. Everyone else went to Hudson. Also, for those going to Harbor for clinicals, it isn't the same clinical experience because there are more restrictions on what can be done by students. It isn't fair for the students, specially when it makes them feel behind on their growth as a student nurse. I would like for the staff from all the semesters to communicate more with each other on what they will be doing their semeater so it can be a cohesive program.
- Less intimidation among the instructors. More open communication with the students, a little more trust. I am not saying we need to be babied, that's not it. But to have that trust of open communication, that we can say whatever we want: insecurities, how to perform a skill, who to talk to regarding a pt (dietitian, MD, CN, etc), and maybe just a simple "Good job" would be enough. Some positive feedback along the way. Not just in first or second, but throughout the program.
- Longer computer hours and library hours.
- Make the tutoring classes more effective by giving more information please. Written Competency review wasn't effective either. The students have no clue how the competency is and always over study.
- More clinical time.
- More faculty supporting their students. It's not uncommon for students to repeat during this program. Students should have a safe space to speak their minds and approach instructors. It's not right that students fear certain instructors and can anticipate potential failure because if the pattern of certain instructors. Patient safety is important but students need support too in order to become a great nurse that advocates for patients. Great nurses need supportive instructors. I did not always get this but I'm grateful for the instructor that gave me the support u needed.
- My most biggest complaint, which I hope is consistent with the whole class, is the LACK OF CONTINUITY from one clinical instructor to the next. For example, in second semester, you learn how to hang piggybacks- one instructor will show you how to back prime and another will not. THEN you get to third and fourth semester, start to back prime, and the instructor will be like, "What are you going?! You don't EVER back prime, it's technically against policy because you are modifying how the Alaris pump calculates the secondary bag." Then THE STUDENT get in trouble without the instructor asking how come you learned this way. It is not just piggybacks that are inconsistent; I get that all instructors are different in the way they do things, but they need to at least be aware who does what and why and not reprimand the students.

The clinical worksheets, oh my gosh! I do not understand why the instructors don't know why it would take us sometimes six hours in the beginning to do these things. It is really a lot of work. They do help out a lot with learning, but honestly in first and second semester it was a lot of copying and pasting and not a whole lot of learning. They give us an example of how these things should be done (the example is 14 pages long), but in reality, at County, it is MUCH longer. My suggestion to remedy this is to make fourth semester students guide first semester students in learning the best ways to go about reducing the times.

I think administration, not only the semester coordinators should look at Class Climate. There are some instructors who need to be much tougher on their students and there are some that are a little too tough. I think it should be consistent throughout the program. NOW the program has lopsided instructors. You've taken all the really hard instructors out of first semester, second semester is a breeze, now I heard third isn't so bad, but fourth is a NIGHTMARE; they are all hard in fourth; the students that are now in first semester will be doomed in fourth semester because their expectations are really high (that's not a bad thing), but some of the first semester instructors(i.e. the new instructors) expectations are really low.

Give students more access to the simulation lab. On that note, simulations are absolutely horrible and really shoot down the students confidence because you've given a scenario, then you choose randomly what role you get with no time to prepare and by the time you get in the groove of the role, time is up. Simulations are a time to show your clinical instructor how you're doing in clinicals and it is not an accurate assessment at all. The ONLY one I did enjoy was in fourth semester; you pretty much chose your role- what you're good at- and you are given a moment to shine.

There should be clinical scenario competencies throughout the whole program- not just third and fourth semester. I can see how first can really benefit, as well as second. I know there are written competencies in second, but this could be incorporated in the scenarios. I think it would take the shock out of the whole situation.

- New building with good looking environment.

- The consistency between instructors needs to be worked on in fourth semester. Every instructor has very different expectations...
- There needs to be some improvement in the way instructors teach. There is inconsistency in the way teaching is done from one semester to another. Some instructors need to be more professional and not talk down to their students. The learning environment isn't always a comfortable one because of the the instructor's intimidating and condescending personality.
- although most instructors have a teaching style that is conducive to student learning, there are still a few instructors who I felt did not respect other students (myself included) during moments of evaluation. I believe that every student at County is eager to learn and fully respects the comments made by their instructors. Because of this, when a student is treated unkindly, it hinders their learning rather than supports.
