**Position Information:** LAC+USC Medical Center Interventional Radiology is currently seeking a highly qualified individual to fill the positions of Registered Nurse II to provide nursing care to patients undergoing interventional radiology procedures. The Registered Nurse II will be working the Interventional Radiology, and requires on call rotation. The Registered Nurse II will report to Supervising Staff Nurse I and/or Nurse Manager.

**Responsibilities include but are not limited to the following:**

- Provides direct patient care including assessment, planning, implementation, and evaluation of nursing care, treatment or interventions in the interventional radiology and recovery area.
- Conducts an assessment, reassessment and monitoring of the patients prior to, during and post procedures to assess the patients' risk of progressing to a higher acuity or emergent situation, and performs efficiently in emergency situations.
- Prepares patient for the diagnostic or interventional procedures ensuring completion and the application of universal protocol with the multidisciplinary team.
- Assists with the interventional procedures with proficient knowledge and skills to identify various devices and the use and operation of specialized equipment for diagnostic and interventional procedures.
- Demonstrates a proficient knowledge of cardiac arrhythmias and interventions applied for treatment of cardiac arrhythmias.
- Demonstrates proper and safe administration of medications and performs proficiently and safely during emergencies.
- Recognizes emergent and urgent situations, prioritizes and thinks quickly to respond to changing patient care needs in collaboration with all members of the healthcare team.
- Coordinates delivery of patient care with other services and disciplines to achieve optimal patient outcomes and participates in identifying and resolving ethical issues.
- Serves as a preceptor and mentor for new RNs and relief charge nurse as needed.
- Performs work with integrity and in compliance with professional nursing practice standards, policies and procedures, respecting patients' rights, privacy and confidentiality.

**Desirable Qualifications:**

- Minimum three years recent experience working in an ICU/ coronary care unit and/or cardiac catheterization lab
- Effective interpersonal and organizational skills, critical thinking, decision making, problem solving skills and adaptability
- ACLS Certifications
