MEDICAL CASE MANAGER for Service Planning Area (SPA) 1 and 2

POSITION INFORMATION: Housing for Health (HFH) is currently seeking a highly qualified Registered Nurse II for medical case management of medically complex, previously homeless patients now housed in Permanent Supportive Housing (PSH) through the Housing for Health program. These are field work positions requiring home assessments to previously homeless persons who are at risk of losing or are not thriving in their housing placement due to a medical and/or behavioral health conditions. This is a full-time permanent position that reports to the Supervising Staff Nurse or the Permanent Supportive Housing (PSH) Clinical Program Director.

RESPONSIBILITIES INCLUDE BUT ARE NOT LIMITED TO THE FOLLOWING:

- Assesses the medical, behavioral and social conditions of the individual referred by the contracted Intensive Case Management Services (ICMS) agency for Medical Assistance and In-Home Care Giving (IHCG) requests.
- Works closely with the individual (patient/client), their medical providers and ICMS staff to achieve timely treatment, planning, implementation, and follow through of medical management.
- Establishes a professional rapport with the individual, medical providers and referral agency to produce creative and effective solutions to achieve maximum medical and behavioral health improvements.
- Instructs client, family, or caregiver and Case Managers based on identified learning needs.
- Coordinates and implements the approved plan to successful completion.
- Participates in monthly staff meeting, and case conferences with the Housing for Health and contract agency teams.
- Helps facilitate transitions to higher level of care or Enriched Residential Care.
- Reports to the referral source in writing and verbally in a consistent, timely and professional manner.
- Helps develop best practices in field medical case management.
- Serves as a professional role model, provide direction and act as an effective resource person to all members of the care team.
- Provides individualized and specialized field-based nursing care to the specific PSH client including wellness checks and client monitoring.
- Keeps concise, HIPAA compliant records.
- Provides empathetic care with a harm reduction, "whatever it takes" philosophy.
- Other duties as assigned.

DESIRABLE QUALIFICATIONS:

- Minimum two years recent public health or acute clinical experience in providing care to adults with complex physical, mental and/or substance abuse disorders or conditions
- Highly motivated with excellent and strong organizational, interpersonal, team building, critical thinking, and conflict resolution skills
- Flexible, able to manage multiple tasks simultaneously and work effectively in a team-based setting
- Excellent written and verbal communication skills

Candidates must currently hold a permanent County of Los Angeles payroll title of Registered Nurse II to be considered for a transfer or are reachable on a DHS certification list to be considered for a promotion or as a new hire.
