The Los Angeles County Department of Health Services (DHS) is soliciting requests from qualified temporary nursing personnel services firms to be selected to contract for the provision of temporary nursing personnel services at the service locations in the attached listing.

MINIMUM QUALIFICATIONS:

1. Firms interested in participating in DHS' Temporary Nursing Personnel Services Agreement Program must have as an entity or through its principals or officers (at the sole discretion of County) have a minimum of five (5) years of experience within the last five (5) years of providing qualified temporary nursing personnel to hospitals within the United States prior to the effective date of a County agreement under this program.
2. Firms must have a local office located within Southern California, defined as within the boundaries of the following counties: Los Angeles, Orange, Riverside, San Bernardino, San Diego, Santa Barbara, and Ventura.
3. Firms must be Joint Commission certified in Health Care Staffing Services.
4. Firms must have a full-time Director of Nursing who holds unrestricted, current, active, and valid licensure as a registered nurse in the State of California and serves your firm exclusively.
5. Interested firms must be able to agree to accept all terms, conditions and rates offered in the sample agreement (attached).

Note: THE AGREEMENT IS NON-NEGOTIABLE.

DHS C&G will then send your firm a Vendor Certification Questionnaire. Upon the completion of DHS C&G's review of the Vendor Certification Questionnaire and if the information provided by your firm is deemed acceptable, the Temporary Nursing Personnel Services Agreement will be sent to your firm to complete, sign and submit for final review, approval and execution.
