LACDMH OPENS PEER RESOURCE CENTER AT HEADQUARTERS

WHAT: The Los Angeles County Department of Mental Health (LACDMH), will be opening a peer resource center at its headquarters building on the corner of 6th Street and Vermont Avenue. The May 1, 2017 opening celebration will feature a ribbon-cutting event with speeches from LACDMH leadership and government officials, LACDMH clients and volunteers, followed by activities and tours of the new facility.

Staffed primarily by paraprofessionals and volunteers with lived experiences, the center will provide peer-to-peer support to people facing mental health challenges and connect them with local resources for emotional recovery and wellness. Clinical and administrative staff from LACDMH’s Outreach and Triage Bureau will also be at the center to ensure a smooth transition for individuals who need crisis intervention or professional services.

The walk-in center will be open to LACDMH clients, family members, loved ones and community members – with an emphasis on connecting unserved or underserved populations with mental health resources and services.
