REQUEST APPROVAL TO AMEND 20 LEGAL ENTITY AGREEMENTS TO ADD CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS FUNDING FOR MENTAL HEALTH SERVICES FOR FISCAL YEAR 2015-16 (ALL SUPERVISORIAL DISTRICTS)

SUBJECT

Request approval to amend 20 existing Legal Entity Agreements to add California Work Opportunity and Responsibility to Kids (CalWORKs) funding for the purpose of continuing mental health services without interruption to program participants during Fiscal Year 2015-16.

IT IS RECOMMENDED THAT THE BOARD:

- 1. Approve and authorize the Director of Mental Health, or his designee, to prepare, sign, and execute amendments, substantially similar in format to Attachment A, to add California Work Opportunity and Responsibility to Kids (CalWORKs) funding to 20 existing Legal Entity (LE) Agreements under which CalWORKs services are currently provided, and also add CalWORKs Homeless Family Solutions System (HFSS) funding for homeless CalWORKs families to six (6) of the 20 LE Agreements, as listed in Attachment B, for a total cost of \$14,369,459, in order to continue providing mental health services to CalWORKs program participants during the 2015-2016 fiscal year.
- 2. Delegate authority to the Director of Mental Health, or his designee, to prepare, sign, and execute any future amendments to these LE Agreements and establish as a new Maximum Contract Amount

(MCA), the aggregate of the contract provider's original agreement and all amendments provided that: 1) the additional funding allocation does not exceed an increase of 20 percent of each individual provider's MCA, which includes all funded programs combined (of which the CalWORKs and HFSS funding are only two such programs), within a specific fiscal year; 2) approval by County Counsel, or the respective designee, is obtained prior to any such Amendment; 3) County and Contractor may, by written Amendment, mutually agree to reduce programs, and further revise the applicable MCA; 4) any revisions are used to provide additional services and/or to reflect program or Board policy changes; 4) the Director notifies your Board and the Chief Executive Officer (CEO) of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Board approval is requested to amend the agreements of 20 LE contractors currently operating CalWORKs programs to ensure the continued and uninterrupted provision of mental health services to CalWORKs program participants during FY 2015-16, and also funding for HFSS homeless families who are also coping with mental illness. The current funding agreements for mental health services to CalWORKs participants and HFSS will expire on June 30, 2015. Approval of this recommendation will allow DMH to continue to serve CalWORKs participants and homeless families in the interim until new CalWORKs providers can be identified through a solicitation process.

DMH is currently finalizing a Request for Proposals (RFP) solicitation for establishing ongoing mental health services for both CalWORKs program participants and CalWORKs homeless families.

<u>Implementation of Strategic Plan Goals</u>

The recommended actions support the County's Strategic Plan Goal 3, Integrated Services Delivery.

FISCAL IMPACT/FINANCING

The total cost of adding CalWORKs funding allocations to all 20 existing legal entity agreements and adding HFSS funding to six of the 20 existing legal entity agreements for FY 2015-16 is \$14,369,459. The additional CalWORKs allocation for 20 LE Agreements is funded through an intrafund transfer from Department of Public Social Services (DPSS) in the amount of \$13,469,459 for the provision of mental health supportive services; and \$900,000 for HFSS allocations to serve CalWORKs homeless families. This funding is included in DMH's 2015-16 Recommended Budget.

There is no net County cost associated with the recommended action.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In 1997, Governor Wilson signed AB 1542 which conformed California to changes in federal welfare programs. The intent was to ensure that welfare is a temporary support in times of crisis rather than a way of life, to encourage and reward personal responsibility and accountability by participants, and to foster a "Work First" attitude through the application of strict work requirements.

In California, the Welfare-to-Work Program is designed to assist individuals, who are receiving assistance through CalWORKs, to transition as rapidly as possible from dependency on public

assistance into unsubsidized employment and self-sufficiency. Parents or caretakers in families on welfare, unless exempted, are required to meet work requirements by subsidized employment, work experience, community service, vocational training, mental health treatment, substance abuse treatment, domestic violence services, and educational services.

DPSS allocates State CalWORKs funding to County departments, specifically DMH, for CalWORKs mental health supportive services. Since 1997, DMH has received intrafund transfers from DPSS to provide a wide range of mental health treatment services to CalWORKs participants. These services are specifically designed to help individuals overcome the barriers which hinder them from obtaining and retaining employment.

The Amendment format has been approved as to form by County Counsel. The CEO has reviewed the proposed actions.

In accordance with your Board Policy Manual, Section 5.120, Authority to Approve Increases to Board Approved Contract Amounts requirements, DMH notified your Board on May 19, 2015 (Attachment C), identifying and justifying the need for requested percentage increase exceeding 10 percent.

Through the contract term, DMH will continue supervision and monitoring of existing CalWORKs service providers to ensure that these providers are in compliance with DMH Agreements' provisions and policies, and that performance outcomes are being achieved.

CONTRACTING PROCESS

DMH began the CalWORKs RFP process with the development of the solicitation document and scoring tool. However, as the solicitation draft was being finalized, DPSS requested the addition of the HFSS component into the CalWORKs RFP. This added component required DMH to make further revisions to the RFP and develop a new Scoring Tool. These new additions have delayed the release of the RFP.

DMH is currently finalizing the RFP and it will be issued in accordance with State requirements regarding the allocation of CalWORKs funding within Los Angeles County. The RFP will be distributed to agencies on the Departmental Bidders list and will be announced through publications in local community and ethnic newspapers, as well as through DMH's own internet site.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Board approval of the contract amendments allows CalWORKs contractors to continue providing services without interruption through FY 2015-16 while DMH conducts a RFP solicitation process. Upon completion, DMH will return to your Board for approval to award the successful proposers.

NOTICE OF INTENT TO REQUEST DELEGATED AUTHORITY TO APPROVE A PERCENTAGE INCREASE EXCEEDING TEN PERCENT OF THE MAXIMUM CONTRACT AMOUNTS OF TWENTY LEGAL ENTITY AGREEMENTS FOR CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS MENTAL HEALTH SERVICES AND

HOMELESS FAMILY SOLUTIONS SYSTEM FOR

FISCAL YEAR 2015-16

This is to advise your Board that the Department of Mental Health (DMH) is scheduling a Board letter for the June 2, 2015, agenda requesting approval to amend 20 Legal Entity (LE) Agreements to implement the California Work Opportunity and Responsibility to Kids (CalWORKs) Program and the Homeless Family Solutions System (HFSS) Program and to establish new Maximum Contract Amounts (MCAs) for Fiscal Year (FY) 2015-16. This Board letter also requests an additional ten percent for a total of twenty percent delegated authority to increase the MCAs for the 20 LE contractors.

In accordance with Board of Supervisors Policy No. 5.120, prior Board notice is required for any department requesting delegated authority to increase Board-approved contracts over ten percent at least two weeks prior to the Board meeting at which the proposed contract is to be presented.

JUSTIFICATION

This authority will allow DMH greater capacity to amend the following 20 LE Agreements: 1) 1736 Family Crisis Center; 2) Alma Family Services; 3) Child & Family Guidance Center; 4) Children's Institute, Inc.; 5) Didi Hirsch; 6) El Centro de Amistad; 7) ENKI Health & Research, Inc.; 8) Hillsides; 9) Hillview Mental Health Center; 10) Pacific Asian Counseling; 11) Pacific Clinics; 12) Penny Lane; 13) Prototypes; 14) Providence Community Service; 15) San Femando Valley Mental Health Center; 16) SHIELDS For Families; 17) South Central Health Rehabilitation; 18) Special Services For Groups; 19) The Guidance Center; and 20) The Help Group to implement additional funding and services in an expeditious manner.

It will also allow DMH and its LE contractors to maintain business continuity in the provision of current mental health services to severely and persistently mentally ill CalWORKs participants and homeless families throughout the County of Los Angeles. In most instances where speed and response time are of key importance, the increased delegated authority will allow DMH and its network of contract agencies to maximize, prioritize, and increase access to services on a continuous and ever-increasing basis to its ever-growing clientele, which more effectively meets the County's mission, "To Enrich Lives Through Effective And Caring Service."

NOTIFICATION TIMELINE

Consistent with the procedures of Board Policy No. 5.120, we are informing the Board of our intention to proceed filing the Board letter with the Executive Office of the Board of Supervisors for the June 2, 2015, Board meeting. Should there be a need to exceed the twenty percent delegated authority, DMH will return to your Board with a request to amend these LE Agreements accordingly.
