**APPROVAL TO AMEND LEGAL ENTITY AGREEMENT WITH
TARZANA TREATMENT CENTER, INC.
(SUPERVISORIAL DISTRICTS 3 AND 5)
(3 VOTES)**

SUBJECT

Request approval to amend an existing Department of Mental Health Legal Entity Agreement with Tarzana Treatment Centers, Inc., to increase funding of an existing Healthy Way L.A. Tier II Specialty Mental Health Services program funded by State Mental Health Services Act revenue.

IT IS RECOMMENDED THAT THE BOARD:

1. Approve and authorize the Director of Mental Health (Director), or his designee, to prepare, sign, and execute an amendment, substantially similar to Attachment, to the existing Department of Mental Health (DMH) Legal Entity (LE) Agreement with Tarzana Treatment Centers, Inc. (Tarzana), to increase the level of services for Healthy Way L.A. (HWLA) Tier II program. The amendment will be effective upon your Board's approval and will add \$260,000 for Fiscal Year (FY) 2012-13, increasing the Maximum Contract Amount (MCA) to \$6,864,711.
2. Delegate authority to the Director, or his designee, to prepare, sign, and execute future amendments to this LE Agreement and establish as a new MCA, the aggregate of the original Agreement and all amendments; and to further amend this LE Agreement as necessary provided that: 1) the County's total payments to this contract provider for each fiscal year will not exceed an increase of 10 percent from the Board-approved MCA; 2) any such increase will be used to provide additional services or to reflect program and/or policy changes; 3) your Board has appropriated sufficient funds for all changes; 4) approval as to form by County Counsel is obtained prior to execution of any amendments; 5) the County and Contractor may, by written amendment, reduce

programs or services without reference to the 10 percent limitation and revise the applicable MCA; and 6) the Director, or his designee, notifies your Board and the Chief Executive Officer (CEO) of Agreement changes in writing within 30 days after execution of each amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the requested actions will allow DMH to amend its LE Agreement with Tarzana to increase its current HWLA Tier II program allocation to serve additional eligible HWLA enrollees through the end of FY 2012-13. The amendment amount for Tarzana is above the previously-approved 20 percent delegated authority, thus requiring your Board's approval.

Implementation of Strategic Plan Goals

The recommended actions are consistent with County's Strategic Plan Goal 3, Integrated Services Delivery.

FISCAL IMPACT/FINANCING

The total cost of this amendment is fully funded by State Mental Health Services Act revenue in the amount of \$260,000, increasing the MCA to \$6,864,711 for FY 2012-13. Funding for this amendment is included in DMH's FY 2012-13 Final Adopted Budget. There is no net County cost impact associated with the recommended actions.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Tarzana is a nonprofit organization with its headquarters office located at 18646 Oxnard Street, Tarzana, CA 91356, Third Supervisorial District. As a multiservice agency, Tarzana has served Los Angeles County residents since 1972 providing a wide array of services ranging from Specialty Mental Health Services, Alcohol and Substance Abuse treatment, Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome treatment, to primary care services.

On June 14, 2011, in support of the 1115 Waiver Demonstration Project, your Board authorized DMH to enter into agreements with the Department of Health Services' Community Partners and existing qualified DMH LE providers for provision of Tier II Specialty Mental Health Services to eligible HWLA enrollees under the current Los Angeles County Low Income Health Plan. DMH identified the Mental Health Integration Program (MHIP) as the designated treatment model for services rendered under these agreements. Tarzana was deemed qualified as a LE provider upon DMH's confirmation of its capacity to deliver Specialty Mental Health Services using the MHIP model, an evidence-based practice that aims to streamline access to services by integrating health and mental health services for adults who are experiencing an early onset of mild to moderate psychiatric symptoms.

Since becoming a HWLA Tier II Specialty Mental Health Services provider in FY 2011-12, Tarzana has developed a MHIP program serving individuals who meet HWLA Tier II program criteria. In FY 2012-13, Tarzana reported encountering an influx of HWLA enrollees requiring Tier II Specialty Mental Health Services and expended its original program allocation at an unanticipated accelerated rate. The requested amount for this amendment will support Tarzana's current effort to serve additional HWLA enrollees through the end of FY 2012-13.

DMH clinical and administrative staff will administer and monitor the LE Agreement, evaluate programs to ensure that quality services are being provided to clients, and make certain that agreement provisions and departmental policies are followed.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Board approval of the proposed actions will enable Tarzana to maintain its current capacity, support continuity of care, and continue to promote access to integrated treatment.

AMENDMENT NO. 4

THIS AMENDMENT is made and entered into this ___ day of _____, 2013, by and between the COUNTY OF LOS ANGELES (hereafter "County") and Tarzana Treatment Center, Inc. (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated June 6, 2012, identified as County Agreement No. MH120964, as subsequently amended (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year (FY) 2012-13 only, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, County and Contractor intend to amend Agreement to increase the Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) Funded Program (Non Medi-Cal/Non Healthy Families) funds in the amount of \$260,000 for the provision of Healthy Way L.A. (HWLA) Tier II Specialty Mental Health services to eligible enrollees of the Low Income Health Program (LIHP), under the 1115 Waiver Demonstration Project, and individuals meeting eligibility criteria for Match Program Pending; and

WHEREAS, for FY 2012-13 only, the Maximum Contract Amount (MCA) is increased by \$260,000 and the revised MCA is \$6,864,711.

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

1. For FY 2012-13 only, current MHSA PEI (Non Medi-Cal/Non Healthy Families) Funded Program funds is increased from \$527,694 to \$787,694 for a total increase of \$260,000.
2. For FY 2012-13 only, the MCA is increased by \$260,000; the revised MCA is \$6,864,711.
3. Financial Exhibit A (FINANCIAL PROVISIONS), Attachment II, Paragraph C (Reimbursement for Initial Period) shall be deleted in its entirety and the following substituted therefor:

“C. REIMBURSEMENT FOR INITIAL PERIOD

(1) The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) of the Legal Entity Agreement shall not exceed SIX MILLION EIGHT HUNDRED SIXTY FOUR THOUSAND SEVEN HUNDRED ELEVEN DOLLARS (\$6,864,711) and shall consist of Funded Programs as shown on the Financial Summary.”
4. Financial Summaries for FY 2012-13 (Attachment III) – 4, attached hereto and incorporated herein by reference, shall supersede and replace the previously effective Financial Summaries (Attachment III) – 3, to the Agreement.
5. The Financial Summary Subprogram Schedule for FY 2012-13 (Attachment IV) - 4, attached hereto and incorporated herein by reference, shall supersede and replace the previously effective Financial Summary Subprogram Schedule (Attachment IV) – 3, to the Agreement.
6. Contractor shall provide services in accordance with Contractor's FY 2011-12 Negotiation Package for this Agreement and any addenda thereto approved in writing by County's Director of Mental Health or his designee.

7. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
