AUTHORIZATION FOR A SOLE SOURCE AMENDMENT WITH CALIFORNIA INSTITUTE FOR MENTAL HEALTH

TO DEVELOP A STATEWIDE CO-OCCURRING DISORDERS

SUBJECT

Request approval for a sole source amendment with the California Institute for Mental Health to develop a statewide Co-Occurring Disorders Technical Assistance Center.

IT IS RECOMMENDED THAT YOUR BOARD:

- 1. Approve and instruct the Director of Mental Health, or his designee, to prepare, sign, and execute sole source Amendment No. E5, substantially similar to Attachment I, to the existing Consultant Services Agreement No. MH050013 with the California Institute for Mental Health (CIMH), to develop a statewide Co-Occurring Disorders Technical Assistance Center (The COD Center) in the amount of \$163,500 for Fiscal Year (FY) 2009-10, fully funded by Substance Abuse and Mental Health Services Administration (SAMHSA) Federal Block Grant, with a revised Total Compensation Amount (TCA) of \$1,327,200, effective upon Board approval.
- 2. Delegate authority to the Director of Mental Health, or his designee, to prepare, sign, and execute future amendments to the consultant Agreement with CIMH, and establish as a new TCA the

aggregate of the original agreement and all amendments through and including this amendment, provided that: 1) the County's total payments to CIMH for each fiscal year does not exceed an increase of 20 percent from the applicable revised Board-approved TCA; 2) any such increase is used to provide additional services or to reflect program and/or policy changes; 3) your Board has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Executive Officer (CEO), or their designee, is obtained prior to any such amendment; 5) County and CIMH may by written amendment reduce services or programs without reference to the 20 percent limitation and revise the applicable TCA; and 6) the Director of Mental Health notifies your Board of Agreement changes in writing within 30 days after execution of each amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Board approval is required for this amendment as the increase exceeds the 20 percent Board delegated authority limit.

Board approval of the recommended actions will allow CIMH to develop the COD Center to provide service for individuals diagnosed with mental health and substance abuse co-occurring disorders.

The COD Center will build a statewide infrastructure, including a website, which will support California counties' mental health systems' efforts in promoting clients recovery and wellness. The website will serve as a forum to disseminate current information on COD research, treatment models, promising practices and system-wide issues. CIMH will conduct periodic meetings with individual counties/cities and providers to determine specific needs to enhance their delivery of COD services. CIMH will also provide trainings, consultation and on-going technical assistance to supervisors and direct service practitioners on applications of various integrated treatment models.

As a statewide organization, CIMH has been in the forefront of promoting comprehensive mental health services for individuals with co-occurring disorders through training, technical assistance, research, policy development, and collaboration. CIMH has the proven leadership required to develop and implement policy changes, training and technical assistance, and expert consultations as demonstrated with their involvement in the California Co-Occurring Joint Action Council (COJAC). During the current Fiscal Year, CIMH made COD information available to counties through webcasts and video conferences. Additionally, CIMH has developed products such as the COJAC screening tool to assess individuals for co-occurring disorders, the Dual Diagnosis Capability in Addiction Treatment instrument to screen the providers' ability to provide co-occurring disorder services, and a housing resource model which informs about the categories of housing which best serves different groups of COD clients. Based on its proven expertise in providing COD training and consultation, CIMH is in the unique position to develop the COD Center.

DMH has selected CIMH to undertake the development of the COD Center as the agency has the necessary organizational structure, professional personnel, technical competence, and statewide collaboration experience needed to achieve the objective set out for the COD Center.

The recommended actions are consistent with the County's Strategic Plan Goal 4, Health and Mental Health.

FISCAL IMPACT/FINANCING

There is no increase in net County cost. The \$163,500 is fully funded by SAMHSA. Sufficient appropriation is included in DMH's FY 2009-10 Final Adopted Budget for this amendment. The revised FY 2009-10 TCA for CIMH will be \$1,327,200.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In FY 2008-09, DMH accepted the annual SAMHSA Federal Block Grant from the State Department of Mental Health (SDMH), which included a one-time allocation of \$327,000 for the development of the COD Center. In October 2008, SDMH notified DMH that funds were allocated for expenditure, and California Mental Health Directors Association (CMHDA) was then designated to develop the COD Center. It became known later that due to some internal transitioning within SDMH management that CIMH was to be the actual contractor for this project. Official notice regarding CIMH did not reach DMH in time to award the project to CIMH during FY 2008-09. The \$327,000 currently remains intact and unspent with DMH. On November 10, 2009, SDMH notified DMH that the subject allocation is available for FY 2009-10 expenditure. The Department estimates the cost for deliverables to be \$163,500 and that the deliverables can be achieved during the three months remaining in FY 2009-10 (April to June). DMH may request the authority to renew CIMH's contract during FY 2010-11 and provide additional SAMHSA funds for the project.

CIMH's statement of work for the COD Center project includes: 1) developing a website containing COD resource information and member services directory to share treatment strategies, 2) compiling and analyzing data on evidence-based and promising practices for serving people with cooccurring disorders, 3) conducting statewide regional trainings on integrated and specialized COD services, and 4) providing training and technical assistance to individual counties/cities and providers (e.g. senior management, clinic managers, clinical supervisors, and direct service practitioners). The goal is to bring recovery and wellness to COD clients by enabling and educating all levels of provider organizations, including managers/administrators, supervisors, direct service providers (e.g. alcohol/drug, mental health, co-occurring staff), consumers and family members.

The Amendment (Attachment I) has been approved as to form by County Counsel. The CEO has reviewed the proposed actions.

The required Sole Source Contract Checklist, identifying and justifying the need for a sole source contract amendment, has been approved by the CEO (Attachment II).

CONTRACTING PROCESS

DMH is requesting approval of a sole source contract amendment with CIMH, which is uniquely qualified to provide these services, specifically to develop a statewide COD Technical Assistance infrastructure and website in accordance with the Statement of Work detailed in the Deliverables.

The sole source decision is based on DMH's historical experience that CIMH has consistently provided quality SAMHSA services and is a leader in the provision of co-occurring disorders training and technical assistance. This leadership role is supported by the fact the California Mental Health Directors Association Governing Board has chosen CIMH by consensus as best suited to create this statewide training and COD Center.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The amendment will provide an information resource center on mental health substance abuse cooccurring treatment models and practices for treatment and administrative staff throughout California. It will enhance mental health systems efforts in bringing recovery and wellness to target population.

AMENDMENT NO. <u>E5</u>

THIS AMENDMENT is made and entered into this _____ day of _____2010, by and between the COUNTY OF LOS ANGELES (hereafter "County") and <u>California</u>

<u>Institute for Mental Health</u> (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated June 12, 2007, identified as County Agreement No. MH050013, and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year (FY) 2009-10 only, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, for FY 2009-10 only, County and Contractor intend to add Substance Abuse Mental Health Services Administration (SAMHSA) Federal Block Grant (FBG) in the amount of \$163,500 to the Total Compensation Amount (TCA). The allocated SAMHSA FBG is for the development of a statewide Co-Occurring Disorders Technical Assistance Center (the COD Center) to enhance service provisions to individuals diagnosed with mental health and substance abuse co-occurring disorders. Contractor shall provide training and technical assistance to service providers throughout California. Contractor shall perform services as specified in Exhibit EA-5, Statement of Work; and

WHEREAS, effective October 21, 2009, County and Contractor intent to amend Agreement to add new provisions to the Agreement pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.206), Defaulted Property Tax Reduction Program; and

WHEREAS, County and Contractor intend to amend Agreement to modify Paragraph 26.0 (TERMINATION FOR DEFAULT) to include language in subparagraph 26.1 on "TERMINATION FOR BREACH OF WARRANTY TO MAINTAIN COMPLIANCE WITH COUNTY'S DEFAULTED PROPERTY TAX REDUCTION PROGRAM"; and

WHEREAS, for FY 2009-10, the TCA of \$1,163,700 will be increased by \$163,500. The revised TCA will be \$1,327,200.

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

 Paragraph 5.0 <u>COMPENSATION</u>, Subparagraphs 5.1 and 5.2 shall be deleted in their entirety and replaced by:

"5.0 COMPENSATION:

5.1 In consideration of the performance by Contractor in a manner satisfactory to County of services described in Exhibits EA-1, EA-2, EA-4 and EA-5 Statements of Work, Contractor shall be paid in accordance with the Fee Schedule established in Exhibit EB-5 and according to the Payment Schedule-COD established in Exhibit EA-5. Total compensation for all services furnished hereunder shall not exceed the sum of ONE MILLION THREE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED DOLLARS (\$1,327,200) for Fiscal Year 2009-10. Notwithstanding such limitation of funds, Consultant agrees to satisfactorily complete all work specified in Exhibits EA-1, EA-2, EA-4 and EA-5 Statements of Work. To request payment, Consultant shall present County's Program Manager monthly in arrears invoices accompanied by a statement of the number of hours worked daily by each individual assigned to the

project and a report of work completed for the invoice period. This report shall be prepared in a format satisfactory to County's Program Manager or his/her designated representative.

5.2 The Total Compensation Amount for this Agreement shall not exceed ONE MILLION THREE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED DOLLARS (\$1,327,200) for Fiscal Year 2009-10. In no event shall County pay Contractor more than this Total Compensation Amount for Contractor's performance hereunder. Payment to Contractor shall be only upon written approval of the invoice and report by County's Program Manager or his/her designated representative.

Consultant shall submit invoices to:

 Department of Mental Health Consultant Services Agreement shall be modified and the following inserted therefore:

"47.0 CONTRACTOR'S WARRANTY OF COMPLIANCE WITH COUNTY'S DEFAULTED PROPERTY TAX REDUCTION PROGRAM: Contractor acknowledges that County has established a goal of ensuring that all individuals and businesses that benefit financially from County through contract are current in paying their property tax obligations (secured and unsecured roll) in order to mitigate the economic burden otherwise imposed upon County and its taxpayers.

Unless Contractor qualifies for an exemption or exclusion, Contractor warrants and certifies that to the best of its knowledge it is now in compliance, and during the term of this contract will maintain compliance, with Los Angeles County Code Chapter 2.206.

- 48.0. TERMINATION FOR BREACH OF WARRANTY TO MAINTAIN COMPLIANCE WITH COUNTY'S DEFAULTED PROPERTY TAX REDUCTION PROGRAM: Failure of Contractor to maintain compliance with the requirements set forth in Paragraph 47.0 (CONTRACTOR'S WARRANTY OF COMPLIANCE WITH COUNTY'S DEFAULTED PROPERTY TAX REDUCTION PROGRAM) shall constitute default under this contract. Without limiting the rights and remedies available to County under any other provision of this contract, failure of Contractor to cure such default within 10 days of notice shall be grounds upon which County may terminate this contract and/or pursue debarment of Contractor, pursuant to County Code Chapter 2.206."
- 3. Paragraph 47.0 (NOTICES) shall be changed to read Paragraph 49.0. Any references made to Paragraph 47.0 (NOTICES) shall be deemed a reference to Paragraph 49.0. Whenever the <u>Paragraph 47.0 "NOTICES"</u>, appears in Agreement, the parties agree that <u>Paragraph 49.0 "NOTICES"</u> shall be substituted therefor.
- The EXHIBIT EA-5, Statement of Work, attached hereto and incorporated herein by reference, shall be added to the Agreement.

- EXHIBIT EB-5, Fee Schedule attached hereto and incorporated herein by reference, shall supersede and replace the previously effective Exhibit EB-4, to the Agreement.
- Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.

EXHIBIT EA-5 Co-Occurring Disorders Technical Assistance Center Statement of Work (SOW) FY 2009-10

Co-Occurring Disorders

Co-Occurring Disorders (COD) occur when a client experiences both a mental illness and a substance-related disorder. Currently, integrated treatment may not be available to COD clients. Frequently, such clients are inadequately or inappropriately served due to a lack of provider knowledge of best practices. As a result, the rates of homelessness, jail sentencing, morbidity, and mortality tend to be higher among COD clients than non-COD clients.

A high percentage of the population served by the Los Angeles County Department of Mental Health system has co-occurring mental illness and substance abuse disorders. Developing effective treatment strategies for COD clients is one of the Department's priorities. Funded by SAMHSA, this amendment requires California Institute for Mental Health (CIMH) to develop a statewide Co-Occurring Disorder Technical Assistance Center to enhance DMH technical and clinical skills and bring recovery and wellness to the target population.

Co-Occurring Disorders Technical Assistance Center

CIMH shall develop the Co-Occurring Disorders Technical Assistance Center (The COD Center) to provide a statewide information infrastructure to enhance service provisions to COD clients. The COD Center will provide the scope of support needed to effectively promote recovery of individuals with COD and bring about real change and sustained improvement within the statewide mental health system and the Department's Adult System of Care (ASOC).

CIMH shall perform the Statement of Work specified as follows:

Deliverables

CIMH shall develop a statewide website of COD information and resources.
 The COD Center website will be developed in three phases:

Phase I: During the first phase, CIMH will post basic pertinent service delivery and clinical information on COD practices and services, including links to existing websites.

Phase II: The second phase involves identifying resources (e.g., literature)

and information concerning evidence-based and promising practices for organizations and practitioners providing co-occurring recovery services. The website will provide information and strategies for implementation of these practices, including links to other national and local sources of information.

Phase III: This phase concentrates on assembling a comprehensive member services directory comprised of Mental Health/Alcohol or Drug (AOD) agencies/behavioral health authorities (counties/cities) and other providers. The directory will serve as a forum for sharing treatment strategies among members.

- CIMH shall research, analyze and evaluate various integrated COD treatment models, culminating in the provision and promotion of website information on available optimum services models. The sharing of this information will enable county mental health systems to make informed decisions regarding the most appropriate treatment model for various populations (e.g., age, gender, ethnic/cultural, families).
 - a. CIMH Senior Associate and their consultant experts will maintain collaborative relationships with representatives of the Los Angeles County Department of mental Health, Adult System of Care, to assure that the Deputy Director and President/CEO of CIMH will produce the appropriate practical data on evidence-based and promising practices for serving people with co-occurring disorders.
 - The information and the analysis will be posted and available as a hard copy or PDF download on the COD Center website.
 - c. In addition, tools for assisting counties/programs in making decisions about which programs or strategies to implement will be posted on the website and available to support required technical assistance or development of specialized training.
- CIMH shall begin the planning, coordination and preparation of COD regional trainings in FY 2009-10.

CIMH will:

- a) Ensure each comprehensive regional training will be 11 15 hours in length, involving up to 150 participants at each of the regional trainings.
- b) Schedule and organize trainers who are experts in the field, local and national; providers and researchers of exemplary programs within California. Trainers will also include consumers and family members.
- c) Convene on-going planning meetings to ensure that training will be

targeted to all levels of provider organizations, including managers/ administrators, supervisors, direct service providers (alcohol/drug, mental health and co-occurring staff), consumers and family members.

- d) Ensure that syllabi, materials, and handouts necessary for trainings are obtained in advance of the Regional trainings. Topics will include, but not necessary be limited to, information on current research, implementation of evidence-based and promising practices, system-wide issues to be addressed, participation of consumers and family members in treatment, motivational interviewing, stages of change, screening and assessment tools.
- e) Trainings will be formatted with a keynote speaker addressing the state of the art of providing services to people with co-occurring disorders, panel presentations on model programs and breakout groups on more specific topics, such as evidence-based practices, implementation strategies and research. The breakout groups will provide for group interaction to enhance learning at the trainings.
- f) Prepare evaluations to distribute to participants in each training, assessing the learning that took place. This information will be used to adjust subsequent training session focus and approaches. Attendees will be able to secure Continuing Education units.

CIMH shall also:

- a) Develop curricula and provide training and consultation to individual counties/cities and providers. CIMH staff/consultants will work with each entity requiring assistance to determine the specific needs to enhance delivery of COD services in that organization.
- Provide consultation concerning assessment of system-wide change areas and individual program development.
- c) Provide training and technical assistance to supervisors and direct service practitioners in the implementation of specific practices (e.g., Integrated Dual Diagnosis Treatment, motivational interviewing and stages of change).

The total cost for these services shall not exceed \$163,500.

Payment Schedule-COD

This schedule applies to disbursements of \$163,500 SAMHSA federal block grant funds only. It specifies payment schedule for the services described in EA-3 (Statement of Work).

DMH shall pay to CIMH the following SAMHSA funds based on periodic invoices from CIMH to DMH as described below:

COUNTY OF LOS ANGELES – DEPARTMENT OF MENTAL HEALTH JUSTIFICATION FOR A SOLE SOURCE AGREEMENT CALIFORNIA INSTITUTE FOR MENTAL HEALTH

BACKGROUND

California Institute for Mental Health (CIMH) is a private consultant services agency specialized in technical mental health knowledge. CIMH was established by the California Mental Health Directors Association (CMHDA) in 1993 to provide training, technical assistance, research and policy development statewide and work collaboratively with all mental health system stakeholders in order to promote excellence in mental health services. The CMHDA Governing Board determined by consensus to create a Co-Occurring Disorders Technical Assistance Center (The COD Center) at CIMH for the purpose of developing a statewide infrastructure that would enable CIMH to support counties throughout the State in their efforts to more effectively promote recovery of individuals with co-occurring disorders. CIMH submitted a proposal which was accepted and approved by the Governing Board. There was no bidding process for the State of California for the COD Center.

In Fiscal Year 2008-09, DMH accepted the annual Substance Abuse and Mental Health Services Administration Federal Block Grant award from the State Department of Mental Health (SDMH) which included a one-time allocation of \$327,000 for the development of the aforementioned COD Center. Initially, SDMH notified DMH that CMHDA was the designated contractor to develop the COD Center. DMH later learned from SDMH that the contractor for the subject project was changed to CIMH. Additionally, due to management changes at SDMH, official change notice did not reach DMH in time to award the project to CIMH during FY 2008-09, the fiscal year first designated for the expenditure of these funds. The \$327,000 remains intact/unspent with DMH. On November 10, 2009, the State Department of Mental Heath (SDMH) notified DMH that the subject allocation is available for FY 2009-10 expenditure. The Department estimates the development cost to be \$163,500 for the four months remaining in FY 2009-10. The balance of \$163,500 from the total award amount of \$327,000 is reserved for the FY 2010-11 COD Center expenditure. DMH will request the authority to expend this amount during the FY 2010-11 budget process to complete the project. DMH has selected CIMH for this project.

SOLE SOURCE JUSTIFICATION

CIMH has been identified as the sole source to develop the COD Center as their proposal was approved by the Governing Board of the CMHDA. CIMH is uniquely qualified to develop the COD Center as they have established a broad range of partnerships and collaborations throughout California's mental health system and specialize in education and training, technical assistance, consultation, and evaluation and research in mental health services. A sole source contract with CIMH will enable CIMH to develop the COD center and further enhance Los Angeles County Department of Mental Health's commitment to providing an array of treatment, recovery, and supportive services to clients with co-occurring mental health and substance abuse disorders.
