**DEPARTMENT OF MENTAL HEALTH: SERVICE AREA 8 PSYCHIATRIC  
MOBILE RESPONSE TEAM LOMITA REFURBISHMENT PROJECT  
ESTABLISH CAPITAL PROJECT; APPROVE PROJECT BUDGET  
APPROVE APPROPRIATION ADJUSTMENT  
(FOURTH DISTRICT) (3 VOTES)**

**IT IS RECOMMENDED THAT YOUR BOARD:**

1. Find the Service Area (SA) 8 Psychiatric Mobile Response Team (PMRT) Lomita Refurbishment project categorically exempt under the California Environmental Quality Act (CEQA).
2. Approve the establishment of Capital Project (C.P.) No. 86862 for refurbishment of the County-owned building located at 24330 Narbonne Avenue, Lomita, CA 90717, to house the Department of Mental Health's (DMH) SA 8-PMRT.
3. Approve the attached Appropriation Adjustment to transfer \$430,000 from C.P. No. 69572 to C.P. No. 86862.
4. Approve the \$430,000 estimated total project budget for the SA 8-PMRT Lomita Refurbishment project as detailed in Attachment A.

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

Approval of the recommended actions will establish C.P. No. 86862 and allow for the refurbishment of a portion of the County-owned building located at the Lomita Civic Center to house the SA 8-PMRT from the Harbor-UCLA Medical Center campus.

The PMRT is a direct services program that provides emergency psychiatric outreach services. The team consists of mental health professionals that provide community-based psychiatric services, directly assisting individuals with acute mental health needs or crises by visiting them at home, school, and hospitals when psychiatric emergency services are unavailable. In some cases, psychiatric services are provided on the street where the PMRT assists the mentally ill homeless. PMRT operates 24 hours-a-day, 7 days-a-week, responding daily to calls dispatched from their offices during business hours and on an on-call basis after hours. The PMRT program, which started in 1998, specializes in the emergency mental health needs of children, families, adults, the homeless and the elderly.

The PMRT for SA 8 is currently housed at Bungalow D2 of the Harbor-UCLA Medical Center campus. Built in the 1940s during World War II, the bungalow was originally intended as temporary barracks and has since outlived its useful life. Having endured extensive structural damage over the years, the bungalow is dilapidated and is scheduled to be torn down. Additionally, since occupying Bungalow D2 in 1998, the SA 8-PMRT program has outgrown the existing space. DMH, in collaboration with the Chief Executive Office (CEO), has identified available and adequate space at the County-owned facility located at 24330 Narbonne Avenue, Lomita, in the Lomita Civic Center, which formerly housed staff from the Assessor.

Tenant Improvements and minor alterations are required to prepare the space for occupancy by the PMRT staff. The proposed refurbishment project includes general facility improvements and renovation of approximately 4,300 square feet within the overall 17,000 square foot facility. General improvements and renovations include installation of new modular furniture, floor tiles and carpet, paint, relocation of doors, re-keying doors, demolition and construction of several walls, creation of a high density chart room, electrical work, and modifications necessary to meet voice and data requirements. The proposed refurbishment project will be completed by the Internal Services Department (ISD).

The proposed refurbishment project would provide operationally efficient space for the SA 8-PMRT staff and alleviate overcrowding while ensuring the continued, uninterrupted provision of community based psychiatric services in the South Bay and Long Beach areas.

### **Implementation of Strategic Plan Goals**

The recommended actions are consistent with the principles of the Countywide Strategic Plan Organizational Goal No. 2, "Workforce Excellence" by providing a safe and adequate facility to enhance the quality and productivity of the County's workforce.

### **FISCAL IMPACT/FINANCING**

The estimated total cost of the SA 8-PMRT Lomita Refurbishment Project, including construction, furniture, and telecommunication lines is \$430,000. The attached appropriation adjustment will transfer \$430,000 into C.P. No. 86862 from C.P. No. 69572 to fully fund the project. The scope of work for C.P. No. 69572 has changed thus making funds available for this project. The project will be funded by prior year Net County Cost. Upon approval of the attached Appropriation Adjustment, sufficient funds will be available in the FY 2007-08 Capital Projects/Refurbishments Budget to fully fund the project. The Project Schedule and Budget Summary are included in Attachment A.

### **Operating Budget Impact**

Following completion of this project, DMH estimates an ongoing annual operating budget impact of \$33,364, which includes the cost of utilities and building maintenance. In addition, DMH estimates one-time start-up costs of \$170,000 for office equipment and computer systems. Sufficient funding for these costs is included in the DMH Adopted Budget for FY 2007-08.

### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

SA 8-PMRT has been operating for the last 15 years on the Harbor-UCLA campus and has occupied Bungalow D2 since 1998. Since then, the program has grown and its space requirements have changed. Given that the current building lacks sufficient work and file storage space, in October 2005, DMH requested the CEO Real Estate Division to conduct a search for space in the SA 8 area. Before conducting a search for lease space, the CEO determined the PMRT program could use available, County-owned space in Lomita. The former Assessor building is approximately 17,000 square feet and is located in the Lomita Civic Center. The Fire Department's Southwest District Office – Health Hazardous Material and the Public Defender occupy the rest of the building. In order to prepare the 4,300 square feet of that site for the PMRT staff, DMH needs to make tenant improvements and minor alterations. The refurbishment project will be completed by ISD.

The proposed actions have been reviewed by County Counsel and CEO.

**ENVIRONMENTAL DOCUMENTATION**

The proposed project has been reviewed and determined to be categorically exempt under CEQA Guidelines, Section 15301 (a) and under Class 1(d) of the County of Los Angeles Revised Environmental Document Reporting Procedures and Guidelines adopted by your Board on November 17, 1987 because the project provides for minor alteration and repair of an existing facility. A Notice of Exemption will be filed with the County Clerk.

**IMPACT ON CURRENT SERVICES**

Services will continue to be provided from the current location until the refurbishment is completed, and DMH staff is relocated to 24330 Narbonne Avenue, Lomita, CA 90717. There will be minimal to no interruptions of services during the relocation.
