APPROVAL TO AMEND AN EXISTING DEPARTMENT OF MENTAL HEALTH LEGAL ENTITY AGREEMENT WITH PROTOTYPES FOR FISCAL YEAR 2005-2006 AND

APPROVAL OF REQUEST FOR APPROPRIATION ADJUSTMENT FOR FISCAL YEAR 2005-2006 (SUPERVISORIAL DISTRICT 1) (3 VOTES)

IT IS RECOMMENDED THAT YOUR BOARD:

- Approve and instruct the Director of Mental Health or his designee to prepare, 1. sign, and execute Amendment No. 5, substantially similar to Attachment I, to the existing Department of Mental Health's (DMH) Legal Entity (LE) Agreement No. DMH-02352 with PROTOTYPES for the provision of mental health services. Through a Memorandum of Understanding (MOU) (Attachment II), between the Department of Children and Family Services (DCFS) and DMH, PROTOTYPES will identify children and their families who need mental health assessment and treatment who reside in Pomona. Through an Intrafund Transfer from DCFS, this amendment will increase PROTOTYPES' Maximum Contract Amount (MCA) by \$173,000, from \$3,258,520 to \$3,431,520. This Amendment will be effective upon execution through June 30, 2006.
- Approve the Request for Appropriation Adjustment (Attachment III) in the amount 2. of \$173,000 for FY 2005-2006. The appropriation increase will provide spending authority for the PROTOTYPES Assessment Program fully funded by an Intrafund Transfer from DCFS.

3. Delegate authority to the Director of Mental Health or his designee to prepare, sign, and execute future amendments to this LE Agreement with PROTOTYPES and establish as a new MCA the aggregate of the original Agreement and all amendments through and including this amendment, provided that: 1) the County's total payments to contractor under the Agreement for FY 2005-2006 shall not exceed an increase of 20 percent from the applicable revised MCA; 2) any such increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer (CAO) or their designee is obtained prior to any such Amendment; 5) the parties may, by written Amendment, mutually agree to reduce programs or services without reference to the 20 percent limitation; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Board approval is being requested to amend the Agreement with PROTOTYPES, as the recommended increase of \$173,000 to the MCA is not within DMH's delegated authority.

The recommended actions will enable DMH, through, PROTOTYPES, to conduct comprehensive mental health assessments of families who are part of the DCFS Points of Engagement Program in Pomona. The goal of the program is to prevent unnecessary foster placement. It is anticipated that many of the families will need comprehensive mental health assessment and treatment services with linkages to ancillary services in the community. DCFS has requested that PROTOTYPES provide the mental health services. PROTOTYPES is the only mental health provider in Service Area 3 that is currently working collaboratively with DCFS as a member of the Points of Engagement Program. PROTOTYPES is familiar with the program and has established a strong working relationship with DCFS and other members of the collaborative.

By working collaboratively, PROTOTYPES will meet the following goals:

- Identify treatment needs of children and their families;
- Reduce the number of children detained from their families while providing appropriate services to the entire family to reduce risk to the children;
- Reunify children in a timely manner with their families by actively linking families early on to appropriate services;

- Ensure that families are referred and linked to the appropriate service provider(s);
- Reduce recidivism;
- Utilize a strength based approach that engages the family in the assessment and treatment process;
- Provide training to DCFS staff on mental health and co-occurring disorders; and
- Collect and analyze data.

In order to accomplish these goals, Board approval is requested to amend the Agreement with PROTOTYPES to provide mental health assessments to DCFS Points of Engagement families.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Programmatic Goal No. 5, "Children and Families' Well-being," within the Countywide Strategic Plan. Your Board's approval of this Amendment will strengthen the mental health services delivery systems and improve service accessibility within Service Area 3.

FISCAL IMPACT/FINANCING

There is no increase in net County cost.

The appropriation adjustment (Attachment III) in the amount of \$173,000, fully funded by Intrafund Transfer from DCFS, will provide spending authority for the PROTOTYPES Assessment Program for FY 2005-2006. PROTOTYPES' MCA will be increased by \$173,000 for the revised MCA of \$3,431,520 for FY 2005-2006.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

PROTOTYPES is a nonprofit organization established in 1986 to promote health and psychosocial well-being on an individual, family, and organization level, through health, mental health, and substance abuse services. PROTOTYPES has been a DMH contract agency since October 1, 2002 and is in good standing with DMH. The Pomona DCFS Regional Office and PROTOTYPES began to collaborate on the assessment program in October of 2005. A pilot program was initiated and 10 families were assessed. All the families were linked to appropriate services within the community. The program demonstrated its ability to reduce unnecessary foster placement by providing mental health services and linking the family to adjunctive community

resources. Due to the program's success, DCFS has agreed to provide DMH with funding for the continuation of the program. DCFS has also requested that DMH contract with PROTOTYPES to support continuity of care for residents of Pomona. Approval of these actions will allow services to continue through the remainder of FY 2005-2006.

The attached Amendment has been approved as to form by County Counsel and the CAO has reviewed the proposed actions. Clinical and administrative staff of DMH will continue to administer and supervise the Agreement, evaluate the programs to ensure that quality services are being provided to clients, and ensure that Agreement provisions and Department policies are being followed.

CONTRACTING PROCESS

A MOU (Attachment II) was entered into by DMH and DCFS on February 21, 2006 to provide services and funding for the PROTOTYPES Assessment Program.

IMPACT ON CURRENT SERVICES

Board's approval of this Amendment will provide critically needed families within the DCFS Points of Engagement Program with a comprehensive assessment to immediately identify families' strengths and needs and provide a timely linkage to a continuum of services.

CONCLUSION

AMENDMENT NO. 5

THIS AMENDMENT is made and entered into this __day of _______, __2006, by and between the COUNTY OF LOS ANGELES (hereafter "County") and PROTOTYPES (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated June 21, 2005, identified as County Agreement No. <u>DMH-02352</u>, and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year 2005-2006 and any subsequent fiscal years, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, for Fiscal Year 2005-2006 only, County and Contractor intend to amend Agreement to add Department of Children and Family Services (DCFS) funds in the amount of \$173,000 to the Maximum Contract Amount (MCA) for the delivery of mental health services for the Joint Assessment Program; and

WHEREAS, for Fiscal Year 2005-2006, the MCA will be increased by \$173,000 with a revised MCA of \$3,431,520; and

WHEREAS, County and Contractor intend to amend Agreement to reflect the correct name of the Contractor specified in the Legal Entity Agreement from PROTOTYPES to PROTOTYPES, Centers for Innovation in Health, Mental Health and Social Services.

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

- Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph B (Reimbursement For Initial Period) shall be deleted in its entirety and the following substituted therefor:
 - "B. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed THREE MILLION FOUR HUNDRED THIRTY-ONE THOUSAND FIVE HUNDRED TWENTY DOLLARS (\$3,431,520) and shall consist of County, State, and/or Federal funds as shown on the Financial Summary. This Maximum Contract Amount includes Cash Flow Advance which is repayable through cash and/or appropriate Service Function Code (SFC) units and/or actual and allowable costs as authorized by other provisions of this Agreement. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder during the Initial Period. Furthermore, Contractor shall inform County when up to 75 percent (75%) of the Maximum Contract Amount has been incurred. Contractor shall send such notice to those persons and addresses which are set forth in Paragraph 60 (NOTICES)."
- Contractor shall hereafter be known as <u>PROTOTYPES</u>, <u>Centers for Innovation in Health</u>, <u>Mental Health and Social Services</u> effective the date hereinabove written, this Agreement shall be between County and <u>PROTOTYPES</u>, <u>Centers for Innovation in Health</u>, <u>Mental Health and Social Services</u>. Any inadvertent future

reference to <u>PROTOTYPES</u> shall be deemed a reference to <u>PROTOTYPES</u>, <u>Centers for Innovation in Health, Mental Health and Social Services</u>. Wherever the Name "PROTOTYPES", appears in Agreement, the parties agree that the name "<u>PROTOTYPES</u>, <u>Centers for Innovation in Health, Mental Health and Social Services"</u> shall be substituted therefor.

- 3. Financial Summary 4 for Fiscal Year 2005-2006 shall be deleted in its entirety and replaced with Financial Summary 5 for Fiscal Year 2005-2006, attached hereto and incorporated herein by reference. All references in Agreement to Financial Summary 4 for Fiscal Year 2005-2006 shall be deemed amended to state "Financial Summary 5 for Fiscal Year 2005-2006".
- Contractor shall provide services in accordance with the Contractor's Fiscal Year <u>2004-2005</u> Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.
- Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.

Memorandum of Understanding Between Los Angeles County Department of Children and Family Services and Department of Mental Health for the PROTOTYPES Assessment Program

This Memorandum of Understanding (MOU) is entered into by the Los Angeles County Department of Children and Family Services (DCFS) and the Department of Mental Health (DMH) for the purpose of implementing the PROTOTYPES Assessment Program. This program will provide for a comprehensive assessment to immediately identify families' strengths and needs and provide timely linkage to a continuum of services for the families that are assessed. This assessment has direct implications for child safety and improved timelines to permanency through family maintenance and reunification. This MOU establishes each Department's commitment to the program and describes the roles and responsibilities of each.

I. BACKGROUND

The Pomona DCFS Regional Office and PROTOTYPES began to collaborate on the assessment program in October of 2005. Since the program was initiated, 10 families have been assessed. All 10 cases were linked to appropriate services whether at PROTOTYPES or other agencies in the community. In three of the cases that were referred, the children had already been removed prior to the assessment. The other seven families that were assessed by the PROTOTYPES Assessment Program are receiving outpatient services for substance abuse and mental health services. The program thus far has demonstrated its ability to reduce unnecessary foster placement by providing mental health services and linking the family to adjunctive community resources. As a result, DCFS has agreed to provide DMH with funding to continue the work through a Departmental Service Order (DSO). DCFS has also requested that DMH contract with PROTOTYPES to support continuity of care for residents of Pomona. DMH will contract with PROTOTYPES to deliver the mental health services.

II. PROGRAM DESCRIPTION

The program was developed as a collaborative effort between the two Departments to ensure comprehensive assessments of families who may be experiencing substance abuse, mental health, and or domestic violence concerns. The purpose of this comprehensive assessment is to identify treatment needs in the areas described above and to provide timely linkages to appropriate services in the community.

By working collaboratively, the PROTOTYPES assessment team will strive to meet the following goals:

- To identify mental health treatment needs of children and their families.
- To reduce the number of children detained from their families, as a result of a mental illness, while providing appropriate services to the entire family to reduce risk to the children.
- To reunify children in a timely manner with their families by actively linking families to appropriate services early on.
- To ensure that families are referred and linked to the appropriate service providers.

- To reduce recidivism.
- To utilize a strength-based approach that engages the family in the assessment process.
- To monitor program outcomes. Data regarding the program outcomes will be collected by PROTOTYPES. This data will be compiled in a monthly report. Data will consist of the following information:
 - > Number of children and families served
 - > Demographic data of the families served such as age, sex, race, and type of services and referrals provided
 - > Evaluation of the program's impact on detention rates for the Pomona DCFS Office
 - > Length of time from referral to assessment by PROTOTYPES Assessment Program
 - > Intervention outcomes

III. DCFS RESPONSIBILITIES

- 1. Identify families at low, medium and high levels of risk that may need a comprehensive substance abuse, mental health, and/or domestic violence assessment.
- 2. Refer the identified families to the PROTOTYPES Assessment Program.
- 3. Facilitate the initial contact between the families and PROTOTYPES.
- 4. Have the family sign the appropriate consent to release information form.
- Participate in the assessment process.
- 6. Invite PROTOTYPES to Team Decision Making meetings.
- 7. Discuss the completed assessment with PROTOTYPES staff.
- 8. Provide funding to DMH to fund the PROTOTYPES Assessment Program. See Financial Conditions for related detail.

IV. DMH RESPONSIBILITIES

Provide administrative and program oversight of the PROTOTYPES Assessment Program, a comprehensive assessment process for children and their families who come to the attention of DCFS due to allegations of abuse and neglect. DMH will ensure the following mental health activities are delivered through a mental health contract with PROTOTYPES.

- 1. Ensure that a mental health or co-occurring assessment is conducted and that appropriate linkages are provided to the family.
- 2. Ensure that mental health or co-occurring consultation is available to DCFS staff as needed.
- 3. Ensure that PROTOTYPES mental health staff is available between the hours of 9:00 AM to 5:00 PM Monday-Friday to provide crisis intervention, case management, outreach, and other mental health services including medication support services.
- 4. Ensure mental health staff attends Team Decision Making meetings and or other family meetings such as Family Group Decision Making meetings.
- 5. Ensure training is provided to DCFS staff on mental health and co-occurring disorders as requested by DCFS.
- 6. Ensure that DCFS staff has access to the results of the mental health and co-occurring assessment including treatment recommendations in order to coordinate care and determine the level of support service needs. All information shared shall be in compliance with the Health Insurance Portability and Accountability Act.
- 7. Ensure that services are easily accessible to the child and family and offered in the home, DCFS office or other community site.
- 8. Ensure that upon discharge, follow up care is provided to ensure linkage to appropriate agencies.
- 9. Maintain information in accordance with confidentiality laws.

V. CONFIDENTIALITY

DCFS, DMH, and PROTOTYPES shall continue to maintain the confidentiality of all records and information relating to all families participating in this program, in accordance with all Federal, State, and County laws, ordinances, regulations, and directives relating to confidentiality.

VI. FINANCIAL CONDITIONS

- 1. DCFS will establish a Departmental Service Order (DSO) in the amount of \$172,800 from January 1, 2006 through June 30, 2006.
 - A. \$160,800 to provide funding for the actual costs related to the delivery of mental health services for children and families.
 - B. \$12,000 to provide training to DCFS staff mental health and co-occurring disorders.

- 2. This is a time-limited expenditure. The time frame is January 1, 2006 through June 30, 2006 (6 months) to serve 20 to 30 families per month.
- 3. DMH agrees that all DCFS funds specified in the DSO shall be used for the purpose of providing mental health and co-occurring assessments and addressing mental health, co-occurring conditions, substance abuse and domestic violence issues by PROTOTYPES.
- 4. DMH will submit to DCFS monthly invoices no later than the 30th of the following month of services.

VII. TERM OF AGREEMENT

This MOU will be effective from January 1, 2006 until June 30, 2006. Either party may terminate this MOU without cause, provided that written notice is given to the other party at least 30 days in advance. This MOU may be amended by mutual written consent of both parties.
