**APPROVAL TO ACCEPT A DONATION FROM THE EVE M. NICKELS TRUST  
(ALL SUPERVISORIAL DISTRICTS)  
(3 VOTES)**

**IT IS RECOMMENDED THAT YOUR BOARD:**

Accept a donation of \$490,903.48 from the Eve M. Nickels Trust to the Department of Mental Health (DMH) to be used in support of the Psychiatric Emergency Services Relief Plan (PES Relief Plan) jointly developed by DMH and the Department of Health Services (DHS).

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION:**

The purpose of this request is to accept a monetary gift of \$490,903.48 from the Eve M. Nickels Trust.

**Implementation of Strategic Plan Goals**

The recommended Board action is consistent with the County's Organizational Goal No. 4, "Fiscal Responsibility," within the Countywide Strategic Plan. Board approval of this request will allow the funds to be used in support of the PES Relief Plan.

**FACTS AND PROVISIONS/LEGAL REQUIREMENTS:**

The Eve M. Nickels Trust, a testamentary trust, was established for the lifetime benefit of Betty Jane Mull under the will of Eve M. Nickels in the early 1990s. The trust terminated by reason of the death of Ms. Mull on January 20, 2005, and with this monetary gift of \$490,903.48 has now been distributed outright, free of trust, to DMH.

This subject does not apply.


**IMPACT ON CURRENT SERVICES:**
