**HEARING ON DEPARTMENT OF MENTAL HEALTH'S  
REVISED PUBLISHED CHARGES FOR FISCAL YEAR 2004-2005  
(ALL SUPERVISORIAL DISTRICTS)  
(3 VOTES)**

**IT IS RECOMMENDED THAT YOUR BOARD:**

Approve the attached revised Department of Mental Health (DMH) Published Charges (Attachment I) for Fiscal Year (FY) 2004-2005, effective April 1, 2005, in order to comply with Federal Short-Doyle/Medi-Cal (SD/MC) Lower of Cost or Charges (LCC) reimbursement and routine cost requirements.

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS**

Board action is required to revise the Board approved FY 2004-2005 Published Charges to include additional rates for Half-Day Treatment Intensive service – one rate for Medi-Cal and one rate for all other responsible financial parties. A Half-Day Treatment Intensive service is less than four (4) hours. This half-day rate has been developed and included in the FY 2004-2005 Published Charges to accommodate the State's new ruling on the Day Treatment Intensive program. The State DMH has ruled that the time it takes to transport clients cannot be counted towards the minimum hours of a day treatment program, e.g. three (3) hours for a half-day and four (4) plus hours for a full-day. However, the County can claim for other mental health services provided to the clients during this transportation process if the services are medically necessary, referenced on the client plan as an intervention to treat the mental health condition, provided within scope of practice, and approved by DMH.

Previously, the travel time was counted toward the minimum hours of a day treatment program resulting in a full-day service, four (4) hours or more. This practice is disallowable and accordingly, a day treatment service of less than four (4) hours is needed.

The current Published Charges for FY 2004-2005 approved by your Board on June 22, 2004, are still in effect. This action adds an additional service category to DMH's schedule of covered service benefits. Presently, DMH's schedule of covered service benefits only reflects a full day rate for the Day Treatment Intensive service. This action is to add a half-day rate for such service. Board action is required to ensure that Published Charges are in compliance with Medi-Cal requirements. The recovery of Federal revenues in compliance with State and Federal regulations necessitates that Published Charges be established at least annually. Federal requirements stipulate that Published Charges are to be determined at the Countywide level.

#### **Implementation of Strategic Plan Goals**

The recommended Board action is consistent with the principles of the Countywide Strategic Plan Organizational Goal No. 4, "Fiscal Responsibility." This action will ensure that Published Charges are in compliance with Medi-Cal requirements, thereby averting Federal LCC audit disallowance.

#### **FISCAL IMPACT/FINANCING**

The subject does not apply.

Approval of the two (2) rates for Half-Day Treatment Intensive service will be compliant with the Federal LCC principle and will avoid audit disallowances. DMH has not included any charges, which are set by either State or Federal agencies for which it has no jurisdictional rate setting authority. DMH will bill those charges as directed by those authorities.

#### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

In FY 2003-2004, your Board approved DMH's revised Published Charges on October 28, 2003, to permit DMH to include administrative overhead costs for all services that will be billed to non-Medi-Cal responsible financial parties. For Medi-Cal plans, the methodology to calculate the Published Charges to bill Medi-Cal plans remains the same as originally approved by the Board on June 24, 2003. The rates for Medi-Cal plans do not include administrative overhead costs. Medi-Cal administrative

costs are reimbursed through a separate and specific mandated State reimbursement methodology. Accordingly, this action will result in the Published Charges rates for the Half-Day Treatment Intensive service – one (1) rate for Medi-Cal and one (1) rate for all other responsible financial parties.

The Published Charges for FY 2004-2005 were developed using actual cost report data for FY 2002-2003 and/or FY 2003-2004. This cost report data was adjusted by the Federal Home Health Agency Market Basket Index.

Government Code Section 66018, added by stats. 1990, ch. 1572 (AB 3228), §20, requires the publication of notice and a public hearing to be held prior to the adoption of new fees or the increase of existing fees. Such a notice will be published at the minimum of 10 days prior to the public hearing.

#### **CONTRACTING PROCESS**

The subject does not apply since DMH's Published Charges apply only to DMH's directly operated clinics.


#### **IMPACT ON CURRENT SERVICES**

The recommended revised Published Charges will become effective April 1, 2005. Failure to establish new annual Published Charges will result in reduced revenues from non-Medi-Cal, Medi-Cal, and Healthy Families plans.

**CONCLUSION**
