**APPROVAL OF REQUEST TO WAIVE CONTRACT LANGUAGE
ON A ONE-TIME BASIS AND
APPROVAL OF REQUEST FOR APPROPRIATION ADJUSTMENT FOR
SENATE BILL (SB) 90 PAYMENTS TO MENTAL HEALTH SERVICE PROVIDERS
FOR FISCAL YEARS 2000-2001, 2001-2002, and 2002-2003
(ALL SUPERVISORIAL DISTRICTS)
(4 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve, on a one-time basis, the request to waive contract language authorizing the Department of Mental Health (DMH) to pay mental health service providers for Assembly Bill (AB) 3632 services delivered in Fiscal Years (FYs) 2000-2001, 2001-2002, and 2002-2003 prior to receipt of State Senate Bill (SB) 90 funds.
2. Approve and instruct the Director of Mental Health or his designee to prepare, sign, and execute amendments, using a previously Board-approved format (Attachment I), to 22 existing DMH Legal Entity (LE) Agreements, identified on Attachment II, for FY 2002-2003 only. Effective upon Board approval, the amendments increasing FY 2002-2003 Maximum Contract Amounts (MCAs) will enable DMH to pay 22 AB 3632 mental health service providers for AB 3632 services prior to receipt of State SB 90 funds.
3. Delegate authority to the Director of Mental Health or his designee to prepare, sign, and execute future amendments to the Agreements and establish as a new MCA the aggregate of the original Agreement and all amendments through and including these amendments, provided that: 1) the County's total payments to Contractor under the Agreement for each fiscal year shall not exceed an increase

of 20 percent from the applicable revised MCA; 2) any such increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer or their designees is obtained prior to any such Amendment; 5) the parties may, by written Amendment, mutually agree to reduce programs or services without reference to the 20 percent limitation; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

4. Approve the Request for Appropriation Adjustment (Attachment III) for \$15,049,000 for FY 2004-2005. The appropriation increase will provide spending authority to DMH to reimburse AB 3632 mental health service providers for contracted services to Seriously Emotionally Disturbed (SED) children in FYs 2000-2001, 2001-2002, and 2002-2003. The \$15,049,000 is fully funded with the Sales Tax Realignment funds in the DMH Sales Tax Realignment Trust account.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Your Board's approval of this request is necessary because it will enable mental health service providers identified in Attachment II to be reimbursed for prior year State mandated AB 3632 mental health services that were rendered but not paid for at this time by the State. Payment of these services by the County before the receipt of State funds will assist the mental health service providers with their cash flow.

This request would authorize DMH to use the Sales Tax Realignment funds in the DMH Sales Tax Realignment Trust account, on a one-time, non-precedent setting basis only, to pay mental health service providers for AB 3632 services prior to receipt of State SB 90 funds:

The present fiscal conditions of the State are such that the State has been unable to provide its SB 90 payments for AB 3632 services in a timely manner, creating additional multi-year cash flow problems for mental health service providers. A partial interim solution to this cash flow problem is to redirect unexpended FY 2004-2005 Sales Tax Realignment funds in the DMH Sales Tax Realignment Account Trust to pay mental

health service providers for AB 3632 services delivered in FYs 2000-2001, 2001-2002, and 2002-2003. This will provide some cash flow relief to mental health service providers, thereby allowing for the continuance of AB 3632 services, without interruption, pending fulfillment of the State's payment obligations. Once the SB 90 claiming process is completed and the State validates the SB 90 services for FYs 2000-2001, 2001-2002, and 2002-2003, there may be an adjustment to the mental health service providers' SB 90 final payments.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Organizational Goal No. 4, "Fiscal Responsibility," within the Countywide Strategic Plan. This action will enable DMH to make payments to mental health service providers for AB 3632 services provided to SED children in FYs 2000-2001, 2001-2002, and 2002-2003. In addition, it will provide cash flow relief to mental health service providers, thereby allowing for the continuance of AB 3632 services, without interruption, pending fulfillment of the State's payment obligations.

FISCAL IMPACT/FINANCING

There is no increase in net County cost.

The Department proposes to utilize \$15,049,145 from the Sales Tax Realignment Trust account balance to pay mental health service providers for prior year SB 90 service claims. Upon receipt of State SB 90 funds, the County will redirect such funds back to repay the Sales Tax Realignment Trust account.

While it is the expectation that the State will ultimately reimburse the County and its mental health service providers for these services, the parties agree that, given the urgent circumstances, it is vital that services continue to be rendered without interruption. The County will accept responsibility for these payments for approved AB 3632 services in the event the State does not pay for them, in the absence of fraud or other wrongdoing on the part of the mental health service providers.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In 1984, the California legislature enacted AB 3632 in order to maximize and coordinate the provision of mental health services to SED children. Prior to FY 2002-2003, the State gave DMH an annual allocation of \$2.78 million as categorical funding to pay for mandated AB 3632 services. Since the costs incurred by the County in providing those services far exceeded the categorical funding, the County was reimbursed the excess

costs through the SB 90 mandate reimbursement process. However, in the FY 2002-2003 State Budget, the State eliminated the \$2.78 million categorical funding, and implemented an indefinite moratorium on SB 90 mandate reimbursement to the County.

The County serves as an intermediary role between contracted mental health service providers and the State for AB 3632 mental health services for SED children through the SB 90 reimbursement process, which was designed to enable local governments to recover from a net financial injury that results from this State mandated program.

The claiming process for determining "net financial injury" that results from the State's mandated AB 3632 program is lengthy and involves the following three steps: 1) a SB90 claim showing net financial injury is prepared based on what is reported in the cost report; 2) the State performs a Short-Doyle/Medi-Cal (SD/MC) reconciliation that validates SB90 services; and 3) DMH incorporates the State's SD/MC reconciliation into its settlement process, thereby establishing true and accurate SB90 costs, and determines net financial injury. This three-step claiming process normally takes 20-22 months after the close of the fiscal year and may result in an adjustment to the mental health service providers' SB90 final payments.

Since July 1, 2002, the County has not received any State funding to pay for the mental health services provided to more than 6,000 disabled students in Los Angeles County. The County does not expect to receive any SB 90 funds from the State until FY 2006-2007 and the following years. The State has planned a five-year payout period. Therefore, the DMH proposes to use the Sales Tax Realignment Trust account balance to fund the \$15,049,145. Upon receipt of State payment, the Department will retain the State funds.

Since March 4, 2003, this will be the fifth action taken by your Board to reimburse mental health service providers for prior year AB 3632 services not reimbursed to them by the State. On March 4, 2003, your Board approved a \$6,119,448 payment for FY 2002-2003; on June 17, 2003, your Board approved a \$3,212,595 payment for FY 2002-2003; on June 23, 2003, your Board approved a \$2,130,000 payment for FYs 2000-2001 and 2001-2002; and on July 1, 2003, a \$320,166 payment for FY 2000-2001. The July 1, 2003 action was in response to a June 10, 2003 Board-approved Motion directing the Chief Administrative Officer, Auditor-Controller, and DMH to submit recommendations on any redirecting of unspent and/or additional unallocated funds for SB 90 payments to mental health service providers for FYs 2000-2001 and 2001-2002 claims. This proposed fifth action of \$15,049,145 will bring the total County SB 90 assistance to mental health service providers to \$26,831,354 for FYs 2000-2001, 2001-2002, and 2002-2003.

The existing DMH LE Agreement SB 90 boilerplate language changed in FY 2002-2003. FYs 2000-2001 and 2001-2002 language stated, "SB 90 funds are not part of the Maximum Contract Amount(s) of this Agreement and shall be paid by County to Contractor solely in County's capacity as the SB 90 claim intermediary between the Contractor and the State... Contractor shall be paid by County from SB 90 funds upon receipt from the State"; FY 2002-2003 language stated, "SB 90 funds are part of the Maximum Contract Amount(s) of the Agreement and shall be paid by County to Contractor solely in County's capacity as the SB 90 claim intermediary between the Contractor and the State... Contractor shall be paid by County from SB 90 funds upon receipt from the State."

DMH is contractually bound to compensate mental health service providers for the AB 3632 mental health services provided pursuant to the provisions of the Agreement upon receipt of State SB 90 funds. Therefore, in accordance with the above referenced contract language and with Board approval to waive, on a one-time basis, the contract language that states, "Contractor shall be paid by the County from SB 90 funds upon receipt from the State," this action will result in \$15,049,145 being paid by County to mental health service providers prior to receipt of SB 90 funds from the State.

As stated earlier, while it is the expectation that the State will ultimately reimburse the County and its mental health service providers for these services, the parties agree that, given the urgent circumstances, it is vital that services continue to be rendered without interruption. The County will accept responsibility for these payments for approved AB 3632 services in the event the State does not pay for them, in the absence of fraud or other wrongdoing on the part of the mental health service providers.

Therefore, DMH is requesting an appropriation increase of \$15,049,145 that will allow payment for FYs 2000-2001, 2001-2002, and 2002-2003 to mental health service providers. Upon receipt of State SB 90 funds, the County will redirect such funds back to repay the DMH Sales Tax Realignment Trust account.

CONTRACTING PROCESS

For FYs 2000-2001 and 2001-2002, where SB 90 funds were not part of the MCA, this subject does not apply. For FY 2002-2003, DMH will amend 22 LE Agreements identified in Attachment II to allow mental health service providers to be reimbursed for continually providing State-mandated AB 3632 services.


IMPACT ON CURRENT SERVICES

AMENDMENT NO. _____

THIS AMENDMENT is made and entered into this _____ day of _____, 2004, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated _____, identified as County Agreement No. DMH- and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year 2002-2003 only, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, the present fiscal conditions of the State of California are such that the State is apparently unable to provide its SB 90 payments for AB 3632 services in a timely manner, which circumstances were not anticipated or contemplated by the parties; and

WHEREAS, AB 3632 services derive from a legal mandate and are critical to the recipients thereof; and

WHEREAS, the parties have agreed upon a partial interim solution to this cash flow problem, on a one-time, non-precedent setting basis only, which will

provide some relief to Contractor and allow for the continuance of AB 3632 services, without interruption, pending fulfillment of the State's payment obligations; and

WHEREAS, Contractor understands that County has devoted a limited fund for this purpose, that payments are being made to other similarly situated providers which exhaust the fund, and that, accordingly, there are no other funds presently available for these purposes; and

WHEREAS, in consideration for Contractor's continuing to provide AB 3632 services under this Agreement, notwithstanding the inability of the State to meet its payment obligations in a timely manner, County agrees to pay Contractor \$ _____ as a partial payment for services rendered to date for Fiscal Year 2002-2003 only. It is understood that such services otherwise qualify for payment under the terms and conditions of the Agreement; and

WHEREAS, for Fiscal Year 2002-2003, the revised Maximum Contract Amount will be \$ _____.

NOW THEREFORE, the parties agree to amend the Agreement for Fiscal Year 2002-2003 only, on a one-time, non-precedent setting basis only, as follows:

1. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph B (Reimbursement for Initial Period) shall be deleted in its/their entirety and the following substituted therefor:

(1) "B. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed _____

DOLLARS (\$ _____) and shall consist of County, State, and/or Federal funds as shown on the Financial Summary. This Maximum Contract Amount includes Cash Flow Advance which is repayable through cash and/or appropriate SFC units and/or actual and allowable costs as authorized by other provisions of this Agreement. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder during the Initial Period. Furthermore, Contractor shall inform County when up to seventy-five percent (75%) of the Maximum Contract Amount has been incurred. Contractor shall send such notice to those persons and addresses which are set forth in Paragraph 57 (NOTICES).

2. Financial Summary - for Fiscal Year 2002-2003 shall be deleted in its entirety and replaced with Financial Summary - for Fiscal Year 2002-2003 attached hereto and incorporated herein by reference. All references in Agreement to Financial Summary - for Fiscal Year 2002-2003) shall be

deemed amended to state "Financial Summary - for Fiscal Year 2002-2003."

3. While it is the expectation that the State will ultimately reimburse Contractor for these services, the parties agree that, given the urgent circumstances and the need for the continuation of the services without interruption, County will accept responsibility for this payment for approved services in the event the State does not pay for them, in the absence of fraud or other wrongdoing on the part of Contractor.
4. The agreements set forth in this Amendment are made notwithstanding Paragraph DD of the Agreement, which the parties agree will be waived for these purposes, on this one-time only basis and for this Fiscal Year 2002-2003 only, and only to the extent of the payment by County provided for by this Amendment. Paragraph DD will otherwise apply with full force and effect.
5. Contractor shall provide services in accordance with the Contractor's Fiscal Year 2002-2003 Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.
6. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
